We have performed audits of the financial statements of Liquid Robotics, Inc. 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

Note 1 – Description of the Plan

The following description of the Liquid Robotics, Inc. 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution 401(k) and Profit Sharing plan covering all eligible employees of Liquid Robotics, Inc. (the Company). Employees who are not part of an excluded class become eligible to participate on the first day of the month following their attainment of age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration – Fidelity Management Trust Company (Fidelity) is the custodian and trustee of the Plan.

Contributions – Contributions to the Plan are in the form of salary reductions which participants have elected to defer in lieu of current compensation. Participants may elect to contribute, subject to statutory limitations, up to 80% of their eligible compensation. Participants age 50 or older are allowed to make catch-up contributions. Participants may elect to change contribution percentages to be effective the first of the month after the request is received or as soon as administratively possible. The allocation of both their contributions and employer contributions to the funds may be changed at any time and become effective on the day of the change or the next business day based on the day and time the request for a change is made in relation to the stock market close of business. The Plan allows active employees to contribute to the Plan from pre-tax compensation, after-tax compensation for Roth contributions, or a combination of both. The Plan also accepts certain rollover contributions.

The Company may make discretionary employer matching contributions to the Plan for those participants who are making deferral contributions. During 2024, the Company made employer matching contributions as follows: a 100% match of the first 3% of eligible compensation deferred by each participant and a 50% match of each participant's deferrals of the next 4% of eligible compensation. Under the terms of the Plan and as determined by the Company's Board of Directors, the Company also may make discretionary profit sharing contributions to the Plan for those employees who are employed by the Company as of the last day of the plan year and have completed two months of service with the Company. The Company has not made any profit-sharing contributions to the Plan since inception.

Participant accounts – Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Company's contributions, and allocations of Plan earnings (losses) from the funds in which the account is invested, and charged with an allocation of certain administrative and investment-related expenses and participant-specific charges, if applicable. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Liquid Robotics, Inc. 401(k) Retirement Savings Plan Notes to Financial Statements

Vesting – Participants are fully vested in their rollover and elective contributions and employer matching contributions including accumulated earnings. Any profit-sharing contributions and earnings thereon are vested according to the following schedule:

Forfeitures – Forfeitures are the nonvested portions of a participant’s account that are lost upon termination of employment. Forfeitures occur when a participant receives a distribution of his or her entire vested account or, if the participant does not receive a distribution, after five consecutive one-year breaks in service. Forfeitures are retained in the Plan and may be used to reduce future Company contributions or pay administrative expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$690 and \$679, respectively. During the year ended December 31, 2024, no forfeitures were used to reduce Company contributions or pay administrative expenses.

Withdrawals – Participants may elect to withdraw all or a portion of their vested balance at any time on or after the day they attain age 59-1/2. If a participant is under age 59-1/2, withdrawals are subject to certain hardship rules as provided by the Plan. Employer matching and vested profit-sharing contributions may be fully withdrawn upon termination of employment. Withdrawals of rollover contributions can be made at any time.

Notes receivable from participants – Participants are permitted to borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their total vested account balance at the time of the loan issuance and may have only one loan outstanding at any time. Loans may be further limited in accordance with Plan provisions. The interest rate on new loans is set every month at prime plus 1% as reported by Thomson Reuters as of the close of business on the last business day of the calendar month immediately preceding the date of the loan. Interest rates on outstanding loans ranged from 4.25% to 9.50% at December 31, 2024, with loans maturing at various dates through December 2029.

Benefit payments – Upon termination of service, a participant may elect to receive a distribution of their vested account balance in the form of a lump sum payment, partial payments, installment payments, direct rollover to another qualified plan or individual retirement account. A participant may also defer distribution until a later date, provided the vested account balance exceeds \$7,000.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes to Financial Statements

Risks and uncertainties – The Plan’s investments are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements.

Valuation of investments and income recognition – The Plan’s investments are stated at fair value. Fair value of the financial instrument is the price that would be received to sell an asset or paid to transfer a liability (exit price) in an orderly transaction between market participants at the measurement date. Investments in the Plan are valued as follows:

- **Mutual funds** – The Plan’s investments in mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end as quoted in an active market.
- **Collective trust fund** – Units held in the collective trust fund are valued using the NAV practical expedient of the fund as reported by the fund manager. The NAV is based on the fair value of the underlying assets owned by the collective trust fund, minus its liabilities, and then divided by the number of units outstanding.

Purchases and sales of securities are recorded on a trade date basis, and dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis of accounting. Net appreciation or depreciation in fair value of investments consists of gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of benefits – Benefits are recorded when paid.

Expenses – Necessary and proper expenses of the Plan are paid from the Plan’s assets, except for those expenses the Company chooses or is required by law.

Subsequent events – The Plan has evaluated subsequent events through June 18, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

Accounting Standards Codification (ASC) 820 established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Values are based on unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities. An active market is a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

Level 2 –Values are based on (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in nonactive markets; or (c) valuation models whose inputs are observable, directly or indirectly, for substantially the full term of the asset or liability.

Level 3 –Values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement.

The methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level within the fair value hierarchy a summary of the Plan's investments by general types of assets measured at fair value on a recurring basis at December 31, 2024 and 2023. As required by ASC 820, assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Note 4 – Information Certified by the Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity has certified the completeness and accuracy of the following:

Note 5 – Tax Status

The Plan is based on a non-standardized pre-approved defined contribution plan that received a favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the pre-approved plan, as then designed, was compliant with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter, however, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan's tax-exempt status has not been affected, and no provision for income taxes has been included in the Plan's financial statements.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

Note 7 – Party-in-Interest Transactions

The Plan invested in shares of mutual and collective trust funds managed by affiliates of Fidelity. Therefore, these transactions qualify as exempt party-in-interest transactions.
