Leased employees are not eligible for participation.

Benefit Service: The sum of the Years in which the Employee has been credited with at least 2000 hours of service plus fractions of a year determined in accordance with the following schedule:

Year of Vesting Service: A Plan Year in which a Participant has at least 1,000 hours of service.

Vesting Service: A Participant who completed five years of vesting service is 100% vested in the Accrued Benefit

Average Monthly Earnings: The average of a Participant's greatest five consecutive Annual Earnings, or of all Annual Earnings if there are fewer than five, taking into account no more than ten years immediately preceding the date of determination.

Early Retirement Date: First day of the month coinciding with, or next following, attainment of age 55 and completion of six years of Credited Service.

Normal Retirement Date: First day of the month coinciding with, or next following, the attainment of age 65.

Normal Retirement Benefit: The monthly amount equal to the sum of 2% of Average Monthly Earnings multiplied by the Participant's Benefit Service, plus ½% multiplied by the Participant's Benefit Service, not to exceed 22.75%, multiplied by Average Annual Earnings in excess of \$7,200. In no event will the benefit be greater than 70% of the Average Monthly Earnings, and in no event less than the participant's minimum top-heavy plan benefit.

The benefits were frozen as of 12/31/2010.

Early Retirement Benefit: Accrued Benefit actuarially reduced for early payment.
