Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Tax Sheltered Annuity Savings Plan for Employees of Brattleboro Retreat (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- the amounts and disclosures in the 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles (U.S. GAAP).
- the information in the 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

December 31, 2024 and 2023

1. Description of Plan

The following description of the Tax Sheltered Annuity Savings Plan for Employees of Brattleboro Retreat (the Plan) provides only general information. Participants should refer to the Plan provisions for more information. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

General

The Plan is a defined contribution plan sponsored by Brattleboro Retreat (the Company). Employees are eligible for elective deferrals at their hire date. Employees become eligible for the plan once they meet the one year of service eligibility requirement. There is no minimum age requirement.

Contributions

Contributions to the Plan are made by both participants and the Company. Eligible employees may elect to contribute any amount up to 100% of their eligible compensation up to a maximum amount allowable under federal tax regulations. The Company contributes a match calculated as follows: 50% of participants' elective deferrals up to 6% of eligible compensation. The Company may elect to make a discretionary contribution in any plan year. There was no discretionary contribution in 2024.

Vesting

Vesting in both participant contributions and the Company's contributions, and the related investment income and losses credited to the participants' accounts, occurs at the time of contribution, with no restrictions.

Tax Status

The Plan has been designed to qualify under Internal Revenue Code (Code) Section 403(b). The Plan utilizes a volume submitter plan document from Lincoln Retirement Services Company LLC and has obtained a favorable tax determination letter dated March 31, 2017, from the Internal Revenue Service that states the form of the Plan is acceptable under Code Section 403(b). The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Code Section 403(b).

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's account in either a lump-sum amount or in periodic payments. For termination of services due to other reasons, a participant generally receives the value of the vested interest in his or her account as a lump-sum distribution.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Any active employee may apply for a note in an amount limited to the lesser of \$50,000 or one-half of the participant's vested interest in their account, with a minimum of \$1,000. All notes will bear an interest rate equal to the prime rate of interest plus 1% on the date the note is approved with a repayment schedule over a reasonable period of time, generally not to exceed five years.

All notes made are considered a directed investment from the accounts of the participant maintained under the Plan. As such, all payments of principal and interest made by the participant are credited only to the accounts of such participant. The repayment of existing notes outstanding is received monthly through direct after-tax payroll deductions.

2. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities, at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurement.

Contract value is the relevant measure for a fully benefit-responsive contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Administrative Expenses

Substantially all administrative expenses are paid by the Plan.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

Management has considered transactions or events occurring through June 18, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Investment Contracts with Insurance Company

The Plan entered into fully benefit-responsive investment contracts with Lincoln Financial Group. Lincoln Financial Group maintains the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contracts are included in the financial statements at contract value as reported to the Plan by Lincoln Financial Group. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Lincoln Financial Group. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition in competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

4. Information Prepared and Certified by Trustees

The Plan's investments, notes receivable from participants, investment transactions, net appreciation in fair value of investments, and interest and dividends amounts were obtained by management and agreed to or derived from the information certified by Lincoln Financial Group Trust Company, Inc. and Lincoln National Life Insurance Company as of December 31, 2024 and 2023, and for the year ended December 31, 2024. 5. Parties-in-Interest

Certain Plan investments are shares of mutual funds and investment contracts managed by Lincoln Financial Group. Lincoln Financial Group is the third-party administrator and is related to Lincoln National Life Insurance Company and, therefore, these transactions qualify as parties-in-interest transactions. Administrative expenses paid by the Plan for the investment management services amounted to \$155,068 for the year ended December 31, 2024. Notes receivable from participants are also considered party-in-interest transactions.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Fair Value Measurement

Financial Accounting Standards Board Accounting Standards Codification Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the quoted net asset value of shares of underlying funds held by the Plan at year-end which are traded in an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All of the Plan's investments, at fair value, are held in mutual funds and are Level 1 investments with fair values of \$36,013,056 and \$31,109,021 as of December 31, 2024 and 2023, respectively.
