<b>Normal Benefit Amount:</b>	The Normal Retirement Benefit is 50% of Average Compensation reduced proportionately for less than 25 years of Benefit Service. The earned accrued benefit is a fraction of the Normal Retirement Benefit, multiplied by the ratio of (a) actual years of Benefit Service earned to date, divided by (b) potential years of Benefit Service at the Participant's Normal Retirement Date (or actual date of retirement if later).

## Appendix A - Summary of Plan Provisions (cont.)

**Early Retirement Benefit:** The normal retirement benefit accrued to date is reduced to compensate for the longer period over which benefits will be paid. The early retirement reduction is 5% per year, or portion thereof, by which early retirement precedes normal retirement.

**Disability Benefit:** None.

**Termination Benefit:** A terminating participant who has completed five years of service is entitled to receive a vested monthly benefit starting on his normal retirement date. The amount of the benefit is equal to the retirement income earned on the basis of service to date multiplied by the appropriate vested percentage from the following table:

<u>Years of Service</u>	<u>Vested Interest</u>
less than 5	0%
5 or more	100%

A participant will be 100% vested upon attainment of retirement age, or death while an active employee. Service prior to the effective date is excluded from the calculation of vesting credits.

**Normal Form of Benefit:** The normal form of benefit is a monthly income payable for 120 months Certain and Life.

**Optional Benefit Forms:** At the participant's option, retirement income may be paid in any of the optional forms shown below. Election of an optional annuity form may be made at any time before retirement. For any annuity form (other than the subsidized joint and survivor form), the amount of income is adjusted so the cost to the fund is the same as it would have been under the normal annuity form.

- > Straight Life Annuity
- > 50%, 66-2/3%, 75% or 100% Joint and Contingent Survivor Annuity
- > 60, 120 or 180 months Certain and Life Annuity
- > Single Sum Amount if less than \$5,000

**Death Benefits (Pre-Retirement):** That actuarial equivalent of the vested accrued benefit.

**Death Benefits (Post-Retirement):** None except as provided by the annuity form elected.
