Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pomfret School 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Description of Plan

The following description of Pomfret School 403(b) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

General

The Plan is a contributory Internal Revenue Code ("IRC") Section 403(b) defined contribution retirement plan established with an effective date of January 1, 1967 and most recently amended on January 1, 2022. The Plan covers all eligible employees of Pomfret School, Incorporated (the "School"). Employees become eligible to make salary deferral contributions to the Plan immediately following their date of employment. Employees classified as students are excluded from participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and the IRC. The Trustees of the School are responsible for oversight of the Plan. The Retirement Plan Fiduciary Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Trustees of the School.

Contributions

Each year, participants may make salary deferred contributions to the Plan equal to a percentage of their annual pre-tax eligible compensation, as defined by the Plan, up to IRC limits. Participants may designate all or a portion of their salary deferral contributions as Roth deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan has also elected to allow participants with at least 15 years of service to make Special Long Service Catch-up Contributions, as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of College Retirement Equities Fund ("CREF") variable annuity contracts, a Teachers Insurance and Annuity Association of America ("TIAA") pooled separate account, referred to as the TIAA Real Estate Account, TIAA fixed annuity contracts, referred to as the TIAA Traditional Annuity, and a variety of mutual funds as investment options for participants.

The School makes matching contributions to the Plan up to 9% of base compensation that a participant contributes to the Plan in accordance with the following table:

<u>Participant's salary deferral percentage</u>	<u>Matching percentage</u>
At least 1% but less than 2%	5%
At least 2% but less than 3%	6%
At least 3% but less than 4%	7%
At least 4% but less than 5%	8%
5% or more	9%

A participant becomes immediately eligible for the School's matching contribution if they are scheduled to work over 20 hours per week, as defined by the Plan document. Participants also direct the investment of School contributions. All contributions are subject to certain IRC limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and the School's matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Prior to January 1, 2016, eligible participants were vested immediately in all contributions to their account plus actual earnings thereon. Effective January 1, 2016, eligible participants are vested immediately in their salary deferral contributions and rollover contributions plus actual earnings thereon. Vesting in the School's matching contribution portion of their account is based on years of continuous service. Participants will earn a year of vesting service when they have worked at least 1,000 hours in a Plan year. A participant becomes 20% vested after 1 year of service, 40% vested after 2 years of service, 60% vested after 3 years of service, 80% vested after 4 years of service and 100% vested after 5 years of service. However, if an active participant dies or becomes totally and permanently disabled prior to the normal retirement age, the participant's account becomes 100% vested.

Notes receivable from participants

Participants may borrow from certain portions of their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at the time of the loan using the prime rate as published in *The Wall Street Journal* plus 1%. Principal and interest payments are made directly by participants to TIAA-CREF.

Payment of benefits

Upon termination of service for any reason, a participant with an account balance over \$1,000 may elect to receive a single lump-sum amount, annual installments for a specified term, partial withdrawals or an annuity distribution equal to the value of the participant's vested interest in his or her account. If a participant's balance is less than \$1,000, a lump-sum shall be the only available form for distribution. All benefit distributions are subject to the terms of the funding vehicle from which the account balance is being distributed.

Withdrawals from the participant's salary deferral contribution portion of their account (excluding Roth deferrals) may be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Withdrawals from a participant's rollover account may also be made at any time, in accordance with the provisions specified in the Plan. The Plan allows for qualified birth or adoption distributions as a separate distribution event, in accordance with the provisions specified in the Plan. Additionally, in-service withdrawals are allowed in accordance with the provisions specified in the Plan for participants who have attained age 59½.

Forfeited accounts

There were no forfeited nonvested accounts as of December 31, 2024 and 2023. Any forfeited nonvested accounts may be used to pay Plan administrative expenses or used to reduce future employer contributions. For the year ended December 31, 2024, no forfeited nonvested accounts were utilized to pay Plan administrative expenses or to reduce the School's matching contributions.

Note 2 - Summary of accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in two types of fixed annuity contracts, of which one is considered fully benefit-responsive.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

Investment valuation and income recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value - (see Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Fiduciary Investment Committee determines the Plan's valuation policies utilizing information provided by TIAA and CREF and the Plan's investment advisors. See Note 5 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued by unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the School. Expenses that are paid by the School are excluded from these financial statements. Certain investment management fees, loan issuance and maintenance fees, and third-party administration fees are paid directly by the Plan and are included in administrative expenses. Other indirect investment related expenses are included in the net appreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through June 2, 2025, the date the financial statements were available to be issued.

Note 3 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i), were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by TIAA and CREF.

Note 4 - Fully benefit-responsive investment contracts

The Plan has entered into traditional fully benefit-responsive fixed annuity contracts with TIAA, an insurance company, referred to as the TIAA Traditional Annuity, totaling \$1,518,780 and \$1,594,671 as of December 31, 2024 and 2023, respectively. TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed annuity contract issuer is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and ranges between 1% and 3%. Additional amounts above the guaranteed minimum interest rate may be declared at the discretion of the TIAA Board of Trustees on a year-by-year basis.

The crediting rate is reviewed on an annual basis for funds that are already invested in the TIAA Traditional Annuity and on a monthly basis for new contributions coming into the TIAA Traditional Annuity in the accumulation phase for resetting. The fixed annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that causes a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemptions under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreements without the consent of the issuer.

Note 5 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Variable annuity contracts: Valued at the unit value as reported by the accounts. The unit values are listed on the National Association of Securities Dealers Automated Quotation ("NASDAQ") website and updated overnight for each day that NASDAQ is open. The accounts held by the Plan are deemed to be actively traded.

Nonfully benefit-responsive fixed annuity contracts: The fixed annuity contracts that are not fully benefit-responsive are valued based on the accumulated cash contributions and interest credited to the Plan's contracts, less withdrawals. Crediting rates are a combination of a guaranteed rate and an annually established discretionary rate. These annuity contracts are not available for sale or transfer on any securities exchange. Withdrawals under the fixed annuity contracts may be made in the form of a life annuity or in 10 annual installments. The fully benefit-responsive fixed annuity contracts are valued as described in Note 4.

Pooled separate account: Valued at the unit value reported by the account. The unit value is listed on NASDAQ's website and updated overnight for each day that NASDAQ is open. The account held by the Plan is deemed to be actively traded.

Note 6 - Plan termination

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7 - Plan loans

Participants may borrow from TIAA and CREF using the assets in the pre-tax salary deferral and rollover contribution portion of their account balance as collateral. Under this arrangement, TIAA and CREF have the right to collect the collateral in the event of a default. Principal and interest payments are made directly by participants to TIAA and CREF. At December 31, 2024 and 2023, Plan loans totaling \$5,271 and \$21,955, respectively, were outstanding under this arrangement. There was \$0 and \$2,768 defaulted loans at December 31, 2024 and 2023, respectively. Effective January 1, 2022, TIAA no longer offers Plan loans to the Plan's participants.

Note 8 - Tax status

The Plan has been designed using a volume submitter 403(b) plan document sponsored by The Angell Pension Group, Inc. The Angell Pension Group, Inc. received an advisory letter dated March 31, 2017, in which the IRS stated that the volume submitter 403(b) plan document, as then designed, satisfies the applicable requirements of the IRC. Although the Plan itself has not received a determination letter from the IRS, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, the Plan is deemed to be qualified and tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 - Related party and party-in-interest transactions

Certain Plan investments are proprietary investments managed by TIAA and CREF. TIAA and CREF are the insurance entities that hold certain investments and are also the recordkeeper as agent for TIAA Trust, N.A., the custodian of other investments, as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Indirect fees of \$173,855 incurred by the Plan for TIAA and CREF investment management and other administrative services for the year ended December 31, 2024 are included in the net appreciation in fair value of investments. Direct fees of \$62,894 paid to TIAA and CREF for the year ended December 31, 2024, were incurred by the Plan for other administrative expenses and were charged directly to the participant accounts. The Plan received fee leveling credits from TIAA and CREF in the amount of \$6,042 for the year ended December 31, 2024, which is included in other income in the accompanying financial statements. The Plan sponsor pays directly any other fees related to the Plan's operations.

Effective May 1, 2024, all TIAA-CREF proprietary mutual funds and TIAA-CREF Lifecycle funds were renamed Nuveen funds. TIAA is the parent company of Nuveen, therefore, the Nuveen funds are considered proprietary assets and also qualify as party-in-interest transactions.

At December 31, 2024 and 2023, the Plan's revenue sharing account totaled \$23,111 and \$10,153, respectively. This account is used to pay Plan expenses and any excess amounts may be reallocated to participant accounts. The Plan received revenue sharing credits from TIAA and CREF in the amount of \$24,994 for the year ended December 31, 2024, which is included in other income in the accompanying financial statements. The Plan utilized \$12,850 from the revenue sharing account to pay certain administrative expenses and investment advisory fees for the year ended December 31, 2024.

Note 10 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
