We have performed an audit of the financial statements of Pax Machine Works, Inc. 401(k) Retirement Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1. Plan Description

General

The Pax Machine Works, Inc. 401(k) Retirement Plan and Trust (the "Plan") is a defined contribution plan sponsored by Pax Machine Works, Inc (the "Company") for the benefit of its employees who have at least three months of service. The Plan is subject to the provisions of The Employee Retirement Income Security Act (ERISA). The provisions of the Plan are included in the official Plan document, which legally governs the operations of the Plan and is available for more detailed information.

Contributions

Participants may make pre-tax or Roth contributions of their compensation, not to exceed the maximum amount permitted under the Internal Revenue Code. Participants may enter the Plan on the first day of each quarter following completion of three months of service. Seasonal and temporary employees are allowed to participate after one year of service (1,000 hours), and reaching 21 years of age. These participants may enter the Plan on January 1 or July 1 of each year. Catch-up contributions are also permitted by the Plan, as are rollover contributions.

The Company may elect to make a discretionary matching contribution to the Plan. For the year ended September 30, 2024, the Company made a matching contribution of 25% of the first 8% of compensation deferred by the participant.

Participant Accounts

Each participant's account is credited with participant contributions, Company contributions (if any), and Plan earnings and is charged with an allocation of administrative expenses. Company contributions are allocated to participants' accounts based on the matching formula approved by the board of directors. Plan earnings are allocated to participants' accounts on a pro rata basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants have the opportunity of investing in a variety of investment options. All amounts in participant accounts are participant-directed.

Note 1. Plan Description (Continued)

Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. Plan vesting is as follows:

Years of Service	Vesting Percentage
Less than 2 years	0%
2 years	20%
3 years	50%
4 years	60%
5 years	80%
6 years	100%

Forfeitures

Forfeitures are used to pay Plan expenses or used to reduce Company contributions. During the Plan year ended September 30, 2024, approximately \$1,400 of forfeitures were used to reduce employer contributions. There was approximately \$1,000 of forfeited nonvested amounts at September 30, 2024 and 2023, available for future use.

Payment of Benefits

Normal retirement age under the Plan is 65 years, with the option to withdraw funds at the age of 59 1/2. Minimum distributions are required once the participant reaches 73. On termination of service or retirement, a participant has the following options regarding his or her value of the vested interest: a) receive a lump-sum payment, b) rollover the balance into another qualified plan, or c) remain in the Plan as an inactive participant. However, if a terminated participant's vested account balance is \$5,000 or less and they have not elected a rollover, they will involuntarily receive a lump-sum distribution (rollover to an IRA if more than \$1,000). Upon death or disability, participants are fully vested in Company contributions.

Termination

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time, subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 2. Significant Accounting Policies

Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan and Trust Benefit Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and life insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales transactions are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation of the fair market value of investments consists of the unrealized appreciation or depreciation of investments held during the year and the realized gain or loss on investments sold during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Benefit Payments

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Expense Offset Arrangement

Revenue is earned by the Plan from investments and is used to pay Plan expenses. Revenue sharing contributions are recorded as other income and the expenses paid with the contributions are recorded as administrative expenses.

Subsequent Events

Management of the Company has evaluated events and transactions for possible recognition or disclosure through June 12, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by Empower Annuity Insurance Company of America

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America, has certified the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of September 30, 2024 and 2023, and the schedule of assets (held at end of year) as of September 30, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended September 30, 2024.

Note 4. Fair Value Measurements

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

Note 4. Fair Value Measurements (Continued)

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Pooled separate accounts ("PSA"): Valued at net asset value ("NAV") at the end of the Plan year. PSA's are made up of a wide variety of underlying investments such as equities, preferred stock, bonds, real estate and mutual funds. The NAV is based on the value of the underlying assets owned by the PSA, minus any liabilities, and then divided by the number of shares outstanding. The NAV of a PSA is not a publicly quoted price in an active market, therefore, the NAV is used as a practical expedient to estimate fair value. The Plan's PSA investments have a daily redemption frequency, do not require a redemption notice period, and have no unfunded commitments as of September 30, 2024 and 2023, respectively.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Investment Contract with Insurance Company

The Plan holds a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings at guaranteed crediting rates, less participant withdrawals, and administrative expenses.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to the following: 1) temporary absence; 2) change in position or other occurrence qualifying as a temporary break in service under the Plan; 3) transfer of other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; 4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Company's business; 5) removal from the Plan of one or more groups or classifications of participants; 6) partial or complete Plan termination; or 7) Plan disqualification. The Administrative Committee does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Note 6. Transactions with Parties-in-Interest

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Certain Plan investments at September 30, 2024 and 2023, are shares of an investment contract managed by Empower Annuity Insurance Company of America as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan also invests in pooled separate accounts affiliated with Empower Trust Company. Certain administrative expenses of the Plan, including annual audits of the Plan's financial statements, are paid directly by Pax Machine Works, Inc. In addition, certain administrative functions are performed by the employees of the Company at no cost to the Plan.

Note 7. Tax Status

The Plan, which is a prototype plan of Pension Innovations & Consulting, LLC, obtained its latest opinion letter on November 30, 2020, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of Section 401(a) of the Internal Revenue Code ("IRC") and therefore not subject to tax. The Plan has been amended, however, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years ended prior to September 30, 2021.

Note 8. Risks and Uncertainties

The Plan provides for various investment options. The underlying investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Amendment

The Plan was amended, effective July 1, 2025, to reduce the service period to 30 days and allow participants to enter the Plan monthly. Additionally, the Plan added automatic enrollment for employees hired July 1, 2025, at a 3% deferral rate. Participants may still elect their own deferral percentage.
