### TO THE PARTICIPANTS AND ADMINISTRATOR OF RRVW-TCW INCENTIVE COMPENSATION SAVINGS PLAN

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **RRVW-TCW Incentive Compensation Savings Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of RRVW-TCW Incentive Compensation Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

#### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). 

#### NOTE 1 – GENERAL DESCRIPTION OF THE PLAN

---

The following description of the RRVW-TCW Incentive Compensation Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

##### **General**

The Plan is a defined contribution plan covering all employees of Red River Valley & Western Railroad Company (“RRVW”) and Twin Cities & Western Railroad Company (“TCW”), collectively referred to as the “Companies”. Employees are eligible to participate in the Plan on the first day of employment with the Companies. Employees must have 1,000 hours of service and be employed on the last day of the plan year to be eligible for the employer discretionary contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

##### **Contributions**

Each year, participants may contribute pretax or taxed annual compensation, as defined in the Plan, subject to Internal Revenue Service (“IRS”) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catchup contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The participant contributions may be allocated to various investment options as directed by the participant. Newly eligible participants are automatically enrolled 35 days after their date of hire at a pre-tax deferral rate of 3%.

Each Company may declare a discretionary Incentive Compensation Award contribution as determined by the Board of Directors. The Incentive Compensation Award is a set amount that is allocated to participants based on the participant’s percentage of eligible compensation as compared to the total eligible compensation for all employees. Both employers automatically contribute 60 percent of this award to the Plan as an employer non-elective contribution. Employees may elect to receive the remaining 40 percent of the Incentive Compensation Award in cash or contribute it to the Plan as an elective deferral. The participants employed by RRVW were awarded an employer non-elective contribution pool of approximately \$1,203,800 and \$764,500 for the years ended December 31, 2024 and 2023, respectively. The participants employed by TCW were awarded an employer non-elective contribution pool of approximately \$548,100 and \$468,700 for the years ended December 31, 2024 and 2023, respectively.

##### **Participant Accounts**

Each participant's account is credited with the participant's contribution plus allocations of (a) the Company's discretionary contribution and (b) Plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The credits are presented gross as other income to the Plan.

Revenue sharing credits, which are considered parties-in interest transactions, are allocated back to participant's accounts as a reduction of administrative expenses for the respective investment funds which generate such credits.

##### **Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments, either annually or more frequently. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. A participant who has reached normal retirement age may also be eligible to receive in-service distribution subject to other requirements. Participants may request hardship withdrawals for extreme hardships, pursuant to plan requirements, not to exceed the total vested balance.

##### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non vested accounts totaled approximately \$19,000 and \$25,100, respectively. Forfeitures can be utilized to reduce plan expenses or employer contributions. Employer contributions were reduced by forfeitures of approximately \$27,100 and \$19,300 for the years ended December 31, 2024 and 2023, respectively.

##### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loans fund. Loan terms range from 1-5 years or up to 25 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate (4.25% to 9.50%) commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

#### NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

---

##### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. A participant is 100% vested in employer discretionary contributions and earnings after two years of credited service.

The accounting principles and practices which affect the more significant elements of the financial statements are:

##### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure on contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales are recorded on trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment gain (loss) includes the plan's gains and losses on investments bought and sold as well as held during the year.

##### **Notes Receivable from Participants**

Loans to participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation gain of investments.

##### **Risks and Uncertainties**

The Plan provides for various investment options in any combination of a variety of mutual funds. Investments in mutual funds are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain mutual funds, it is at least reasonably possible that changes in values of mutual funds will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

##### **Subsequent Events**

Plan management has evaluated subsequent events from December 31, 2024 through June 20, 2025, the date the financial statements were available to be issued. Management has determined that no such events have occurred.

#### NOTE 3 – OTHER INCOME

---

Other income includes administrative revenue credits provided by Fidelity Management Trust Company with respect to Fidelity Funds or Fidelity Investments that exceed the established revenue threshold provided by the administrative contract. Other income related to revenue credits was approximately \$77,000 and \$83,300 for the years ended December 31, 2024 and 2023, respectively.

#### NOTE 4 – FAIR VALUE

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of observable inputs. The three levels of the fair value hierarchy under FASB ASC No. 820 are described as follows:

Level 1        Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2        Inputs to the valuation methodology include.

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3        Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the net asset value (“NAV”) of shares held by the plan at year end. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market Funds:* Valued at cost which approximates fair value.

#### NOTE 4 – FAIR VALUE – Continued

*Stable Value Common Collective Trust:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that the securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 5 – INCOME TAX STATUS

---

The Company has adopted the Fidelity Management Trust Company Volume Submitter Defined Contribution Plan. The prototype plan received its latest determination letter from the IRS dated June 30, 2020, which states that the plan is acceptable under Section 401(a) of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As the Plan is tax-exempt, the Plan administrator has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### NOTE 6 – FINANCIAL INFORMATION CERTIFIED BY PLAN TRUSTEE

---

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator has obtained a certification from Fidelity Management Trust Company, the trustee of the Plan, that all of the information provided by them is complete and accurate. Information included in the accompanying financial statements and supplemental schedule as of and for the years ended December 31, 2024 and 2023 pertaining to investments, notes receivable from participants, dividend and interest income and net investment gain from mutual funds is presented in reliance solely upon that certification.

Certain Plan investments are managed by Fidelity Management Trust Company, the trustee as defined by the Plan, and therefore recordkeeping, loan, and benefit payment processing transactions qualify as party-in-interest transactions. Fees incurred and paid directly by the Plan participants for recordkeeping, loan and benefit payment processing were approximately \$47,400 and \$41,400 for the years ended December 31, 2024 and 2023, respectively.

#### NOTE 8 – PLAN TERMINATION

---

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.
