**Note 1 - Plan Description**

**General**

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan provisions.

The Plan was established as a defined contribution plan on January 1, 2013 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and Section 401 (k) of the Internal Revenue Code of 1986 (IRC). Substantially all employees of the company are eligible to participate in the Plan subject to the eligibility criteria discussed below.

**Funding**

The Plan is a defined contribution plan wherein participants elect to reduce their compensation and have such reductions contributed to the Plan on their behalf. Participants direct their investments in numerous investment options managed by ADP Retirement Services.

Participants may contribute a total of 1% to 90% of their base salary through payroll deductions to the maximum amount permitted under applicable Internal Revenue Service Provisions. Participants can split their contributions between their pre-tax and/or after-tax accounts. Participants who are age 50 or older may make a “catch-up” contribution in excess of Internal Revenue Code or plan limits.

**Allocation**

Each participant’s account is credited with the participant’s contribution and the Organization’s non-discretionary matching contributions. Investment income or loss is allocated daily based on the ratio of each participant’s account balance at the end of each day. Any discretionary or profit-sharing contribution is made annually to participants employed on the last day of the Plan year.

**Eligibility and Contributions**

Employees are eligible to participate in the Plan on the first day of the month following the completion of the eligibility requirements provided they are at least 21 years of age.

There may be special requirements for participants to be eligible for company matching contributions.

Rollover contributions to the plan are allowed.

**Vesting**

Contributions, any amounts rolled into the plan, and company contributions are adjusted for gains and losses, and are always 100% vested.

**Loans**

Active participants may borrow from their savings with a maximum repayment period of five years, unless for the purchase of a primary residence, with interest rate Prime +2%. Fees may be applied.

**Termination**

Although the Organization has not expressed any intent to do so, management may terminate the Plan at any time. Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or one of various installment payments available under the Plan. In addition, upon termination of the Plan, participant's vested interest in employer contributions shall be 100%.

**Payment of Benefits**

Upon retirement, death, disability, or termination of service benefits are payable to the participant.

**Administrative Expenses**

Fees and expenses of the Plan for legal, accounting, and other administrative services may be paid directly by the Company, or, at the Company's discretion, may be paid in whole or in part from Plan assets.

**Note 2 – Transfer of Assets**

On September 30, 2024, the entire balance of \$36,685,460 of plan assets was transferred to Aon Pooled Employer Plan. As a result, there were no net assets in the Plan as of September 30, 2024. Employees will retain their balances through future contributions, earnings, and benefits available will be made through the new plan. A short plan year and final return 5500 will be filed by the Plan administrator accordingly. Activity beyond September 30, 2024, was not audited and is not reported on the financial statements. All activity related to these plan assets will be reported on Aon Pooled Employer Plan's financial statements going forward.

**Note 3 - Summary of Significant Accounting Policies**

**Basis of Accounting**

This summary of significant accounting policies of the Plan is presented to assist in understanding the financial statements. The financial statements and notes are representations of the Plan's administrator, who is responsible for their integrity and objectivity. The accounting policies conform to accounting principles generally accepted in the United States of America (GAAP) and have been consistently applied in the preparation of the financial statements.

**Estimates**

The preparation of the financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amount reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Investments Valuation and Income Recognition**

Investment contracts held by a defined contribution plan are required to be reported at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Note 4 - Income Tax Status**

The Plan received a letter dated July 08, 2014 from the IRS identifying the Plan as acceptable under section 401 of the IRC. In the opinion of the plan administrator, the plan is currently being operated in accordance with the Plan agreement and in conformity with the applicable provisions of the IRC and therefore exempt from federal income taxes. Therefore, no provisions for income taxes has been included in the Plan's financial statements.

GAAP require plan management to evaluate tax positions taken by the plan and recognize a tax liability or asset if the organization has taken an uncertain position that more likely

than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

**Note 5 - Information Certified by Trustee**

**Note 7 - Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable input (level 3 measurements). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Unadjusted quoted prices available in active markets for identical investments as of reporting date.

Level 2: Observable inputs to the valuation methodology are other than Level 1 inputs, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies.

Level 3: Inputs to the valuation methodology are unobservable inputs in situation where there is little or no market activity for the asset or liability, and the reporting entity makes estimates and assumptions related to the proving of the asset or liability including assumptions regarding risk.
