NOTE 1 – DESCRIPTION OF PLAN

The following description of the Spectrum Industries, Inc. 401(k) Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

Effective July 1, 1993 and restated August 28, 2002, Spectrum Industries, Inc. (the “Company”) implemented a defined contribution plan. The Plan covers substantially all non-union employees of the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan allows other employers to adopt provisions of this Plan. Other employers that have adopted the Plan’s provisions are as follows:

Effective January 1, 2008, the stockholders and the board of directors of the Plan sponsor (Spectrum Industries, Inc.) and Wealthy Street Corporation approved a plan of merger and a certificate of merger. In accordance with the agreements, the Plan sponsor was merged with and into Wealthy Street Corporation. The shares of the Plan sponsor were cancelled and all rights ceased.

The Plan has been amended from time to time to comply with current legislation and management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

Eligibility

Employees become eligible to participate following completion of 60 days of service. They may enter the Plan as of the first day of the month following eligibility. Employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining are not eligible to participate in the Plan unless the agreement expressly provides for participation in this Plan.

Contributions

Participants may make voluntary contributions to the Plan of up to 100% of their annual eligible compensation, but not in excess of the maximum amount permitted by the Internal Revenue Code. The Company may elect to make a matching contribution determined annually. The Company's matching contribution totaled 25% of employee deferrals (up to 8% of eligible compensation). In addition, the Plan sponsor may elect to make a special discretionary profit-sharing contribution to eligible participants, determined each year by management. There was no special discretionary contribution for either of the years ended December 31, 2024 or 2023.

Participants may also elect to contribute after tax dollars into their plan accounts.

Participant accounts

Upon enrollment in the Plan, or at any time subsequent, a participant may direct contributions into any of the available investment options. Each participant's account is credited with contributions in an amount equal to the salary reduction elected by that employee, the related matching contribution and, if applicable, a portion of the special discretionary contribution for non-highly compensated employees equal to a percentage of each eligible individual's compensation. Earnings and administrative expenses are allocated based on the participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately 100% vested in their accounts.

Benefit Payments

Generally, benefits are paid to participants at termination. When the service period ends as a result of death or retirement, the participant or beneficiary will receive a lump sum distribution equal to the value of their accounts. Participants may elect to defer receipt of benefits. At December 31, 2024 and 2023, the Plan had obligations to terminated employees of \$2,055,823 and \$2,118,160, respectively.

Investment Options

All investments are participant directed among various *Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company* and *Principal Life Insurance Company*, mutual fund options at December 31, 2024 and 2023.

Notes from Participants

The Plan no longer allows participants to borrow money from the Plan, except in cases where the participant can prove hardship.

Administrative Expenses

Unless elected to be paid by the Company, administrative expenses incurred in connection with the Plan shall be paid from forfeitures, except for expenses related to distributions and other participant-initiated transactions, which are charged to the account of the participant.

Certain plan administrative fees are absorbed by the Company and certain administrative fees are paid by the Plan. Administrative fees paid by the Plan totaled \$59,027 and \$56,780 during 2024 and 2023, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

All Plan investments at December 31, 2024 and 2023 are held by the Plan custodians, *Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company* and *Principal Life Insurance Company*, and are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for further discussion and disclosure related to fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Realized and unrealized gains and losses on the Plan's investments are included in net appreciation in the fair value of investments in the statements of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America require Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination, the plan custodian shall hold the funds for distribution and distribute to the participants the full amount standing to their credit on the date of such termination, less the administrative cost to the custodian for such distribution, in accordance with the Plan provisions.

NOTE 4 – TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan qualifies under Section 401(a) of the Internal Revenue Code (IRC) and is therefore not subject to tax under present income tax law. Although the Plan has been amended since receiving the determination letter, management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

NOTE 4 – TAX STATUS (CONTINUED)

The Plan has adopted the provisions of ASC Topic 740, *Income Taxes*, relating to uncertain tax positions. ASC Topic 740 provides a consistent framework to determine the appropriate level of tax reserves to maintain for uncertain tax positions. Specifically, the Plan must recognize a tax liability (or asset) if the Plan has taken an uncertain position that *more likely than not* would not be sustained upon examination by applicable taxing authorities.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 or 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition or additional disclosure in the financial statements.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

The Company provides certain accounting, recordkeeping, and administrative services for the Plan for which no compensation is received. Administrative expenses for legal, accounting and other services are rendered by parties-in-interest and are paid by the Company.

Certain plan assets are in investment funds managed by *Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company* and *Principal Life Insurance Company*. *Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company* and *Principal Life Insurance Company* are the Plan custodians; therefore, transactions with *Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company* and *Principal Life Insurance Company* qualify as party-in-interest transactions.

NOTE 6 – INVESTMENTS - UNAUDITED

NOTE 7 – FAIR VALUE OF FINANCIAL INSTRUMENTS

FASB ASC Topic 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). ASC Topic 820 requires fair value measurements to be separately disclosed by level within the fair value hierarchy.

The three levels of fair value hierarchy under ASC Topic 820 are described as follows:

Level 1: inputs to the valuation methodology are unadjusted quoted prices for *identical* assets or liabilities in active markets that the Plan has the ability to access.

Level 2: inputs to the valuation methodology include: quoted market prices for *similar* assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Valuation is generated from model-based techniques that use at least one significant assumption not observable in the market. These unobservable assumptions reflect the estimates of assumptions that market participants would use in pricing the asset or liability.

The following valuation methodologies were used to measure the fair value of the Plan's investments:

Common collective trusts (CCT's) consist of investments in open-ended mutual funds, insurance company separate accounts, and collective trust funds. CCT's are valued at the NAV of underlying portfolio fund shares at year-end. CCT holdings are included as Level 1 assets in the fair value hierarchy.

Pooled separate accounts consist of units of participation in separate accounts, which are valued daily at their accumulated unit value. Accumulated unit value is determined based on the net asset values of the underlying mutual funds, which are generally quoted in active markets that the Plan has access to. There are no transfer or redemption restrictions, and no unfunded commitments on these investments. Pooled separate accounts are included as Level 1 assets in the fair value hierarchy.

Registered investment companies are valued at quoted market prices in an exchange and active markets that the Plan has access to. Registered investment company holdings are included as Level 1 assets in the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Further, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
