Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the GF Health Products, Inc. Employees 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Note 1. Description of Plan

The following description of GF Health Products, Inc. Employees 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan, originally established February 1, 1996, is a defined contribution plan covering all employees of the company who are 21 or older, have completed at least 60 days of service, and are not employed in a Puerto Rico facility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees may enter the Plan on the first day of the month after meeting the eligibility requirements. All eligible employees who have not elected a deferral percentage or opted out of the Plan will automatically have compensation deferred at a starting rate of 6%. Deferral rates are automatically increased 1% every year on January 1st until the deferral equals 8% unless the employees opt out of automatic increases.

Contributions:

Participants may contribute a percentage of their pre-tax annual compensation, as defined in the plan, as well as post-tax Roth contributions as voluntary contributions in accordance with the provisions of Section 401(k) of the Internal Revenue Code. Participants may also contribute amounts representing distributions from other tax qualified plans. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employer matching contributions are made for all persons who were active participants at any time during a pay period. The employer matches 50% of the participants' elected deferrals, up to \$1,000 per year. Qualified nonelective contributions may be made at the Board of Trustees' discretion.

Participant accounts:

Each participant's account is credited with the participant's contribution, an allocation of the employer's contribution, plan earnings, and charged with an allocation of certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer's contributions portion of their accounts is based on years of continuous service. A participant is 100 percent vested after five years of credited service.

Forfeited accounts:

Forfeitures are retained in the Plan and will first be used to reduce employer contributions and then used to pay administrative expenses. In 2024, forfeitures of \$22,839 were used to reduce employer matching contributions. At December 31, 2024, unallocated forfeitures totaled \$18,906 (\$1,814 at December 31, 2023).

Note 1. Description of Plan (continued)

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the rates between 4.25% and 9.50%, which are commensurate with local prevailing rates charged at commercial institutions for similar loans at that time. Principal and interest is paid ratably through payroll deductions.

Payment of benefits:

Upon retirement, death, or disability, a participant or beneficiary may elect to receive either a lump sum amount equal to the value of his or her account, or regular periodic installments, as provided for by the Plan.

Upon termination of service for a reason other than normal retirement, death, or disability, a participant may elect to receive the value of the vested interest in his or her account, as provided for by the Plan. Participants may also make withdrawals prior to termination after attaining age 59 1/2.

Hardship withdrawals are permitted as defined in the Plan documents.

Participants and beneficiaries who have a distributable event that would meet the requirements of an eligible rollover distribution are allowed an in-plan conversion of non-Roth accounts to Roth accounts.

Note 2. Significant Accounting Policies

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative expenses:

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses and certain participant-requested service fees are included in administrative expenses and charged directly to the participant's account.

Note 2. Significant Accounting Policies (continued)

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Payment of benefits:

Benefit distributions, determined in accordance with provisions of the Plan, are recorded when paid.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Note 3. Excess Contributions

The Plan failed discrimination testing for the years ended December 31, 2024 and 2023. At December 31, 2024 and 2023, excess contributions of \$5,575 and \$5,298, respectively, are recorded as a liability in the accompanying Statements of Net Assets Available for Benefits and as a corresponding distribution for 2024 and 2023. The Plan distributed 2024 excess contributions to the applicable participants prior to March 15, 2025, and distributed 2023 excess contributions to the applicable participants prior to March 15, 2024, in accordance with the Internal Revenue Code (IRC).

Note 4. Related Party Activity

Certain plan investments are management by John Hancock Trust Company, LLC. John Hancock Trust Company, LLC is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan pays administrative fees to John Hancock Retirement Plan Services (an entity related to John Hancock Trust Company, LLC through common ownership), which totaled \$40,721 for the year ended December 31, 2024, and is included in the Statement of Changes in Net Assets Available for Plan Benefits. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

- C. Investment information included in Schedule of Assets Held at End of Year.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Plan sponsor has the right under the plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their accounts.

Note 8. Income Tax Status

The Plan adopted a prototype basic plan document and received an opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the prototype basic plan document is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Any employer adopting this form of the plan will be considered to have a plan qualified under the applicable section of the IRC. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes is included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Fair Value Measurements

The Plan's investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as quoted by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net assets value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value fund: The net asset value (NAV) for each unit class of the trust is calculated daily by dividing the net assets applicable to each unit class by the respective number of units outstanding for the class. Deposits to and withdrawals from the trust may be made daily at the current net asset value (NAV) per unit. Each unit is equal in value to every other unit.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
