1. Description of the Plan

The following description of the Affiliated Healthcare Systems Retirement Partnership 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General – The Plan is a defined contribution plan sponsored by Affiliated Healthcare Systems (AHS or the Employer) for the benefit of its employees. All employees, except for those: (i) covered by a collective bargaining agreement, unless the agreement requires the employees to be included under the Plan; (ii) leased employees; (iii) nonresident aliens; and (iv) employees who are eligible to participate in the Northern Light Health Retirement Partnership 403(b) Plan, are immediately eligible to participate in the Plan. Employees of AHS who have been paid for at least 1,000 hours in the 12 months following their date of hire and have attained age 21 are eligible to receive Employer contributions beginning the January 1 or July 1 following their one-year anniversary. AHS and the plan administrator control and manage the operation and administration of the Plan. Fidelity Management Trust Company serves as the Plan's trustee and maintains the Plan's investments. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, contributions under the Plan are permanently discontinued and the Plan is frozen. Accounts of all participants became 100% vested as of January 1, 2024.

Contributions – The Plan provides that eligible employees can contribute to the Plan through payroll deferrals at specified percentages of their compensation. Employees may defer up to 84% of their pay subject to Internal Revenue Service (IRS) limits. Under current IRS regulations, amounts contributed by participants are excluded from the participants' taxable income until such amounts are received by them as a distribution from the Plan. However, the Plan also provides that AHS, when extending the benefits of the Plan to any employee, may place limitations on the amount of employee contributions to comply with certain statutory limitations.

The Employer makes a non-discretionary contribution to the Plan in amounts ranging between 50%-100% of the participants' contributions, subject to a maximum of 4% of a participant's base compensation.

Investment Options – Participants may direct their contributions and Employer contributions and any related earnings into various investment options. Investment objectives are as stated in the prospectus. The Plan currently offers several mutual funds and a group annuity contract as investment options for participants.

Vesting – Participants' accounts are fully vested at all times in employee deferral contributions and are not subject to forfeiture for any reason. Participants are fully vested in Employer contributions after three years of vesting service, with the exception of the Miller Drug Plan participants. For these participants, matching Employer contributions received from the Miller Drug Plan will vest ratably over five years. Safe harbor and discretionary Employer contributions from the Miller Drug Plan are fully vested at all times.

Forfeited Accounts – At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$535 and \$6,941, respectively. Forfeited balances of terminated participants will be used to reduce administrative fees and future Employer contributions. During the years ended December 31, 2024 and 2023, \$6,920 and \$343, respectively, of forfeitures were used.

Payment of Benefits – Participants receive distributions upon the occurrence of the following events: (i) termination of employment; (ii) attaining normal retirement age; (iii) becoming disabled; (iv) demonstration by the participant to the plan administrator that the participant is experiencing hardship, as defined in applicable regulations promulgated or to be promulgated pursuant to Section 401(k) of the Internal Revenue Code (IRC) or standards established by the Secretary of the Treasury or his/her delegate; or (v) requesting in-service withdrawal upon attainment of age 59½. Participants may elect to receive part or all of his/her distribution in a lump sum, an annuity or have the amounts rolled over. Absent an election by the participant, distributions of less than \$1,000 are made in a lump sum; distributions between \$1,000 and \$5,000 are automatically rolled over to an IRA; and amounts over \$5,000 are maintained in the Plan.

Participant Accounts – Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contribution, rollovers, and allocations of (1) employer discretionary contributions and (2) plan earnings, and charged with an allocation of Plan losses and expenses. Allocations are based on participant earnings of account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants – Participants may borrow from their own contributions up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's accounts and bear interest at rates that range from 4.25% to 9.50%. Interest rates are set at prime plus 1% at the time of the loan.

2. Summary of Significant Accounting Policies

Method of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Risks and Uncertainties – The Plan invests in various mutual funds and a group annuity contract which invests in various securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Benefits – Benefits to participants are recorded when paid.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value, except for a benefit-responsive investment contract, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments. See Note 8 for discussion of fair value measurement.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

3. Investment Contract with Insurance Company

The Plan has a benefit-responsive investment contract with Lincoln National Life Insurance Company (Lincoln). Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

4. Information Certified by the Trustee of the Plan

The investments, investment transactions, net appreciation in fair value of investments, notes receivable from participants and interest and dividends were obtained by management and agreed to or derived from the information certified by Fidelity Management Trust Company, the trustee of the Plan, as complete and accurate. 5. Related-Party Transactions

Plan investments include shares of mutual funds sponsored and managed by Fidelity Investments (Fidelity). Fidelity Management Trust Company, an affiliate of Fidelity, is the trustee of the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

Fidelity provides certain administrative services to the Plan pursuant to a Master Services Agreement (MSA) between the Employer and Fidelity. Fidelity receives revenue from mutual fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan. If the revenue received by Fidelity from such mutual fund service providers exceeds the amount owed under the MSA, Fidelity remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During the years ended December 31, 2024 and 2023, \$6,944 and \$4,029, respectively, were remitted to the Plan and \$7,760 and \$6,430 were applied to the payment of administrative expenses for the years ended December 31, 2024 and 2023, respectively. No amounts were allocated to participants accounts in 2024 or 2023. The remaining unallocated balance of \$36,078 and \$35,727 as of December 31, 2024 and 2023, respectively, is included in investments at fair value in the accompanying financial statements.

Participants are directly charged a quarterly flat fee of \$10.75 for 2024 and 2023. Total record keeper fees paid to Fidelity were \$21,313 and \$21,005 for the years ended December 31, 2024 and 2023, respectively. Retirement consultant fees paid by the Plan were \$6,920 and \$343 for the years ended December 31, 2024 and 2023, respectively.

6. Plan Termination

Although it has not expressed any intent to do so, AHS has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

7. Tax Status of the Plan

The Plan is part of a prototype plan designed by the trustee. The IRS has determined and informed the trustee by a letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination; however, the plan administrator believes that the Plan is designed and currently operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

8. Fair Value Measurement

The framework for measuring fair value in accordance with U.S. GAAP establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, and other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

Mutual funds – The fair values of mutual funds are based on the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
