## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements**

We have performed an audit of the financial statements of the Miccosukee Tribe of Indians of Florida 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO THE FINANCIAL STATEMENTS**

---

**NOTE 1 – PLAN DESCRIPTION**

The following description of the Miccosukee Tribe of Indians of Florida 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan's document for a more complete description of the Plan's provisions.

**General**

The Plan, which was incepted on January 1, 1997, is classified as a defined contribution 401(k) plan, covering employees of Miccosukee Tribe of Indians of Florida (the “Tribe”) (the “Employer”) with at least one-half year of service during the Plan year and who are ages 18 or older. The primary purpose of the Plan is to provide employees of the Tribe with financial benefits upon retirement.

**Contributions**

Each year participants may elect to contribute a portion of their gross compensation, not to exceed the IRS limit for the plan year, through a salary reduction agreement. Participants direct the investment of their contributions into various investment options offered by the Plan. The Employer made discretionary contributions on behalf of the participants. This Contribution consisted of 100% of the first 5% of an employee's compensation. The contributions are credited to individual accounts for each participant.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through bi-weekly payroll deductions.

**Vesting**

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Tribe's matching contributions is immediately vested.

**Payment of Benefits**

Upon retirement, disability or death, a participant or beneficiary receives the entire amount credited to the participant's account in either a lump sum or, at the participant's election, in annual installments. Upon termination, other than by retirement, disability or death, a participant becomes eligible to receive the current value of the participant's vested account in a lump sum.

**Participant Investment Rollovers**

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America. Presented below is a summary of significant accounting principles followed in the preparation of the accompanying financial statements.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

**Investment Valuation and Income Recognition**

At December 31, 2024 and 2023, the Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurement.

The net appreciation in the fair value of investments includes realized and unrealized gains and losses on fair value of investments held by the Plan. Purchases and sales of investments are recorded on a settlement date basis. Interest income is accrued as it is earned and dividends are recorded as of the ex-dividend date.

The change in net unrealized appreciation of investments held from the beginning of the plan year to the end of the plan year is included with realized gains/losses as net investment income/loss reported in the accompanying statements of changes in net assets available for benefits.

**Administrative Costs**

Administrative expenses charged to the Plan during the plan year ended December 31, 2024 were \$114,344.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles and with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results may differ from those estimates.

**Payment of Benefits**

Benefits are recorded when paid.

**Income Tax Status**

The Plan uses a prototype adoption agreement provided by the Plan's certifying entity. The Plan administrator believes the Plan is a qualified trust under Section 401 of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's certifying entity has obtained a favorable tax determination letter from the Internal Revenue Service regarding the prototype adoption agreement and therefore believes it to be exempt from Federal income taxes under Section 501(a). The Plan's prototype adoption agreement has been amended since receiving the determination letter to comply with new requirements.

The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

**Subsequent Events**

The Plan has evaluated subsequent events through June 12, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Tribe has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In the event of the termination of the Plan, the rights of the affected participants under the Plan shall be fully vested and nonforfeitable.

**NOTE 4 – RISK AND UNCERTAINTIES**

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 5 – INFORMATION CERTIFIED BY THE PLAN'S CERTIFYING ENTITY**

The Plan's investments were held and administered by State Street Bank & Trust, the Plan's certifying entity. All investment information presented in the accompanying financial statements and supplemental schedule, including notes receivable, investments held and net appreciation in fair value of investments and interest and dividends, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Plan's certifying entity listed above in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

**NOTE 6 – GUARANTEED INVESTMENT CONTRACT**

The Plan offers participants the option to invest in a Guaranteed Investment Option (“GIO”) issued by Transamerica Life Insurance Company (“Transamerica”). The GIO is a group annuity contract that is backed by the general account of Transamerica and is designed to provide preservation of principal and a guaranteed rate of return. Transamerica guarantees the payment of principal and a fixed interest rate credited to participant accounts. The interest rates are set by Transamerica periodically and are guaranteed for a specified period. The average crediting interest rate for the year ended December 31, 2024 was 2.46%.

Participants may ordinarily direct permitted withdrawals or transfers from the GIO at contract value. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses.

The GIO is a benefit-responsive investment contract and is presented at contract value in the statements of net assets available for benefits. Contract value is the relevant measure for participant transactions because it is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Certain events, such as Plan termination, bankruptcy of the Plan sponsor, or a mass layoff, could limit the Plan’s ability to transact at contract value with Transamerica. The Plan administrator does not believe that the occurrence of any such events which would limit the Plan’s ability to transact at contract value with participants is probable.

At December 31, 2024 and 2023, the contract value of the GIO was \$2,820,979 and \$892,442, respectively.

**NOTE 7 – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include the following:
  - Quoted prices for similar assets or liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in inactive markets
  - Inputs other than quoted prices that are observable for the asset or liability
  - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means
  - If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE 7 – FAIR VALUE MEASUREMENTS (Continued)**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the quoted net asset value ("NAV") of shares held by the Plan at year end.

*General account:* Valued at by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

*Common/Collective trusts:* Valued at the net asset value of units of a bank collective trust. The net asset value, as provided by the certifying entity, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchased and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 8 – TRANSACTIONS WITH PARTIES-IN-INTEREST**

Certain Plan investments are held in cash reserves or in common/collective trusts with State Street Bank & Trust Co. (certifying entity) and Transamerica are considered party-in-interest.

Certain participants of the Plan had outstanding loans (notes receivable from participants) with the Plan as of December 31, 2024 and 2023. These loans are considered party-in-interest transactions according the DOL guidelines. Total notes receivable from participants as of December 31, 2024 and 2023 were \$2,210,839 and \$2,018,470, respectively.

**NOTE 9 – DEEMED DISTRIBUTIONS**

As of December 31, 2023 there were deemed distributions, as a result of defaulted plan loans, of \$43,660.
