


NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

Note 1 - Description of Retiree Plan and Significant Accounting Policies

The following description of the Retiree Plan of the I.U.O.E. Local 15 Welfare Fund (the "Retiree Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Retiree Plan first became effective January 1, 2013 and is a welfare benefit plan established under an Agreement and Declaration of Trust pursuant to collective bargaining agreements between the International Union of Operating Engineers Local 15, 15A, 15B, 15C, 15D, 15G, 15H (the "Union") and various employers and employer associations in the construction industry in the New York Metropolitan Area. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Benefits for retired participants, eligible under the terms of the Welfare Fund of the International Union of Operating Engineers Local Unions 15, 15A, 15C, 15D AFL-CIO (the "Welfare Plan"), are paid by the Retiree Plan. The financial activity of the Retiree Plan, as well as the Welfare Plan, is accounted for through a single trust. Employer contributions are allocated to cover the expenses of the Retiree Plan. Pending guidance from the Department of Labor, the Retiree Plan's financial statements only reflect the activity of the Retiree Plan. For clarity, the Retiree Plan's financial statements should be read in conjunction with the Welfare Plan's financial statements.

Management has evaluated subsequent events through the date of the auditor's report, the date the financial statements were available to be issued.

Purpose

The purpose of the Retiree Plan is to provide health and other benefits to eligible participants.

Benefits

Benefits are paid by means of a trust and group insurance contracts. The benefits include, but are not limited to medical, dental, optical, death, Medicare supplemental, hospital, prescription drugs, and surgical. Medical Reimbursement Accounts (Health Reimbursement Accounts) provide additional health care benefits that are limited to amounts accumulated in the individual account and are governed by the provisions of the Plan.

Actual benefits, including conditions and limitations thereto, are governed by the provisions of the Retiree Plan.

Note 1 - Description of Retiree Plan and Significant Accounting Policies (cont'd)

Participants consist of the following classes

Retired participants and dependents

Participants consist of retired participants receiving retirement benefits from the Central Pension Fund of the International Union of Operating Engineers. Retirees must be over the age of 62 and have either attained three pension credits within the five year period immediately preceding retirement and have a minimum of 10 years of credited service, or have 25 years of pension credit at the time they apply for retirement.

Plan termination

The Trustees expect and intend to continue the Retiree Plan indefinitely, but reserve the right to amend or terminate it as provided for by the applicable Trust Agreement and Retiree Plan provisions. If the Retiree Plan is terminated, trust assets will be used to pay all expenses under the terms of the Retiree Plan in the order of priority specified in the Plan and as otherwise required by law.

Basis of accounting

The financial statements are presented on the accrual basis of accounting.

Postretirement benefit obligations and other plan benefits

As the Welfare Plan has committed to fund the postretirement benefit obligations as well as the estimated claims payable and claims incurred but not reported, these obligations will continue to be reflected on the Welfare Plan's financial statements.

Administrative expense allocation

The administrative office is occupied by the Retiree Plan and various related organizations. Certain expenses not specifically applicable to a particular entity are allocated based on the estimated benefit received by each entity. Amounts reported as receivable from related organizations or payable to related organizations generally include balances for shared expenses.

Administrative expenses estimated to be attributable to the Retiree Plan for the years ended December 31, 2024 and 2023 were \$256,650 and \$202,224, respectively.

Note 2 - Employers' contributions

In accordance with collective bargaining agreements and participation agreements, employers are required to make contributions to the Welfare Plan on behalf of employees performing covered work. Employers' contributions are generally based on hours paid.

Note 2 - Employers' contributions (cont'd)

Employers' contributions are allocated to the Retiree Plan to cover benefit payments and share administrative expenses.

Note 3 - Form 5500 clarification

The Welfare Plan's Form 5500 - Schedule H - Part II reflects all benefits (including benefits attributable to the Retiree Plan). The benefits attributable to the Retiree Plan are then reflected as a reduction on Line 2e(3). The Retiree Plan's Form 5500 - Schedule H - Part II reflects the benefits attributable to the Retiree Plan as a positive amount on Line 2e(3).

Note 4 - Tax status

The trust funding the Retiree Plan has received an exemption letter from the IRS dated May 5, 1977, stating that the trust is tax exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code ("IRC"). The Retiree Plan and trust are required to operate in conformity with the IRC to maintain the tax exempt status of the trust. The Trustees believe that the Retiree Plan, including amendments, is being operated in compliance with the applicable requirements of the IRC and, therefore, believe the related trust is tax exempt.
