Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Comniscient Technologies, LLC 401(k) P/S Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Notes to Financial Statements

Note 1 - Description of Plan

The following description of the Comniscient Technologies, LLC 401(k) P/S Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan, established on January 1, 2014, is a defined contribution plan sponsored by Comniscient Technologies, LLC (“the “Plan Sponsor”) and is intended to provide eligible employees with supplemental retirement income. The Plan covers all employees of Comniscient Technologies, LLC, Cloud Stream Communications LLC, Telecom Resource Center LLC, and Opensignal, Inc. (collectively referred to as the “Employer” or “Company”). The Plan offers retirement benefits for employees other than employees subject to a collective bargaining agreement or non-resident aliens. The Plan is funded through both Employer and employee contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Substantially all investments are participant directed.

Employees become eligible to commence salary deferrals and receive an Employer matching contribution once they have attained the age of 18 and have completed one month of service following the commencement of employment.

Employees become eligible for the Employer matching contribution once they have completed 1,000 hours of service during the plan year and are employed by the Company at the end of that period.

Participant Contributions

Participants may contribute pre-tax or roth up to 100% of their annual compensation as defined by the Plan up to certain limitations. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan may accept Rollover contributions made on behalf of any eligible employee regardless of whether the employee has met the age and service requirements. Eligible employees that have not met the eligibility requirements of the Plan will be deemed a Participant to extent of amounts in the employee’s Rollover Contribution Account.

Employer Contributions

Each Plan year, the Company may make matching contributions, on behalf of the employees, in its sole discretion. For the Plan year ended December 31, 2024, the Company elected to match 75 cents on the dollar, up to 4% of pay.

The Company may make, in its sole discretion, a non-elective contribution to the Plan for the benefit of participants at its discretion, in addition to the matching contributions. No such contribution was made for the 2024 Plan year.

In addition to the contributions described above, the Company may make additional Qualified Non-Elective Contributions for the benefit of participants determined at the discretion of the Company. No such contribution was made for the 2024 Plan year.

Note 1 - Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Employer's contributions and Plan earnings, and reduced by direct loan fees, benefit disbursement fees, if applicable, and investment professional fees. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and Employer matching contributions plus actual earnings thereon.

Forfeitures

At December 31, 2024 and 2023, there was \$17 and \$0, respectively, in forfeited non-vested accounts. These amounts may be used to offset Plan expenses or to reduce Employer contributions. During the year ended December 31, 2024, no forfeitures were used to offset Employer contributions or pay Plan expenses.

Payments of Benefits

In-service withdrawals from a participant's elective account are permitted only due to financial hardship or upon reaching age 65. Hardship withdrawals may be taken from all accounts without respect to earnings. The amount of hardship distribution cannot exceed the amount to meet the immediate financial hardship. Upon termination of service with the Company, if the vested amount (excluding rollovers) does not exceed \$5,000, the vested Account balance will be distributed from the Plan. Participants may elect to 1) receive this distribution in cash or in-kind; or 2) roll over the distribution to an individual retirement account (IRA) or the qualified plan that allows such rollovers. However, if the participants do not timely return their election forms, the following will apply: if the vested amount of a participant's Account balance is less than or equal to \$1,000, the participant's vested Account will be distributed to them in cash. If the participant's vested Account balance is more than \$1,000, but does not exceed \$5,000, the Plan administrator will transfer the vested Account to an IRA established in the participant's name; unless the distribution occurs after the Required Beginning Date.

Notes Receivable from Participants

Subject to approval by the Plan administrator, a participant may borrow a minimum of \$1,000 up to the lesser of \$50,000 or 50% of the participant's vested account. The loans are secured by the balance in the Participant's vested account and bear interest at prime plus 1%. Loan terms are up to five years unless the loan is for the purchase of a primary residence, which can be for up to twenty years. The Plan allows participants to have up to one loan outstanding at a time. Principal and interest are paid ratably through payroll deductions.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

Investments, Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the trustee and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits Paid

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from the estimates that were used.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Subsequent Events

The Plan administrator has evaluated subsequent events through June 25, 2025, the date that the financial statements were available to be issued. No significant matters were noted for disclosure as part of the evaluation.

Note 3 - Information Certified by Custodian

Plan investments are held in mutual fund accounts by Ascensus Trust Company (“Ascensus”), the custodian and trustee. The fair value of investments as of December 31, 2024 and 2023, and all investment transactions for the year ended December 31, 2024, including interest and dividends, and net appreciation in fair values are certified as complete and accurate and reported to the Plan by Ascensus, LLC as agent for Ascensus Trust Company. Information contained in the supplemental schedule and notes receivable from participants is also certified by Ascensus.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level I – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level II – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III – Inputs that are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 - Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events such as an international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

Note 7 - Tax Status

The Plan adopted the Plan Administrators, Inc. Non-Standardized Pre-Approved Profit Sharing Plan that received a favorable determination letter from the Internal Revenue Service on June 30, 2020. Management believes the Plan's operations have been and intend to continue to be in accordance with all applicable provisions of the Internal Revenue Code and ERISA. Therefore, no provision for income taxes has been included in the Plan's financial statements.

During the year ended December 31, 2022, it was discovered that certain of the Plan's provisions related to the definition of compensation for participant and Employer contributions as per the Plan document were not properly applied, the results of which are not determinable as of the date of this report. The Plan Sponsor has engaged ERISA counsel to file through the Voluntary Correction Program ("VCP") with the IRS to fully correct these matters to maintain the Plan's tax exempt status. Plan management feels that any corrective actions required by the IRS will not have a material effect on the Plan. The filing was completed in May of 2024. There has been no determination from the IRS.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds held by Ascensus. Ascensus is the trustee and custodian, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid to the trustee and custodian totaled \$45,229 for the year ended December 31, 2024. Notes receivable from Participants also qualify as exempt party-in-interest transactions, as defined by ERISA.

Note 9 - Delinquent Participant Contributions

Defined contribution plans are required to remit participant contributions to the Plan as soon as they can be reasonably segregated from the Employer's general assets. While the Employer remitted substantially all participant contributions to the Plan, contributions of \$1,224 were not remitted within the required time frame during the year ended December 31, 2023, as reflected in the accompanying Schedule of Delinquent Participant Contributions. The Employer calculated lost earnings of affected participants and deposited into the Plan in 2025.
