INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of
Plan International USA, Inc. Retirement Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Plan International USA, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the Plan International USA, Inc. Retirement Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution 401(k) profit sharing plan covering generally all employees of Plan International USA, Inc. (the Plan Sponsor or Employer). The Plan is subject to the provisions of the Employee Retirement Income Securities Act of 1974 (ERISA).

The Plan is administered by the Employer. As administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Two employees of the Employer serve as trustees to the Plan for the term of the trust or until appointment of successors. Hand Benefits & Trust Company is the custodian of the Plan, with administration and recordkeeping performed by BPAS Plan Administration and Recordkeeping Services.

Contributions

Upon attaining age 21 and completing two months of employment, participants may elect to contribute an amount or percentage of their pre-tax or after-tax compensation not to exceed the maximum salary reduction contribution permitted by the Internal Revenue Service (IRS) (\$23,000 plus catch-up contributions of \$7,500 for participants age 50 or older in 2024). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Upon enrollment in the Plan, a participant may direct contributions among various investment vehicles with varying investment goals and risks.

The Employer contributes a safe harbor non-elective contribution equal to 3% of a participant's eligible compensation. In addition, the Employer may contribute a discretionary matching contribution equal to a percentage of each eligible participant's contribution. An additional discretionary non-elective Employer contribution may be made annually, in an amount determined by the Employer.

To be eligible to receive Employer contributions, an employee must have been employed for a year (with a minimum of 1,000 hours worked within 12 months) and have attained 21 years of age.

The Employer elected to match 100% of each participant's pre-tax and after-tax (Roth) contributions up to a maximum of 2% of the participant's eligible compensation for the year ended December 31, 2024. The Employer also elected to contribute a discretionary non-elective profit-sharing contribution in the amount of 3.5% of each participant's eligible compensation for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and their allocations of the Employer's contributions, Plan earnings and losses, and investment expenses. Allocations are based on participants' compensation or account balance, as defined in the agreement. The benefit to which a participant is entitled is the benefit provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus the allocation of Plan earnings on those contributions, at the time of allocation. The safe harbor contributions are vested immediately. Participants become 100% vested in the Employer contributions and the annual allocation of Plan earnings on those contributions after three years of service (50% after two years). In the event of death, disability or attainment of retirement age, the participant shall immediately become 100% vested in his/her account.

Participant Notes Receivable

Participants may borrow from their account a minimum of \$1,000 up to a maximum generally equal to the lesser of \$50,000 or 50% of the vested value of their accounts. Participants are only allowed to have one outstanding loan at a time. Note terms range from 1 to 5 years or up to 15 years for the purchase of a primary residence. The notes are secured by the participant's vested balance and bear interest at the prime rate plus 1%. Notes are repaid to the Plan through after-tax payroll deductions.

Payment of Benefits

Benefits are available for distribution upon retirement, death, disability or termination in a single lump sum or in periodic installments, as elected by the participant or beneficiary. Participants who have attained age 59½ may elect to withdraw all or a portion of their vested account while still employed. Participant vested account balances that are \$1,000 or less upon termination will be paid in an immediate lump-sum distribution. If a participant's vested balance exceeds \$1,000 and is equal to or less than \$5,000, the amount will be rolled over to an individual retirement account designated by the Employer, unless otherwise directed by the participant.

Hardship withdrawals from the Plan are also permitted subject to the applicable IRS laws.

The Plan also permits qualified birth or adoption distributions, whereby a participant may receive a distribution up to \$5,000 during the 1-year period beginning on the date on which the participant's child is born or on which the legal adoption by the Participant of an eligible adoptee is finalized.

Forfeitures

Forfeitures are created when participants terminate employment before becoming fully vested in their accounts. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,055 and \$6,233, respectively. Forfeitures are retained in the Plan and may be used to pay administrative expenses or to reduce Employer contributions payable under the Plan. During 2024, \$17,476 of forfeitures were used by the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest and are secured by the balance in the respective participant's account. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within stated terms. Delinquent notes receivable from participants are reclassified as distributions based on terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Contributions

Employer and participant contributions are recorded bi-weekly when the Employer remits the payroll deductions for investment into the Plan.

Payment of Benefits

Benefits are recognized when paid to participants or their designated beneficiaries.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Employer unless the Employer directs that such expenses shall be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest risk, market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

Financial Instruments with a Concentration of Credit Risk

The Plan's investments are held by a single custodian. The Plan's exposure to credit risk is associated with the outside entity's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

Subsequent Events

The Plan Sponsor has evaluated events through June 24, 2025, which is the date these financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust: Valued at the net asset value of units of a collective trust. The NAV, as provided by Hand Benefits & Trust Company, N.A., is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. Unit values are determined by dividing the fund's net assets at fair value by its units outstanding at the valuation dates.

4. Plan Termination

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan or contributions thereto at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. In the event of Plan termination, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

5. Income Tax Status

The Plan has been designed using a volume submitter plan document designed by Benefit Plans Administrative Services LLC (BPAS). BPAS received an advisory letter dated June 30, 2020, in which the IRS stated that the volume submitter plan satisfies the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the advisory letter in order to comply with the latest applicable tax laws and regulations. The Employer and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

6. Summary of Financial Data Certified by the Custodian

The following is a summary of financial information and data certified by the custodian, Hand Benefits & Trust Company:

Statements of Net Assets Available for Plan Benefits at December 31, 2024 and 2023;

Investment income and interest income from participant notes receivable on the Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024; and

Investment information provided in the supplemental schedule, Schedule of Assets (Held at End of Year) at December 31, 2024.

7. Differences from Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

8. Related Party Transactions and Party-in-Interest Transactions

Plan investments are held and managed by Hand Benefits & Trust Company, the custodian of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to the custodian for administrative services totaling \$28,857 for the year ended December 31, 2024. The Plan also made direct payments to its investment advisor of \$80,385 during 2024. Participant notes receivable also qualify as party-in-interest transactions. Two employees of the Employer serve as the Trustees of the Plan.
