Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 401(a) Profit Sharing Plan of Chugachmiut, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of 401(a) Profit Sharing Plan of Chugachmiut's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended September 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1: Description of Plan

The following description of the 401(a) Profit Sharing Plan of Chugachmiut (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was established on October 1, 1989 and was amended as of January 1, 2022. The Plan is a defined contribution plan covering all employees of Chugachmiut (the Employer). Employees are eligible to participate after completing one year of service during which an employee is credited with 1,000 hours of service. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Employer Contributions

Each plan year, the Board of Directors determines the percentage of the contribution, if any, that will be made for eligible participants. Contributions are allocated to the accounts of the eligible participants on the basis of the ratio that each eligible participant's compensation bears to the total compensation of all eligible participants for the plan year.

The aggregate annual contributions may not exceed the lesser of 25% of compensation or \$69,000 or \$66,000 per participant for the 2024 and 2023 plan years, respectively. Maximum compensation considered in the contributions calculation is \$345,000 and \$330,000 for the 2024 and 2023 plan years, respectively.

Participant Accounts

Each participant account is credited with an allocation of the employer contribution and the plan earnings. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that are reasonable and commensurate with the current commercial rates charged on similar loans by persons in the business of lending money. Principal and interest is paid ratably through biweekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or in annuity payments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants with balances less than \$1,000 will receive a lump-sum payment. Hardships and in-service withdrawals are permitted if certain criteria are met.

Vesting

Participants who achieve the retirement age of 65, are deceased, or become disabled are 100% vested in their accounts provided that they were an employee at the time of such event. Upon termination of employment for any reason other than those previously described, participants are vested in their accounts based on years of completed service. A participant is 100% vested after six years of credited service.

Additionally, any prior service with North Pacific Rim Housing Authority will count towards years of vesting service.

Forfeited Accounts

Forfeitures are non-vested accounts of participants who terminate employment. Forfeitures are used first to pay certain expenses incurred by the Plan. Remaining forfeitures shall then be allocated among eligible participants based on the ratio of each participant's compensation to the compensation of all Plan participants. Forfeited non-vested accounts totaled \$70,442 and \$57,166 at September 30, 2024 and 2023, respectively. These amounts are allocated among eligible participants in the subsequent plan year.

If termination of employment occurs and the participant's non-vested account is forfeited, the forfeited account will be fully restored if reemployment or break in service does not exceed five years.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared using the accrual basis of accounting.

Uses of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Interest Accumulation Account

The Interest Accumulation Account with Mutual of America Life Insurance Company is comparable to a cash equivalent. There are no front or back-end charges, so the account is completely liquid. The interest rate accredited to the account is a current rate and is not dependent upon the length of time the assets are invested. Requests for withdrawal can be made any time. The value shown is the redeemable value; there are no deferred sales charges, load assessments or interest rate adjustments that would affect the value.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation/depreciation includes the Plan's gains and losses on the investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan Administrator has evaluated subsequent events through June 13, 2025, the date on which the financial statements were available to be issued.

Note 3: Information Certified by Mutual of America Life Insurance Company

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mutual of America Life Insurance Company, as issuer, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- (a) Interest accumulation account and investments at fair value, as shown in the Statements of Net Assets Available for Benefits;
- (b) Interest income and net appreciation in fair value of investments, as shown in the Statements of Changes in Net Assets Available for Benefits; and
- (c) All information included in the Schedule of Assets (Held at End of Year), as shown in the supplemental schedule.

Note 4: Fair Value Measurement

Fair value is defined as the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. A framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below.

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts: Investments in insurance company pooled separate accounts are reported at their fair value. Fair value represents the Plan's proportionate share of the total fair value of the net assets of the underlying mutual funds. In determining the total fair value of the net assets of the investment funds, the issuer has valued investments at the quoted closing NAV per share, as reported in active public markets.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Tax Status

The Internal Revenue Service (IRS) has determined and informed the Plan Sponsor by a letter dated October 8, 2015, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the October 8, 2015 determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6: Plan Termination

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of any termination of the Plan, or upon complete or partial discontinuance of contributions, the accounts of each affected participant shall become 100% vested.

Note 7: Related-Party and Party in Interest Transactions

Certain Plan investments are shares of separate accounts managed by Mutual of America Investment Corporation, a subsidiary of Mutual of America Life Insurance Company. Mutual of America Life Insurance Company is the issuer as defined by the Plan and, therefore, these transactions qualify as party in interest transactions as defined by ERISA. Any transactions involving these investments are executed on the open market at fair market value. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party in interest transactions under ERISA.

Note 8: Risk and Uncertainties

Investment securities are exposed to various risks, such as interest rate volatility, market risk, foreign exchange risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
