Opinion

NOTE 1 DESCRIPTION OF PLAN

The following description of the Orion Health Insurance Pool, Inc. (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 2016 to provide health and other benefits to eligible employees of the participating employers in the Plan and covered dependents. The Plan was most recently amended effective January 1, 2022. As of December 31, 2024 and 2023, there were two nonprofit members participating in the Plan. Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to ERISA, as amended.

In general, all employees classified by the members as a full-time employee and scheduled to work at least 30 hours per week on a regular basis or classified as a part-time employee working at least 20 hours are eligible to participate.

The Plan is governed by a Board of Directors while daily operations were conducted by Risk Program Administrators LLC (the Administrator) in exchange for an annual fee. Services provided by the Administrator include accounting, recordkeeping, and member relations.

Contributions

The members make contributions to the Plan as needed to fund claims and operating expenses. The participants also contribute to the Plan. Any deficiency of the Plan's net assets over benefit obligations would be subject to assessment by the members.

Benefits

The Plan provides benefits to full-time employees working 30 or more hours per week 75% of the time, and part-time employees working at least 20 hours per week if the employer allows part-time coverage. Eligible covered dependents of the employees are also covered under the Plan. All employees must complete the waiting period to be eligible.

The Plan provides health benefits (medical, vision, dental, and prescription drugs), life insurance, long-term disability benefits, and accidental death and dismemberment benefits to eligible members and to their beneficiaries and dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured Benefits

The Plan fully insures the life insurance benefits (basic, supplemental, and dependent), accidental death and disability benefits (basic, supplemental, and dependent), long-term disability benefits, and vision benefits. The members purchase annual insurance contracts for these insured benefits. Premiums for all insured benefits are paid from the assets of the VEBA trust.

Stop Loss Coverage

The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount).

Self-Insured Benefits

Medical, prescription, and dental benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors. The claims processors pay claims directly to or on behalf of participants and then are reimbursed by the Plan's VEBA trust. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Health Savings Accounts

Individuals enrolled in certain high-deductible health plans (HDHPs) can establish a health savings account (HSA) to receive tax-favored contributions (from either the employee or member). The contribution made to the HSA is used on a tax-free basis to pay or reimburse qualifying health expenses.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Cash and Cash Equivalents

Balances are insured by the Federal Deposit Insurance Corporation (FDIC) up to certain limits. At times, cash in bank may exceed FDIC insurable limits.

In August 2017, the Plan entered into a sweep arrangement with Wells Fargo Bank, N.A. Under this arrangement, available cash balances are invested overnight in high quality, short-term money market instruments that consist of U.S. government obligations and repurchase obligations that are secured by collateral of government securities. These funds are classified as interest bearing cash and are included in cash equivalents along with outstanding checks in excess of cash on the statements of net assets available for benefits and benefit obligations.

Cash and Cash Equivalents (Continued)

The Plan's interest-bearing cash is stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Investment income is recorded on the accrual basis.

Restricted Cash

Restricted cash held by the Plan consists of cash held in a custodial banking arrangement and is a security deposit for the payment of claims and funds held in the HSA account. Restricted cash was \$89,400 and \$69,000 at December 31, 2024 and 2023, respectively.

Health Savings Account

Member and employee contributions to the HSA are included in member and participant contributions, respectively, on the statements of changes in net assets available for benefits and benefit obligations. Bi-weekly amounts are transferred to the HSA vendor and recorded as "Transfers to Health Savings Accounts" as the participant owns the account and the Plan has no obligation to pay any benefits from these funds.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of fees paid to third-party claims and Plan administrators, the actuary, as well as any audit and legal fees. These expenses are reported on the statements of changes in net assets available for benefits and benefit obligations as Administrative Expense.

Payment of Benefits

Claim payments are recorded when paid by the Plan. These payments are recorded as claims paid in the accompanying statements of changes in net assets available for benefits and benefit obligations.

Stop Loss

Premiums for stop loss insurance are included in insurance premiums in the accompanying statements of changes in net assets available for benefits and benefit obligations. Stop loss reimbursements and adjustments totaling \$752,224 and \$627,717 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits and benefit obligations for the years ended December 31, 2024 and 2023, respectively.

Subsequent Events

The Plan has evaluated subsequent events through May 5, 2025, the date the financial statements were available to be issued. No significant events have been identified that would require modification or disclosure to the financial statements.

NOTE 3 FAIR VALUE MEASUREMENTS

The Plan categorizes its assets and liabilities measured at fair value into a three-level hierarchy based on the priority of the inputs to the valuation technique used to determine fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Interest-Bearing Cash – Investments in cash and cash equivalents are valued based on cost, which approximates fair value.

NOTE 4 BENEFIT OBLIGATIONS

The Plan "self-funds" medical, prescription, and dental benefits provided to participants but insures life, accidental death and dismemberment, long-term disability benefits, and vision. As of December 31, 2024 and 2023, there are certain self-funded claims that have been incurred on which benefit payments will be made subsequent to that date. The liability for claims payable was estimated based on actual claims adjudicated prior to December 31 but paid after December 31. The liability for claims incurred but not reported was estimated by the Plan's actuary in accordance with accepted actuarial principals based on claims data provided by the Plan's third-party administrators.

These amounts are paid by the Plan only if claims are submitted and approved for payment. The liability for loss adjustment expenses is a reserve for administration fees due to run-out of claims in the event of Plan termination and is included in benefit obligations in the accompanying statements of net assets available for benefits and benefit obligations.

NOTE 5 TAX STATUS

The VEBA trust, which funds certain benefits of the Plan, received an exemption letter from the Internal Revenue Service (IRS) dated June 23, 2016, stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the Internal Revenue Code (IRC). The Plan was organized as a nonprofit pursuant to state of Arizona Statute Section 41-621.01. The Plan is considered to be a nonprofit organization and is not subject to federal or state corporate income taxes; therefore, no provision for income taxes was recorded in these financial statements.

In addition, the Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

NOTE 5 TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024 and 2023, no such tax liability or asset was deemed necessary. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intention to do so, the members have the right under the Plan to modify the benefits provided to participants; modify the contributions required of participants; discontinue member contributions at any time; and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the members or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Compensation paid to the Administrator for the operation of the Plan was \$371,595 and \$353,900 for the years ended December 31, 2024 and 2023, respectively. No rent amounts were charged to the Plan by the Administrator relating to use of the office facilities during the years ended December 31, 2024 and 2023.

NOTE 8 RISKS AND UNCERTAINTIES

The liability for claims payable was estimated based on actual claims adjudicated prior to December 31 but paid after December 31. The liability for claims incurred but not reported was estimated by the Plan's actuary in accordance with accepted actuarial principals based on claims data provided by the Plan's third-party administrators. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
