### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Sani-Matic, Inc. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Sani-Matic, Inc. **NOTE 1 DESCRIPTION OF THE PLAN**

The following description of Sani-Matic, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering employees of Sani-Matic, Inc. (the Company), excluding union employees, nonresident aliens, and leased employees, who have completed two consecutive months of service and have reached the age of 19. The Plan is subject to the provision of the ERISA.

**Contributions**

Each year, participants may elect to make before tax or Roth contributions to the Plan up to the maximum allowed by the Internal Revenue Service (IRS), and provided these contributions will not cause the Plan to exceed the nondiscrimination limits, in which case, excess contributions will be refunded to the participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant. Participants who will attain age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover).

The Company contributes matching contributions which are determined at the discretion of the Board of Directors of the Company. Matching contributions to the Plan for the year ended December 31, 2024 was 40% of deferrals up to 5% of compensation. For the year ended December 31, 2023, the Company made matching contributions totaling approximately \$219,000. Profit sharing contributions may be contributed at the option of the Company's Board of Directors. There was no profit sharing contribution for the year ended December 31, 2024.

**Investment Options**

Upon enrollment in the Plan, participants may direct the investment of their account balances into a variety of investment options offered by the Plan. Participants may change their investment options daily.

**Participant Accounts**

Each participant's account is credited with participant contributions, participant rollover contributions, and the Company's contributions and an allocation of plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Through March 15, 2016, participants are immediately vested in their contributions, Company matching contributions and Company discretionary contributions, plus actual earnings thereon. Effective March 15, 2016, vesting on the Company's matching contribution and discretionary contribution portions of a participant's account, contributed after March 15, 2016, are based on years of service. A participant becomes 20% vested after two years of credited service and such vesting is increased ratably to 100% after six years of service, as defined. In the event of termination prior to achieving 100% vesting, the nonvested portion is forfeited.

**Payment of Benefits**

Benefits under the Plan are paid upon retirement, termination, death, or disability. A terminated participant with a vested account balance of \$7,000 or less will receive a lump-sum distribution. If the vested account balance is greater than \$7,000, the terminated participant may elect to defer distribution of their account. Upon termination of service, these participants may elect to receive benefits in a lump-sum distribution, installments, or partial withdrawals.

Participants may elect to withdraw all or any part of their vested account at any time upon attaining age 59 1/2. Hardship withdrawals are also permitted if a participant meets certain conditions defined in the Plan document.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$37 and \$46, respectively. These accounts may be used to pay plan expenses or reduce future Company matching contributions. There were approximately \$14,000 of forfeitures used in 2024 to reduce Company matching contributions and plan expenses, as stated in the Plan document.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Administrative Expenses**

As provided in the Plan document, administrative expenses may be paid either by the Plan or by the Company. The Company has historically paid the operating expenses for the Plan.

**Subsequent Events**

The Plan has evaluated subsequent events through June 3, 2025, the date the financial statements were available to be issued.

The Plan was amended, effective January 1, 2025, to increase the automatic enrollment deferral percentage to 6%. In addition, the Board of Directors approved an increase of their matching calculation for 2025 to 40% of deferrals up to 6% of compensation.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Reliance Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Shares of Registered Investment Companies**

Shares of registered investment companies are valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded.

**Collective Fund**

Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

**NOTE 5 PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**NOTE 6 RELATED-PARTY TRANSACTIONS**

Certain Plan investments are managed by Reliance Trust Company (Reliance). Reliance is the trustee as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 7 TAX STATUS**

The Plan is placing reliance on an opinion letter received from the IRS on the prototype plan indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is therefore not subject to tax under current income tax law. The prototype Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balance and the amounts reported in the statements of net assets available for benefits.
