Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Brosnan Risk Consultants 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of Plan

The following description of the Brosnan Risk Consultants 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan, established on January 1, 2021, is a defined contribution plan covering all eligible employees of Brosnan Risk Consultants (the "Employer"). Employees are eligible to participate in the Plan, as defined in the Plan document, if they are 18 years of age or older and complete 6 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants may contribute up to 100% of their eligible compensation on a pre-tax or Roth basis, subject to limitations of the Internal Revenue Code ("IRC"). Employees who are age 50 or over may make catch-up contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

In accordance with the Plan document, the Employer will make safe harbor contributions on behalf of eligible Plan participants equal 100% of the first 4% of compensation contributed to the Plan.

Vesting

A participant is 100% vested in his or her accounts including allocated earnings thereon at all times.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of: (a) Employer contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. All investments are participant directed.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump sum amount or installments over a certain period, under the plan equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In-service distributions are allowed for participants age 59 ½.

Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

1. Description of Plan (continued)

Notes Receivable from Participants

Participants may borrow from their account balance a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's account. Loans are generally payable within five years and bear a reasonable rate of interest as determined by the plan administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest is paid ratably through payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the fully benefit-responsive group annuity contract that is reported at contract value. The mutual funds are valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end and are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. These funds are deemed to be actively traded. The pooled separate accounts are reported at the value reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts. The group annuity contract is valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

2. Summary of Significant Accounting Policies (*continued*)

Investment Valuation and Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Fees related to record-keeping services are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the NAV of the respective investment vehicles and, consequently, those expenses are not separately reflected but are a component of net depreciation in value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and a distributable event occurs (retirement, termination, death), the participant loan balance is reduced and a benefit payment is recorded. Until a distributable event occurs, the loan will continue to have a balance and accrue interest.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is May 22, 2025.

3. Information Certified (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments held at December 31, 2022 and 2021, and net depreciation in value of investments and interest and dividends for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, qualified institutions.

The group annuity contract is valued at contract value. At December 31, 2022 and 2021, the contract value amounted to \$19,761 and \$4,568.

5. Principal Guaranteed Option

The Principal Guaranteed Option ("PGO") is a guaranteed general account-backed group annuity contract issued by Principal Life Insurance Company to Principal Trust Company. Principal and a rate of interest are guaranteed by the full faith and credit worthiness of Principal Life Insurance Company. The PGO meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

A composite crediting rate contractually guaranteed by Principal Life Insurance Company is credited to account balances. The rate is reset on a semiannually basis.

Benefit payments to participants for plan benefit events, including retirement, termination of employment, disability, plan termination, death, loans, and withdrawals, as allowed by the Plan, are made without any surrender charge or early termination charge. There are no restrictions on investment transfers initiated by a participant from the PGO to non-competing investment options.

The Plan administrator does not believe that any events, that would limit the Plan's ability to transact at contract value with Plan participants, are probable of occurring.

6. Income Tax Status

The Plan has adopted a pre-approved plan, which received an Internal Revenue Service ("IRS") opinion letter dated June 30, 2020, which states that the Plan was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Plan Termination

The Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

8. Party-In-Interest Transactions

Certain Plan investments are managed by Principal Life Insurance Company and Principal Trust Company, the trustees of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Employer, who may be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

9. Prohibited Transaction

During the 2022 and 2021 plan years, the Employer failed to remit to the Plan certain participants' contributions and loan repayments amounting to \$112,337 within the period described by the Department of Labor ("DOL") regulations. Delays in remitting the contributions and loan repayments to the Plan were due to administrative oversight. During 2022, the Employer made the necessary corrections to satisfy both the DOL and IRS guidance for \$23,977 of the delinquent contributions and loan repayments. In 2024, the Employer made the necessary corrections to satisfy both the DOL and IRS guidance for \$1,372 of the delinquent contributions and loan repayments. During 2025, the Employer made the necessary corrections to satisfy both the DOL and IRS guidance for \$86,988 of delinquent contributions and loan repayments.

10. Employer Contribution Receivable

During the 2022 Plan year, the Employer self-identified issues with regard to their processing of participants' and Employer contributions. In order to self-correct, the Employer calculated \$2,774 of unremitted participants' contributions and \$6,386 of Employer contributions, which were remitted to the Plan in April 2025. These amounts are included with lost earnings in the participant and Employer contributions receivables.

11. Due to Plan Sponsor

During the 2021 plan year, the Employer determined that certain participants received overpayments related to participants' and Employer contributions amounting to \$15,772 of participants' contributions and \$9,333 of Employer contributions. These amounts were refunded to the Plan Sponsor in December 2022. Subsequently, further analysis was performed, and it was determined that \$3,227 should not have been refunded to the Employer. These contributions were funded back to the Plan by the Employer in March 2024.

12. Due to Broker

The due to broker amount consists of purchases of securities executed during the 2021 plan year that were purchased in error and reversed in the 2022 plan year.

13. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2022 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
