## **Independent Auditors' Report**

### ***Opinion***

We have audited the financial statements of Expressions Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits - liquidation basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - liquidation basis for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits - liquidation basis of Expressions Profit Sharing Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits - liquidation basis for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Expressions Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### ***Emphasis of Matter - Terminating Plan and Liquidation Basis of Accounting***

As further discussed in Note 1 to the financial statements, the Plan Sponsor, Quarles II, Inc. d/b/a Expressions Footwear voted on February 25, 2022 to terminate the Plan and management determined liquidation is imminent. As a result, Expressions Profit Sharing Plan is presenting the financial statements on the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audits of the Financial Statements***

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. ### **Note 1: Description Of Plan**

The following description of Expressions Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General - The Plan was established in 2001 to provide retirement benefits for employees of Quarles II, Inc. d/b/a Expressions Footwear (the Company). The Plan provides for the participation of all employees over the age of 18 who have completed one year of eligibility service. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - The Company can make a discretionary contribution to be determined by the employer on behalf of eligible participants during the year. Participant directed investments are not permitted by the Plan. Contributions are subject to Internal Revenue Code limitations.

Participants' accounts - Each participant's account is credited or charged, as applicable, with all allocations of the Company's contributions, if any, transfers, plan earnings (losses), payments, forfeitures, withdrawals, expenses, or other distributions made to or from such accounts during the period. Allocations are based on participant earnings or account balances, in accordance with terms of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - A participant's vested interest in the employer contribution account of the Plan is based on years of continuing service as defined in the Plan document. A participant is 100% vested after six years of credited service or termination of the Plan. On February 25, 2022, upon termination of the Plan, all participants became fully vested in their account balances.

Payment of benefits - On termination of service or separation of service, due to death, disability, or retirement, a participant or their beneficiary will be entitled to receive a distribution of their total vested account balance. Benefits will be paid in accordance with the terms of the Plan.

Plan termination - On February 25, 2022, the Plan Sponsor, Quarles II, Inc. d/b/a Expressions Footwear terminated the Plan in connection with the sale of Quarles II, Inc. d/b/a Expressions Footwear to Jako Enterprises, LLC.

Forfeited accounts - Forfeitures may be used to reduce the Company's contributions.

### **Note 2: Summary Of Significant Accounting Policies**

Investment valuation and income recognition - Accounting principles generally accepted in the United States of America establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available. The three levels of the fair value hierarchy in accordance with accounting principles generally accepted in the United States of America are described below:

Level 1: Unadjusted quoted prices in active markets for identical, unrestricted assets, or liabilities that the Plan has the ability to access at the measurement date;

Level 2: Quoted prices which are not active, quoted prices for similar assets or liabilities in active markets, or inputs other than quoted prices that are observable (either directly or indirectly) for substantially the full term of the asset or liability; and

Level 3: Significant unobservable prices or inputs (including the Plan's own assumptions in determining the fair value of investments) where there is little or no market activity for the asset or liability at the measurement date.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Purchases and sales of securities are reflected on a trade-date basis. Gains and losses on sales of securities are based on the actual cost of the specific security. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Income taxes - The Plan is exempt from federal income tax under the Internal Revenue Code. Tax positions are evaluated and recognized in the financial statements when it is more-likely-than-not the position will be sustained upon examination by the tax authorities.

The prototype plan document adopted by the Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Basis of accounting - The financial statements have been prepared on the liquidation basis of accounting.

### **Note 2: Summary Of Significant Accounting Policies (Continued)**

Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. The application of these accounting principles involves the exercise of judgment and use of assumptions as to future uncertainties and, as a result, actual results could differ from these estimates. The Plan periodically evaluates estimates and assumptions used in the preparation of the financial statements and makes changes on a prospective basis when adjustments are necessary.

Presentation - Certain reclassifications, when applicable, are made to the prior year financial statement presentation to correspond to the current year's format. Reclassifications, when made, have no effect on total net assets available for benefits - liquidation basis or changes in net assets available for benefits - liquidation basis.

### **Note 3: Fair Value Measurements**

The following is a description of the valuation methodology used for assets at fair value at December 31, 2023:

*Money market funds:* Valued at a constant dollar per share.

The preceding method may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

All assets have been valued using a market approach. There were no changes in the valuation techniques during the year.

Fees for certain administrative expenses may be paid by the Plan Sponsor.

### **Note 5: Concentrations Of Credit Risk**

The Plan maintains accounts with a stock brokerage firm. Balances are insured up to the Securities Investor Protection Corporation limits and Federal Deposit Insurance Corporation limits.

### **Note 6: Commitments And Contingencies**

The Plan follows the guidance for uncertainty in income taxes. As of December 31, 2024, the Plan believes that it has appropriate support for the income tax positions taken and to be taken on its returns based on an assessment of many factors including experience and interpretations of tax laws applied to the facts of each matter. The Plan has concluded that there are no significant uncertain tax positions requiring disclosure, and there are no material amounts of unrecognized tax benefits.

The Plan was notified on December 5, 2022 by the Internal Revenue Service that it had been selected for examination for the tax year ended December 31, 2020 to address certain plan document and operational failures. In April 2023, the Internal Revenue Service expanded the examination to include years 2016 through 2021.

Plan document failure:

- 1.) The Plan Sponsor failed to amend the Plan by executing appropriate Plan restatement documents before the Economic Growth and Tax Relief Reconciliation Act of 2001 (EGTRRA) and The Pension Protection Act of 2006 (PPA) amendment deadlines.

### **Note 6: Commitments And Contingencies (Continued)**

Operational failures:

- 1.) Failure to provide a cash or deferred arrangement. The Plan restatements adopted in 2001, in 2021 and 2022, state that the Plan provides a cash or deferred arrangement. However, a cash or deferred arrangement has never been intended by the Plan Sponsor or offered to participants in the actual operation of the Plan. Also, as reflected in the annual reports filed by the Plan Sponsor, the annual listing of allocations to participants prepared by the third party administrator (TPA) and in the annual nondiscrimination tests prepared by the TPA, a cash or deferred arrangement was never considered by the Plan Sponsor to constitute a part of the Plan.
- 2.) Failure to determine profit sharing allocations in accordance with the Plan document. The original Plan document and all restatements describe the allocation of profit sharing contributions in various ways which are inconsistent with the manner in which the Plan has been administered.
- 3.) Failure to maintain consistent plan terms in succeeding versions of the Plan. Successive versions of the Plan document contain inconsistencies in terms.

On December 22, 2023, the Plan received notice from the Internal Revenue Service that the examination of the December 31, 2016 - December 31, 2021 Plan years had been completed and that certain plan deficiencies were noted and corrected by entering into a closing agreement. On September 24, 2021, the Plan Sponsor adopted amendments that satisfy the requirements of the non-amender items, retroactively to the effective dates of those specific provisions contained in the amendments. The Internal Revenue Service has agreed to treat the Plan as if it had complied with the required regulations for the Plan years ended December 31, 2001 through December 31, 2021.

Certain errors were identified related to the processing of employer contributions, allocation of investment earnings, and benefit payments during the years ended December 31, 2019 through December 31, 2024. Identified errors resulted in the reallocation of the employer contribution and related investment earnings. The Plan Sponsor remitted additional contributions of \$46,995 for the years ended December 31, 2019 through December 31, 2024 to the Plan to true-up participant account balances.

### **Note 7: Subsequent Events**

Subsequent events have been evaluated through June 25, 2025, which is the date the financial statements were available to be issued.
