### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Culinary Institute of America Defined Contribution Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

## NOTES TO FINANCIAL STATEMENTS

### 1. Plan Description:

The following description of The Culinary Institute of America Defined Contribution Plan (the "Plan") is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the plan's provisions.

#### General

The Plan, which was established by The Culinary Institute of America (the "Institute") in 1967, is a defined contribution plan to provide retirement income benefits to eligible employees who are employed by the Institute and have met the minimum length of service requirements. The Plan was amended and restated on January 1, 2009 to incorporate all provisions that are required by the Internal Revenue Service ("IRS"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Plan participants are eligible employees for whom the Institute made retirement contributions or who maintain a participant account within the Plan.

The Board of Trustees of The Culinary Institute of America passed a resolution authorizing the merger of the Culinary Institute of America Tax Deferred Annuity Plan into the Culinary Institute of America Defined Contribution Plan. This merger was effective January 1, 2012. The Defined Contribution Plan's plan document was restated effective January 1, 2012.

Effective July 12, 2022, the Plan was amended for the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), which laws change the Plan to, among others, allow certain eligible individuals to receive coronavirus-related relief for loan repayment, suspend required minimum distributions, and delay the commencement date for required minimum distributions.

#### Eligibility

Employees are eligible to participate in the Plan on the first day of employment. To receive employer contributions, employees must be eligible and complete one year of service (1,000 hours). There is no minimum age requirement to participate. Student workers are not eligible to participate in the Plan.

#### Contributions

Plan participants may make voluntary pre-tax or post-tax deferrals of their compensation, not to exceed the maximum annual contribution allowed by the Internal Revenue Code ("IRC"). Deferrals are always fully vested and cannot be forfeited. The Plan has automatic enrollment at 4% which increases by 1% per year up to a maximum of 10%, unless the participant elects otherwise. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Institute provides matching Plan contributions for participants based on the following criteria:

- 3% of annual base compensation of the Taxable Wage Base plus 6% of base compensation above the Taxable Wage Base unless they are part of an excluded class of employees as defined within the Summary Plan Document, and
- 100% of the employees' matched elective deferral of greater than 1% but less than or equal to 4% of annual base compensation unless they are part of an excluded class of employees as defined within the Summary Plan Document.

A vested participant may allocate his or her contribution and the Institute's matching contribution among the Institute's various investment options including TIAA annuities. The number of units purchased is based on the net asset value of the investment unit on the day the contributions are received.

#### Participant Accounts

Contributions made by the participants and the employer are reported to the Plan's recordkeeper and are allocated to the respective participant's account. Each participant's account is credited with the participant's contributions, the employer's contributions, and allocations of the Plan earnings net of administrative expenses. Allocations of participant earnings are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## 1. Plan Description (continued):

### Notes Receivable from Participants

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or fifty percent of their vested account balance. Loan terms range from one to five years, with the exception of loans for the purchase of a primary residence. The loans are secured by the balance in the participant's account and are offered with a fixed rate of interest. Principal and interest are paid ratably through payroll deductions.

### Collateralized Loans

Prior to April 1, 2019, plan loans were available to participants through TIAA, subject to certain limitations. Plan loans were issued directly from the funds owned by TIAA and loan proceeds were not removed from a participant's account balance. However, a portion of a participant's TIAA Traditional Annuity account balance remains reserved, or held in collateral, to cover the outstanding loan amount for the period of time the loan is outstanding. See Note 5 for discussion of the TIAA Traditional Annuity. For active loans, investments equal to 110% of the outstanding loan amount are reflected in the statements of net assets available for benefits and serve as collateral for the loan. Investments underlying defaulted loan balances are reflected in the statements of net assets available for benefits until a distribution event occurs.

At December 31, 2024 and 2023, participants had outstanding Plan loan balances due to TIAA of \$540,346 and \$709,392, respectively.

### Vesting

Participants are immediately vested in their contributions and the employer contributions plus actual earnings thereon.

### Payment of Benefits and Withdrawals

On termination of service due to death or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments. For termination of service due to other reasons, a participant may receive the value of the participant's vested interest in his or her account as a lump-sum distribution.

In addition, participants may elect in-service withdrawals of their elective deferral account balances after reaching age 59-1/2 or for hardship purposes. Rollover account balances and certain employee deferrals made prior to 1989 may be withdrawn at any time.

In the event a vested participant dies prior to commencement of retirement benefit payments, the current value of the annuity accumulation is then payable to the beneficiary or beneficiaries named by the participant in a single sum or under any one of the income options offered by the Plan custodian.

### Plan Termination

Although it has not expressed any intent to do so, the Institute has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants are already fully vested in the value of their account balances.

### Administration

The Institute is the Plan sponsor and is responsible for enrolling participants, sending Plan contributions for each participant to the custodian, and for performing other required duties. Administrative expenses are paid by the Institute. The Institute also pays administrative expenses out of the Plan's investment earnings, whenever there is sufficient earnings to cover these expenses. Custodian expenses for accounting, reporting, contract issuance and other services are paid by the Plan from investment earnings. TIAA is the recordkeeper of the Plan. TIAA and CREF is the custodian of the Plan.

## 2. Summary of Significant Accounting Policies:

### Basis of Accounting

The Plan uses the accrual method of accounting which recognizes income when it is earned and expenses as they are incurred.

### Pervasiveness of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results may differ from those estimates.

### 2. Summary of Significant Accounting Policies (continued):

#### Investment Valuation and Income Recognition

The fully benefit responsive annuity contract is stated at contract value. All other investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net realized and unrealized appreciation/(depreciation) includes the Plan's gains or losses on those investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

#### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

The Plan's investments are not insured or protected by the Plan's trustees and custodian. Accordingly, the Plan is subject to the normal investment risks associated with money market funds, mutual funds, stocks, bonds and other similar types of investments.

#### Income Taxes

The Plan has adopted an ERISA 403(b) volume submitter plan sponsored by TIAA. The Plan has received an opinion letter from the Internal Revenue Status as to the Plan's qualified status. The letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan and concluded that, as of December 31, 2024, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### Subsequent Events

The date to which events occurring after December 31, 2024, the date of the most recent statement of net assets available for benefits, have been evaluated for possible adjustment to the financial statements or disclosure is June 2, 2025, which is the date on which the financial statements were available to be issued.

### 3. Information Certified by Custodian:

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and the supplemental schedule, that was prepared by or derived from information provided by the custodian and furnished to the Plan Administrator. The Plan Administrator has obtained certification from TIAA and CREF, the custodian, that information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and the supplemental schedule.

The custodian also certified to the completeness and accuracy of \$19,213,032 and \$22,285,778 of net appreciation in fair value of investments and \$4,455,595 and \$2,970,575 of interest and dividends related to the aforementioned Plan Assets for the years ended December 31, 2024 and 2023, respectively.

### 4. Fair Value Measurements:

Accounting principles generally accepted in the United States of America establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- a. Quoted prices for similar assets or liabilities in active markets;
- b. Quoted prices for identical or similar assets or liabilities in inactive markets;
- c. Inputs other than quoted prices that are observable for the asset or liability;
- d. Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Non-Benefit Responsive Annuity Contract:* Valued at the amounts Plan sponsors would receive if they were to withdraw or transfer their funds within the Plan prior to their maturity (Level 3 inputs).

*Investments Measured at Net Asset Value:*

- The fair values of accumulation units held by the Plan in certain CREF accounts are based on each account's daily net asset value ("NAV"). These accounts are not exchange traded. Data for NAVs are available daily to Plan administrators and client investors on TIAA's website, and provides sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of individual underlying holdings. Underlying holdings are primarily valued using market quotations or prices obtained from independent pricing sources. There are no unfunded commitments from participants in the Plan who invest in these accounts.

### 4. Fair Value Measurements (continued):

- The fair value of the Plan's interest in the TIAA Real Estate Account (a pooled separate account) is based on the fund's daily NAV. The unit value of the fund is calculated daily and available to the Plan Administrator and client investors on TIAA's website. Underlying holdings are primarily valued using independent appraisals or independent pricing sources. There are no unfunded commitments from participants in the Plan who invest in this account.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of the future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- Funds in this category invest in a diversified portfolio of domestic and/or foreign stocks to achieve a long-term rate of return.
- Funds in this category invest in various types of debt securities to achieve a long-term rate of return while preserving capital. These funds invest heavily in U.S. Government Bonds.
- Funds in this category invest in domestic and foreign equities and in fixed income securities to achieve a long-term rate of return while giving special consideration to certain social criteria.

- (d) Funds in this category invest in high quality, short-term instruments to achieve high current income and capital preservation. The funds primarily invest in commercial paper, bank obligations, and U.S. Government issued securities that are classified as first-tier securities.
- (e) This fund invests in real estate properties, other real estate related investments, and securities. Underlying real estate holdings are valued principally using external appraisals. Underlying securities are generally priced using values obtained from independent pricing sources.

### Level 3

Management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to the total net assets available for benefits. During 2024 and 2023 net purchases amounted to (\$1,522,873) and (\$1,264,462), respectively, and net transfers in amounted to \$363,785 and \$168,365, respectively.

### 5. TIAA Traditional Annuity:

The TIAA Traditional Annuity is a guaranteed fixed annuity contract available as an investment option to Plan participants. Each contract is fully and unconditionally guaranteed by TIAA. The Traditional Annuity is offered through a variety of contract types, including Retirement Annuities ("RA"), Group Retirement Annuities ("GRA"), Supplemental Retirement Annuities ("SRA"), and Group Supplemental Retirement Annuities ("GSRA"). The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account, and the options for income upon retirement. The TIAA Traditional Annuity within SRA and GSRA contracts, as well as holdings reported in the Plan Loan Default Fund on the Statement of Net Assets, have no liquidity restrictions and are benefit responsive as contemplated by FASB ASC 962-325-35-5. The TIAA Traditional Annuity holdings within RA and GRA contracts have liquidity restrictions and are nonbenefit responsive.

Upon a distributable event, the participant surrenders the future accumulation benefits in exchange for a cash payout based on the contract value, demonstrating that contract value can be monetized when a distributable event occurs.

When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA's claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate.

The RA contract does not allow lump-sum cash withdrawals and transfers must be spread over 10 annual installments. With the GRA contracts, lump sum withdrawals are available within 120 days of termination of employment and are subject to a 2.50% surrender charge. All other withdrawals and transfers from RA and GRA contracts must be spread over 10 annual installments (five annual installments for withdrawals after termination of employment). The SRA and GSRA contracts provide for full participant-directed liquidity. When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits.

### **6. Related Party Transactions:**

Certain Plan investments are managed by TIAA and CREF. TIAA and CREF is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management and administrative services amounted to \$143,001 and \$107,450 for the years ended December 31, 2024 and 2023, respectively.
