## INDEPENDENT AUDITORS' REPORT

To the Trustees and Participants  
of The Global Orphan Project 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of The Global Orphan Project 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Supplemental Schedules Required by ERISA

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF THE PLAN

The following description of The Global Orphan Project 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions. The Plan was originally established January 1, 2020.

**General** – The Plan is a defined contribution plan that covers substantially all employees of The Global Orphan Project, Inc. and The GO Exchange, LLC (collectively, the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective December 3, 2024, assets were transferred to Reliance Trust Company and T. Rowe Price Retirement Plan Services, Inc. (“TRP”), serves as recordkeeper. Prior to December 3, 2024, Capital Bank and Trust Company serves as the custodian for the Plan. The Retirement Plan Services Division of The Capital Group Companies, Inc. serves as recordkeeper. MHM Retirement Plan Solutions serves as the third-party administrator (“TPA”). Triune Financial Partners, LLC, is the Plan’s investment advisor. Employees of the Company serve as trustees for the Plan.

Effective January 1, 2024, CarePortal, LLC, a wholly owned subsidiary of The Global Orphan Project, Inc., was added as a participating employer.

**Eligibility** – An employee is eligible to defer a portion of his or her salary to the Plan upon reaching the age of 18 and one full calendar month of service. Participants can enter the Plan on the first day of the month coinciding with or next following the satisfaction of the eligibility requirements.

**Contributions** – Participants may contribute up to 100% of their annual compensation, subject to certain Internal Revenue Code (“IRC”) limitations. Participants over age 50 are permitted to make catch-up contributions.

The Company may make discretionary profit-sharing contributions. A participant must be employed on the last day of the quarter in order to receive a profit-sharing contribution (if declared) with exceptions for death, disability or termination of employment on or after age 65. Profit-sharing contributions were declared in all 4 quarters of 2024 based on 3% of eligible compensation.

**Participant Accounts** – Each participant’s account is credited with the participant’s contribution, employer contributions, and allocations of Plan earnings, and is charged with the participant’s withdrawals and distributions, and share of Plan expenses, if any. The Plan is valued daily, and Plan earnings are allocated to the participants’ accounts based on the value of shares held by the participants in each of the respective funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investment Options** – The Plan offers various mutual funds and a money market fund as investment options for participants.

**Vesting** – Participants’ contributions are fully vested at all times. The Company contributions vest as follows - 33% vested after the first year, 67% vested after the second year and after 3 years of service, Company contributions become fully vested. In the event of permanent disability, death, reaching normal retirement age, or termination of the Plan, the Company contributions will become fully vested.

**Forfeitures** – Forfeitures occur upon termination of a participant whose account is not fully vested. Forfeiture amounts are used to pay any administrative expenses and to reduce employer contributions. During the Plan year ended December 31, 2024, \$625 in forfeitures was used to pay Plan expenses. There are \$16,296 and \$3,978 in forfeitures available at December 31, 2024 and 2023, respectively.

**Payment of Benefits** – Upon termination of service, a participant may elect to receive a distribution of all or any portion of their vested account balance in a single lump sum payment or a rollover into an IRA or other eligible retirement plan, as defined by the Plan document. For distributions greater than \$1,000 but not exceeding \$7,000, the account balance will be distributed to the participant or rolled over into an individual retirement account, unless otherwise directed by the participant.

**In-Service Withdrawals** – Certain participants may make withdrawals prior to termination of employment.

- Hardship withdrawals are available to Plan participants, as defined by the Plan and permitted by the IRC. Hardship withdrawals are limited to active employees and accounts that are 100% vested.
- Participants who have obtained the age of 59 ½ are allowed to receive a distribution of all or any portion of their fully vested contribution accounts, as defined by the Plan.
- Participants may withdraw accounts that are designated as rollover contributions at any time.

**Administrative Expenses** – Administrative expenses incurred by the Plan may be paid by the Plan or by the Company. During 2024, the Plan paid administrative expenses of \$25,860.

**Termination of the Plan** – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, participants' accounts would become fully vested, and all remaining Plan assets would be allocated to the participants as described in the full text of the Plan.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions** – Contributions are reported in the year services are rendered to the Company by the Plan participants.

**Investment Valuation and Income Recognition** – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments in the mutual funds and money market fund are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Payment of Benefits** – Benefit payments are reported in the year paid.

**Date of Management's Review** – Subsequent events have been evaluated through June 26, 2025, which is the date the financial statements were available to be issued, and there were no material events requiring recognition or disclosure.

### 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds and a Money Market Fund – Valued at the net asset value of shares held by the Plan at year end.

#### **4. RISKS AND UNCERTAINTIES**

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### **5. INFORMATION CERTIFIED BY THE CUSTODIANS**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company and Reliance Trust Company (effective December 2, 2024), the custodians of the Plan's assets, have certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Interest and dividend income
- Net appreciation in fair value of investments
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

#### **6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are shares of mutual funds and a money market fund managed by American Funds, an affiliated company of Capital Bank and Trust Company, through December 2, 2024. Both Capital Bank and Trust Company and American Funds are subsidiaries of The Capital Group Companies, Inc. Therefore, these transactions qualify as party-in-interest.

Effective December 2, 2024, plan investments are managed by T. Rowe Price. Therefore, these transactions qualify as party-in-interest.

Certain fees are paid to the TPA and investment advisor, and these are party-in-interest transactions.

#### **7. TAX STATUS**

The Company has adopted a Non-Standardized Pre-Approved Profit-Sharing Plan with CODA which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, stating that the prototype plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan has been amended since the date of the opinion letter. However, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. PROHIBITED TRANSACTIONS**

During the year ended December 31, 2024, employee deferrals of \$18,439 were withheld from two payrolls and not remitted on a timely basis (as defined by the Department of Labor “DOL”) by the Plan Sponsor. The Plan Sponsor remitted all such deferrals to the trust, will subsequently file and pay the appropriate excise tax, and will contribute lost earnings to the affected participants. These transactions were prohibited according to the provisions of the DOL.
