NOTE 1 – DESCRIPTION OF PLAN

The following description of the McHale Landscape Design, Inc. ("Company") Group Health Benefit Plan ("Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan provides health and other benefits covering eligible employees and covered dependents of the Company. The Plan was established June 1, 2021 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Benefits

The Plan provides health benefits (medical, prescription drug, dental and vision), short and long-term disability benefits, and life insurance benefits. The Plan covers full-time employees and their dependents following the completion of 60 days of employment. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act ("COBRA").

In 2022, the Plan had a stop loss insurance policy under which medical and prescription claims were covered in excess of \$60,000 per covered person and which provides a maximum aggregate benefit (in excess of deductible) of \$1,000,000. The minimum aggregate deductible for 2022 was \$716,829.

Plan Administration

The Plan provides health benefits through the Genesis Healthcare Consortium, LLC ("Consortium") developed in 2010 for private sector employers. The Company is a participating member of the Consortium and executed an agreement to administer the Plan through the Consortium.

The Company has engaged third parties to act as service providers. The Company also entered into an agreement with the Consortium whereby the manager of the Consortium will perform administrative services on behalf of the Plan, including development of the program with respect to eligibility and underwriting standards, placing stop loss insurance, coordination of regulatory compliance and document preparation.

The Company also entered into an agreement with an insurance provider to administer the health benefits under the Plan in accordance with its policies and procedures. The insurance company invoices the Plan for claims paid on a monthly basis.

The service providers charge an administrative fee related to the services performed which is paid from the Plan's trust account. These service providers noted above are considered parties-in-interest under ERISA.

In addition, the Plan's other administrative expenses are paid either directly by the Company or by the Plan.

NOTE 1 – DESCRIPTION OF PLAN (continued)

Insured Benefits

The Plan fully insures short and long-term disability benefits, life insurance benefits, and accidental death and dismemberment benefits through United of Omaha Life Insurance Company. Dental and vision benefits are fully insured through United Healthcare Insurance Company. Voluntary worksite benefits, accident benefits, critical care benefits and hospital benefits are fully insured through Colonial Life & Accident Insurance Company. The Company purchases annual insurance contracts for these insured benefits.

Contributions

The Plan is contributory. Employees pay a flat rate toward their coverage and that of their dependents, which varies depending upon which plan options are selected.

The Company funds the health benefits through the use of a trust established by the Genesis Healthcare Consortium, LLC (Consortium) for the Plan. Monthly contributions are made to the trust in an amount sufficient to cover expected claims and administrative expenses of the Plan.

Premiums for dental and vision benefits are paid through the trust. All other premiums are paid directly by the Company to the insurance companies.

COBRA

The Plan offers continuation of benefits (COBRA) for a specified period of time to qualified employees and their dependents who would not otherwise be eligible for continued coverage because of a particular qualifying event.

Each qualifying individual pays his/her premium directly to the service provider.

Plan Termination and Modification

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, the Company must pay the claims incurred and expenses of the Plan due up to the date of termination plus extended benefits, if any, provided under the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting, in accordance with generally accepted accounting principles in the United States of America ("GAAP").

Claims Payable

Claims payable represents the amount of benefit claims incurred and reported to the Plan by the end of the year. See Note 3 for benefit obligations.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Estimated Claims Incurred but not Reported

Estimated claims incurred but not reported are claims which have service dates prior to year ended but are reported to the Plan subsequent to year end. Those amounts are estimated based on actual claims experience. See Note 3 for benefit obligations.

Payment of Benefits

Premiums paid by the trust and the Company and claim payments are recorded when paid.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

NOTE 3 – BENEFIT OBLIGATIONS

Financial Accounting Standards Board Accounting Standards Codification 965, *Accounting and Reporting by Health and Welfare Benefit Plans*, requires disclosure of the following Plan obligations at May 31, 2022:

Plan obligations at May 31, for claims incurred by participants but not reported at that date, are measured at the estimated ultimate cost to the Plan of settling the claims. Estimated ultimate cost reflects the Plan's obligation to pay claims to or for participants, regardless of status of employment beyond May 31, pursuant to the provisions of the Plan.

The liability is computed by the Plan's actuary. The method used to derive the estimated unpaid claims liability applies the reserve factor to a monthly average of the past several months of medical and drug claims, which is then adjusted as needed based on actual subsequent period claims paid.

The Plan does not offer postemployment benefits and, thus, they are not included in the above calculations.

NOTE 5 – TAX STATUS

The Plan is intended to qualify as an employee welfare benefit plan as defined in ERISA, as amended. The Plan benefits are funded out of the general assets of the Company and employee contributions. The health benefits are paid in part from the trust established by the Genesis Healthcare Consortium, LLC and in part by pre-tax contributions made by the employees.

The trust established under the Plan to hold the Plan's assets is a taxable trust.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – RISKS AND UNCERTAINTIES

Plan assets include cash which is held at a bank insured by the Federal Deposit Insurance Corporation ("FDIC"). The Plan has credit risk associated with its cash deposits since the cash on deposit with the bank is more than the FDIC guaranteed limits at various times throughout the year. As of May 31, 2022, the total cash on deposit with the bank was \$150,540.

The actuarial value of benefit obligations is reported based on certain assumptions which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statements.

NOTE 7 – SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through January 31, 2025 the date the financial statements were available to be issued. Plan management is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
