## Independent Auditors' Report

We have performed audits of the financial statements of the Survitec Group NA 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ## NOTES TO FINANCIAL STATEMENTS

### **Note 1. Description of Plan**

The following description of the Survitec Group NA 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General:

The Plan began July 1, 2002 and is a defined contribution plan sponsored by RFD Beaufort, Inc. (the "Company"). The Plan covers employees who have completed at least six months of eligible service, excluding employees who are covered by a collective bargaining agreement and non-resident aliens. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Employees participated in the Plan until February 2023 at which time they began participating in a Pooled Employer Plan ("PEP") that the Plan merged into. In February 2023, all assets of the Plan were merged into the PEP except for the existing group annuity contract. On December 6, 2023, the group annuity contract balance was merged into the PEP.

#### Contributions:

Participants may make pre-tax or Roth 401(k) contributions in any amount up to 100% of their eligible compensation, subject to certain limits imposed by the Internal Revenue Service ("IRS"). The Plan also provides that participants who are projected to be age 50 or older by the end of the calendar year and who are making deferral contributions to the Plan may also make catch-up contributions, subject to certain IRS limitations. Participants may also contribute amounts representing distributions from other qualified retirement plans.

The Company made matching contributions at a rate of 100% of the first 3% of a participant's contributions for the period ended December 6, 2023. The Company may also make discretionary non-elective contributions to the Plan. Discretionary non-elective contributions at a rate of 2% of a participant's eligible compensation were made for the period ended December 6, 2023.

#### Participant Accounts:

Each participant's account is credited with the participant's contribution, any Company contributions, and an allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participants direct their investment fund options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Notes Receivable From Participants:

Participants may borrow from their fund accounts to the extent of one-half of their vested account balance under the Plan, not to exceed \$50,000. The loans are secured by the balance in the participant's account and bear interest at 1% over the prime rate. Principal and interest is paid ratably through monthly payroll deductions.

**Note 1. Description of Plan (Continued)**

Vesting:

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is vested after five years of credited service (20% in year one, 20% each year thereafter) or in the event of death, disability, or attaining normal retirement age as defined by the Plan.

Payment of Benefits:

A participant, upon retirement, termination, disability or a participant's beneficiary upon the participant's death, may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. The Plan also provides for in-service distributions upon attaining age 59½, and hardship withdrawals, subject to certain limitations. Participants may also invest in funds offered by the Plan which provide for a Guaranteed Annual Withdrawal ("GAW") for a participant's lifetime (or the lifetime of the participant and his or her spouse upon election) upon severance of employment. Participants may elect to receive the GAW on an annual, semi-annual, quarterly, or monthly basis. This benefit is offered through the Plan's group annuity contract with Empower Annuity Insurance Company of America ("Empower"), the Custodian of the Plan. The benefits offered under the GAW option accumulate during the employment of a participant and are based on market conditions of the underlying investments in the covered funds, but are guaranteed to be at least the amount of the participant's benefit base, as defined by the Plan.

Forfeited Accounts:

Forfeited non-vested accounts resulting from employer matching contributions may only be used to reduce future employer matching contributions, and forfeited non-vested accounts resulting from employer discretionary non-elective contributions may only be used to reduce future employer discretionary non-elective contributions. Any forfeited non-vested accounts may be used to pay administrative fees. At December 6, 2023 and December 31, 2022, there were \$-0- and \$29,704, respectively, of forfeited non-vested accounts. During 2023, no forfeitures were used and \$42,485 of forfeitures were transferred to the PEP.

**Note 2. Summary of Significant Accounting Policies**

- A. Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Note 2. Summary of Significant Accounting Policies (Continued)**

- B. Investment Valuation and Income Recognition – Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, the Custodian and Empower Trust Company, LLC, the Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Interest and dividends are recorded when received. There is no material difference between the cash and accrual basis relative to the Plan's investment holdings at December 6, 2023 and December 31, 2022. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- C. Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the Plan document.
- D. Administrative Fees – Fees of the Plan are paid by the Company or the Plan at the discretion of the Company. In addition, certain transactions and account maintenance fees are charged to the affected participants. Commission credit payments are made from excess revenue generated by the Plan through fund revenue or fees that are made available to the Plan. At December 6, 2023 and December 31, 2022, there were \$-0- of unused commission credits. During 2023, commission credit deposits of \$6,644 were received and utilized for expenses. The Company monitors the payments received by the Plan service providers to ensure that they are used properly for qualifying Plan administrative and operating expenses.
- E. Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- F. Benefit Payments – Benefits are recorded when paid.
- G. Subsequent Events – The Plan has evaluated subsequent events through May 22, 2025, the date the financial statements were available to be issued.

**Note 3. Unaudited Information**

Empower Trust Company, LLC, Trustee of the Plan, and Empower Annuity Insurance Company of America, Custodian of the Plan, hold the Plan's investment assets and execute transactions therein. The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee and Custodian have certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the statements of net assets available for benefits at December 6, 2023 and December 31, 2022, the related investment and loan interest activity reflected in the statement of changes in net assets available for benefits for the period from January 1, 2023 to December 6, 2023, and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

**Note 4. Fair Value Measurements**

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

Level 1 – Quoted market prices in active markets for identical assets and liabilities

Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data

Level 3 – Unobservable inputs in which little or no market data exists

The following is a description of the valuation methodology used for plan assets measured at fair value:

- The fair value of investments held in the mutual funds is determined based on their quoted closing market prices in active markets for identical investments, and is classified as Level 1.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. There have been no changes in the methodology used from 2022 to 2023. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 5. Group Annuity Contract**

The Plan held an investment contract which met the fully benefit-responsive investment contract criteria and, therefore, was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Investments in the Guaranteed Portfolio Fund are reported at contract value as determined by Empower, which represents contributions plus interest at a specified rate, less participant withdrawals and fees. Empower maintains the investments in a general account. All permitted transactions within this contract are executed at contract value including full liquidation of the Guaranteed Portfolio Fund. Empower is contractually obligated to repay the principal and a specified rate that is guaranteed to the Plan. Empower has indicated that the guaranteed interest rates are reset quarterly.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on several factors, including the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, and prevailing market conditions.

The Guaranteed Portfolio Fund does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. Certain events may limit the ability of the Plan to transact at contract value with the issuer. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants occurred in connection with the merger into the PEP.

#### **Note 6. Income Tax Status**

The Plan has adopted a prototype plan document. This prototype document has obtained an opinion letter dated November 14, 2022 from the IRS in which the IRS stated that the document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

The Plan's management has analyzed the tax positions taken by the Plan and has concluded that, as of December 6, 2023, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

#### **Note 7. Party-in-Interest Transactions**

Certain Plan investments were held in a group annuity contract or mutual funds of Empower or its affiliates. Empower is Custodian as defined by the Plan. These transactions qualify as party-in-interest transactions.

Administrative expenses were paid to the Trustee and Custodian during the period ended December 6, 2023. These transactions qualify as party-in-interest transactions.
