### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements**

We have performed an audit of the financial statements of **Bronco Utah Operation, LLC 401(k) Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## 1. DESCRIPTION OF THE PLAN

The following description of the Bronco Utah Operation, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan covering employees who have completed one month of service and are eighteen years of age or older. Eligible employees are enrolled in the plan the month after a participant first becomes eligible. The Plan was effective on September 1, 2018. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### Contributions

Each year, plan participants may contribute any amount up to 90% of pretax annual compensation, as defined in the Plan. Employees may also elect to make ROTH 401(k) contributions as specified by IRS guidelines. In addition, participants over age 50 may contribute an additional amount as specified by IRS guidelines. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. Annually, the plan sponsor may elect to satisfy safe harbor rules. For the years ended December 31, 2023 and 2022 the plan sponsor elected the traditional enhanced matching safe harbor contribution formula whereby the plan sponsor matches 100% of employees contributions up to 6% of compensation. Additional discretionary non-elective contributions may be contributed at the option of the plan sponsor. There have been no discretionary non-elective contributions made since the Plan's inception date of September 1, 2018 through December 31, 2023.

### Vesting

Participants are vested immediately in their contributions, rollovers from other plans, and safe harbor contributions. Participants are vested in the discretionary non-elective employer contribution portions of their accounts as follows:

1	66%
2	100%

Participants also become 100% vested if the employee is still employed after reaching normal retirement age (65), or if employment is terminated as a result of death or disability.

## **1. DESCRIPTION OF THE PLAN (Continued)**

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, an allocation of the plan sponsor's contributions, as applicable, and the Plan's earnings and losses, which include administrative expenses. Allocations are based on participants' earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Plan Termination**

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

### **Benefit Payments**

On termination of service, disability, retirement, or death, a participant will receive a lump-sum amount equal to the vested value of his or her account on the distribution date. This amount can be paid directly to an account of the participant's choice or rolled over to an eligible retirement plan. Under certain circumstances, including financial hardship, participants may withdraw their contributions prior to occurrence of the events. The plan administrator determines financial hardship.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP) using the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### **Investment Valuation and Revenue Recognition**

The Plan's mutual funds are held at fair value. The Putnam Stable Value fund is held at contract value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividend income is accrued on the ex-dividend date. Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

In general, these securities are exposed to various risks and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the accompanying statements of net assets available for benefits. The plan also holds fully benefit responsive guaranteed investment contracts. The statement of net assets available for benefits presents the contract value basis for fully benefit responsive guaranteed investment contracts because that is the amount participants would receive in a transaction.

### **Operating Expenses**

The Plan and Plan Sponsor pay a portion of the costs of administering the plan.

### **Contributions Receivable and Allowance for Doubtful Accounts**

Employee contributions which are withheld through payroll deductions and have not been credited to the participant accounts as of the end of the fiscal year are recorded as contributions receivable. An allowance for doubtful accounts is not considered necessary.

## **3. TAX STATUS**

The Plan is designed to constitute a qualified plan under Section 401(a) and Section 401(k) of the Code and is, therefore, considered to be exempt from federal income taxes. The Plan received its latest opinion letter on October 6, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended and restated since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Accordingly, no provision for income taxes has been made in the accompanying financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the Plan's form 5500 remains open to examination for three years from the date filed.

## 4. INVESTMENTS

### Unaudited Information Certified by the Plan Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the trustee, has certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate with respect to investments:

- Investments at fair value
- Interest and dividend income
- Net appreciation/(depreciation) in fair value of investments
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

### Fair Value Measurements

FASB Accounting Standards Codification (ASC 820) Fair Value Measurements and Disclosures establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value of a financial instrument is the amount that would be received to see an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). Accordingly, when market observable data is not readily available, the Plan's own assumptions are set to reflect those that market participants would be presumed to use in pricing the asset or liability at the measurement date. Financial assets and financial liabilities recorded in the statement of net assets at fair value are categorized based on the reliability of inputs to the valuation techniques as follows:

**Level 1** – Financial assets and financial liabilities whose values are based on unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access. Examples include prices derived from NYSE, NASDAQ, Chicago Board of Trade, and Pink Sheets.

**Level 2** – Financial assets and financial liabilities whose values are based on (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in non-active markets, or (c) valuation models whose inputs are observable, directly or indirectly, for substantially the full term of the asset or liability. Examples include matrix pricing, market corroborated pricing, and inputs such as yield curves and indices.

**Level 3** – Financial assets and financial liabilities whose values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. These inputs reflect the Plan's estimates of the assumptions that market participants would use in valuing the financial asset and financial liabilities. Examples include investment manager pricing for price placements, private equities, hedge funds, etc.

## 4. INVESTMENTS (Continued)

The Plan uses prices and inputs that are current as of the measurement date, including during periods of market disruption. In period of market disruption, the ability to observe prices and inputs may be reduced for many instruments. This condition could cause an instrument to be reclassified from Level 1 to Level 2 or from Level 2 to Level 3.

### Common Collective Fund

The Putnam Stable Value Fund seeks to maintain the stability of a money market fund while offering returns similar to those of intermediate-term bonds. The strategy can pursue income with interest-rate tracking over time by reinvesting without realizing gains and losses. The fund is fully benefit-responsive. There are no events that limit the ability of the plan to transact at contract value with the issuer.

Events and circumstances that would allow issuers to terminate fully benefit-responsive investment contracts with the plan and settle at an amount different from contract value include transfers from stable value to a competing fund without imposition of a 90-day equity wash feature, transfers/redemptions incited by certain fund-specific plan sponsor communications, or default by the issuer of the contract, among others. Certain corporate actions like a layoff or spin-off of a division may be subject to limitations on the allowable amount covered at book value. Additionally, defaults of underlying securities held by the strategies are not covered by the book value feature. These events are not specific to Putnam, but are common to the stable value industry.

## 5. EXEMPT PARTY IN INTEREST TRANSACTIONS

ADP, Reliance Trust Company and Global Retirement Services provide administrative services to the plan and fees are paid to them and are all parties-in-interest. A portion of administrative expenses, including audit fees, were paid by the plan sponsor for the year ended December 31, 2023. The Plan Sponsor is a party-in-interest.
