## NOTES TO FINANCIAL STATEMENTS

### **Note 1. Description of Plan**

The following description of the A.J. Johns, Inc. 401(k) Profit Sharing Plan and Trust ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General:**

The Plan was established on November 1, 1979 as a defined contribution and profit sharing plan covering all employees of A.J. Johns, Inc, and Concrete Profiles, Inc. (the "Employers"), provided they are not an excluded employee, who have six months of service and are age eighteen or older. The Plan is subject to the provisions of the Employer Retirement Income Security Act of 1974 (ERISA).

#### **Plan Administration:**

John Hancock Life Insurance Company (the "Custodian") serves as custodian of the Plan's assets and performs certain recordkeeping functions of the Plan. The Board of Trustees is responsible for oversight of the Plan. The Board of Trustees determines the appropriateness of the Plan's investment offerings, and monitors investment performance. Effective December 30, 2024, Empower Trust Company began the process of assuming custodial responsibilities for the Plan's assets and will also perform certain recordkeeping functions.

#### **Contributions:**

Participants may elect to make salary deferral contributions to the Plan in an amount up to 100% of their annual pay with a total amount not to exceed \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Employers may make a discretionary matching contribution to be determined for each Participant in a discretionary amount that will not exceed 6% of total compensation. Additionally, the Employers may make a discretionary profit sharing contribution to the Plan, which is allocated among participants who are eligible to share for the plan year. During the year ended December 31, 2024 the Employers made no profit-sharing contribution to the Plan.

#### **Participant Accounts:**

Each participant's account is credited with the participant's contributions and Employers matching contributions, as well as allocations of the Employer's profit-sharing contribution and Plan earnings. Participants' accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## NOTES TO FINANCIAL STATEMENTS

### **Note 1. Description of Plan (Continued)**

#### **Vesting:**

Participants are immediately vested in their employee contributions plus actual earnings thereon. Vesting in the employer's matching and discretionary contribution portion of the participants' accounts plus actual earnings thereon is based on years of continuous service. A participant is fully vested after six years of credited service. The vesting percentages are as follows:

2 years	20%
3 years	40%

6 years	100%

#### **Payment of Benefits:**

Upon termination of service for any other reason, a participant (or beneficiary) may receive a lump sum distribution if their vested account balance does not exceed \$5,000. For vested account balances in excess of \$5,000, participants may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or payments of cash installments over a period not to exceed the participant's assumed life expectancy (or the assumed life expectancies of the participant and their beneficiary).

The plan also permits participants to take distributions prior to termination of employment upon attaining age 59½ or normal retirement age. These in-service distributions may only be drawn from accounts in which the participants are 100% vested.

Additionally, participants who have incurred a "hardship", as defined in the Plan, may take hardship withdrawals, which will be sourced only from their elective deferrals.

#### **Forfeited Accounts:**

Forfeitures may first be used to pay administrative expenses of the Plan. Thereafter, any remaining forfeitures attributable to amounts other than employer matching contributions shall be allocated to participants based on their relative compensation. Remaining forfeitures shall be used to reduce employer matching contributions. As of December 31, 2024 and 2023, the forfeited, non-vested accounts totaled \$2,133 and \$13,656, respectively. For the year ended December 31, 2024, \$18,000 was used to pay for administrative expenses of the Plan.

## NOTES TO FINANCIAL STATEMENTS

### **Note 2. Summary of Significant Accounting Policies**

#### **Basis of Accounting:**

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principals generally accepted in the United States of America.

#### **Use of Estimates:**

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### **Investment Valuation and Income Recognition:**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year, net of investment management fees.

#### **Subsequent Events:**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through June 24, 2025, the date the financial statements were available to be issued.

#### **Payment of Benefits:**

Benefits are recorded when paid.

### **Note 3. Fair Value Measurements**

The Plan applies generally accepted accounting principles for fair value measurements of financial assets and liabilities. These accounting principles define fair value and establish a hierarchy that prioritizes fair value measurements based on the types of inputs used for the various valuation techniques. The three levels of inputs used to measure fair value are as follows:

Level 1 - Values measured using quoted prices in active markets for identical investments.

Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly.

Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

## NOTES TO FINANCIAL STATEMENTS

### Note 3. Fair Value Measurements (Continued)

Following is a description of the valuation methodology used for assets measured at fair value:

Mutual funds: Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities & Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Exchange-traded funds: Valued based on the closing price reported by the fund. ETFs held by the Plan are closed-end funds registered with the Securities & Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The ETFs held by the Plan are deemed to be actively traded.

Collective investment trusts (CITs): valued, as a practical expedient, at the net asset value (NAV) of units held by the Plan at year end. The net asset value of these accounts is based on the market value of the underlying investments. The net asset value is not a publicly quoted price in an active market.

## NOTES TO FINANCIAL STATEMENTS

### **Note 4. Fully Benefit-Responsive Investment Contracts**

The Plan has assets invested in a fully benefit-responsive separate account guaranteed interest contract with John Hancock Life Insurance Company ("Custodian"). The Custodian maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$16,209 and \$2,307,780 respectively. The crediting interest rate is based on a formula agreed upon with the Company. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Empower. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the sponsor to terminate the contract with the Plan and settle at an amount difference from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the sponsor's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the sponsor are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

## NOTES TO FINANCIAL STATEMENTS

### **Note 5. Information Prepared and Certified by the Custodian**

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate in accordance with Section 2520.103-8 of the Departments of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 by John Hancock Life Insurance Company and Empower Trust Company for 2024, and John Hancock Life Insurance Company for 2023.

### **Note 6. Party-in-Interest Transactions**

Certain Plan investments are managed by John Hancock and Empower. These investments and transactions in these investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA. John Hancock and Empower were paid \$55,448 in service expenses for the Plan year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions.

### **Note 7. Plan Termination**

Although it has not expressed any intent to do so, the sponsors have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **Note 8. Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and tax counsel believe that the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

## NOTES TO FINANCIAL STATEMENTS

### **Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.
