Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cathedral Home for Children Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedules Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) at December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

(1) DESCRIPTION OF THE PLAN

The following description of the Cathedral Home for Children (the Organization) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering all eligible employees of the Organization. Employees of the Organization become eligible to participate in elective deferral contributions immediately upon hire. Employees of the Organization become eligible to participate in employer matching contributions after completion of one year of service and attaining 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Retirement Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Retirement Committee reports to the Plan's Board of Directors.

(b) Contributions

Each year, participants may contribute up to 100 percent of pre-tax eligible compensation, as defined by the Plan. Participants who have obtained age 50 before the end of the Plan year are eligible to make certain catch-up contributions.

The Organization matches 100 percent of the first seven percent of eligible compensation that a participant contributes to the Plan. On an annual basis, the Organization can also elect to make discretionary contributions. For Plan year 2024, no discretionary contributions were made. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participants may also rollover amounts representing distributions from other qualified plans.

(c) Participants' Accounts

Each participant's account is credited with the participant's contributions and the Organization's matching contributions, as well as allocations of the Organization's discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(1) DESCRIPTION OF THE PLAN (CONTINUED)

(d) Investment of Contributions

The Plan is a participant-directed plan. Upon enrollment in the Plan, a participant may direct contributions in one percent increments in any of the investment options as made available and determined by the Plan administrator. Participants may change their investment options at any time. The Plan currently offers registered investment companies and a guaranteed investment contract as investment options.

(e) Vesting and Benefits

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their account balance is based on years of service. A participant is 100 percent vested after three years of credited service or upon death or disability prior to termination of service.

(f) Distribution of Benefits

On termination of service due to death, disability, or retirement, a participant is entitled to 100 percent of their account balance. A participant who terminates for any other reason is entitled only to the vested portion of their account. The remainder of the account is forfeited and used to pay administrative expenses of the Plan or to reduce subsequent employer contributions. Upon termination of service, if a participant's account balance is \$5,000 or less, the Plan administrator will distribute the vested account balance. For terminated participants that have not made a payout election and whose account balance is \$1,000 or less, the account balance will be involuntarily distributed in a cash payment. For account balances greater than \$5,000, regardless of the type, a participant will receive their benefit payment in annuity payments or as a single lump-sum payment equal to the value of the participant's vested interest in the account.

(g) Forfeitures

Forfeitures may be used to pay administrative expenses or to reduce employer contributions. Forfeitures were used to reduce employer contributions by \$7,256 during the Plan year ended December 31, 2024. Forfeitures were used to reduce employer contributions by \$12,192 during the Plan year ended December 31, 2023. There were no remaining funds in the forfeiture account at December 31, 2024 and 2023.

(h) Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

(a) Basis of Presentation

The Plan's financial statements are presented on the accrual basis of accounting.

(b) Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value (except for fully benefit-responsive investment contracts). Contract value is the relevant measurement for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and the Plan trustee. See Note 3 for discussion of fair value measurements.

(c) Risks and Uncertainties

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

(d) Payment of Benefits

Benefit payments to participants are recorded upon distribution.

(e) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Subsequent Events

Events occurring subsequent to the Statement of Net Assets Available for Benefits date have been evaluated for financial statement impact or disclosure May 29, 2025, the date the financial statements were available to be issued.

(3) FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuations techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. In periods of market inactivity, the observability of prices and inputs may be reduced for certain instruments. This condition could cause an instrument to be reclassified from Level 1 to Level 2 or from Level 2 to Level 3.

Registered Investment Companies

Investments in registered investment companies (mutual funds) traded on national securities exchanges are valued at quoted closing prices on the last business day of the year and are classified within Level 1 of the fair value hierarchy. Such investments, at fair value, totaled \$4,686,435 and \$4,196,607 as of December 31, 2024 and 2023, respectively.

The Plan has a guaranteed investment contract with Principal Life totaling \$130,515 and \$140,091, as of December 31, 2024 and 2023, respectively. The contract (the Principal Fixed Income Option Non-401(a)) is classified as a traditional investment contract. The contract meets the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by the participant if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. However, transfers to competing plan investment options, as defined within the investment contract, are subject to an equity wash that requires transfers to be directed to a noncompeting investment option under the Plan for 90 days before such transferred amounts may be directed to any other competing plan investment option. In general, withdrawals or transfers will be made in full within three business days after the request. Up to an additional 30 days may be required to process withdrawals or transfers, and during such delays, the account will continue to earn interest.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer, but may not be less than 1 percent. The crediting rate is reviewed on a semi-annual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

(3) FAIR VALUE OF INVESTMENTS (CONTINUED)

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the contract issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 403(b) of the Internal Revenue Code or the failure of the plan sponsor to be tax-exempt under Section 501(c)(3) of the Internal Revenue Code.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

Specific to the traditional investment contract held by the Plan, an employer-level liquidation or employer initiated transfer of the Plan's interest in the traditional investment contract will be subject to either a 12-month irrevocable advance notice or a five percent surrender charge, whichever the employer chooses. Participant initiated transfers from the traditional investment contract may also be subject to the five percent surrender charge when the transfers are requested in anticipation of the employer-level liquidation of the Plan's interest in the contract. The surrender charges will be billed to the employer.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

(4) TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code. The terms of the Plan have been prepared to conform with the sample language provided by the IRS in Revenue Procedure 2007-71 or the draft Listing of Required Modifications issued April 4, 2009. The Plan is required to operate in the conformity with the Internal Revenue Code to maintain the tax-exempt status for Plan participants under Section 403(b).

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability, if the Plan has taken an uncertain position, that more likely than not would not be sustained upon examination by a government authority. The Plan administration has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

(5) INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator has obtained certifications from the Plan's custodian as of and for the years ended December 31, 2024 and 2023 that all information provided by the custodian is complete and accurate. Information included in the accompanying financial statements as to investments in the trust fund administered by the custodian, investment income (loss), and all investment information in the supplemental schedule is presented in reliance solely upon those certifications.

(6) RELATED PARTY TRANSACTIONS

The Organization provides to the Plan certain accounting and administrative services for which no fees are charged.

Certain Plan investments in the guaranteed investment contract managed by Principal Life qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments.
