Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

1. Description of Plan

The following description of The New Teacher Project 403(b) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of TNTP, Inc. (the "Employer") except those employees who normally work less than 20 hours per week and have less than 1,000 hours of service in the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Eligible employees are automatically enrolled in the Plan. Under the terms of the automatic enrollment provision, the Employer withholds 3% of each eligible employee's compensation each payroll period, unless the participant makes an affirmative election not to defer or to defer more or less than the automatic deferral percentage. Participants may elect to have a percentage or specified dollar amount deducted from their compensation as defined by the Plan. The money that is elected to be deducted can either be made on a pre-tax or after-tax (Roth) basis. A participant may elect to increase, decrease or suspend deductions according to procedures established by the Employer. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the statutorily permitted amount. Contributions are subject to certain annual Internal Revenue Code ("IRC") dollar limits.

Participants may also rollover or transfer amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer may make a discretionary matching contribution in an amount determined by the Employer. For the year ended December 31, 2024, the Employer made a discretionary matching contribution, for participants who made contributions, in the amount of 50% of the participant's contributions not to exceed 7% of the participant's eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

1. Description of Plan *(continued)*

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer contribution portion of their account is as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
1-2	50%
2-3	75%
3 or more	100%

Forfeitures

If a participant terminates employment and is less than 100% vested, the participant forfeits the non-vested portion of their account balance. Forfeitures are retained in the Plan and are used to reduce future Employer contributions or Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$14,417 and \$15,453. In 2024, Employer contributions were reduced by \$53,325 from forfeited non-vested accounts. In 2024, \$22 of Plan expenses were paid from forfeited non-vested accounts.

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000. Participant loans are secured by the balance in the participant's account and bear interest at prime rate plus one percent. Loans must be repaid within five years, unless the loan is used to purchase a participant's principal residence or the participant is on authorized leave for military service for a period which extends the maturity date of the loan beyond five years. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, retirement, age 59 1/2 or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account.

A participant may apply for a hardship withdrawal at any time. This withdrawal must be for an immediate and heavy financial need as determined based on Internal Revenue Service Regulations.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (*continued*)

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments, that were valued at fair value, were valued using level 1 inputs.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the group annuity contract, which is stated at contract value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The group annuity contract is valued at contract value, which represents contributions plus credited interest less participant withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from the financial statements. Investment related expenses are included in net appreciation in value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is June 24, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividend income, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Life & Annuity Insurance Company of America and Empower Trust Company, LLC (collectively “Empower”), qualified institutions.

4. Group Annuity Contract

Participants have the option to invest in a benefit-responsive investment contract with Empower Life & Annuity Insurance Company of New York. The Guaranteed Interest Account (the “GIA”) is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets of the portion of the Empower Life & Annuity Insurance Company of New York general account that is used to determine the GIA’s crediting rate compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset at least annually and no more frequently than quarterly for some contracts. Participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract.

Certain events limit the ability of the Plan to transact at contract value. Such events include: (1) removal of a group of participants from plan coverage as a result of temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the Employer or (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan sponsor’s business. Such events may also include (1) removal from the Plan of one or more groups or classifications of participants; (2) partial or complete Plan termination; or (3) Plan disqualification. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best Company, Inc. (A+ as of March 2025), Moody’s Investors Service (Aa3 as of March 2025), Standard and Poor’s (AA as of March 2025), and Fitch Ratings (AA as of March 2025).

5. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their Employer contributions.

6. Tax Status

On April 7, 2021, the Internal Revenue Service (“IRS”) issued an opinion letter to the prototype document preparer indicating that the Plan, as then designed, qualifies under Section 403(b) of the IRC. The Plan has been amended since receiving the opinion letter, however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Party-in-Interest Transactions

Certain Plan investments are managed by Empower. Empower is the trustee and custodian of the Plan, and therefore, these transactions qualify as exempt party-in-interest under ERISA.

For the year ended December 31, 2024, fees paid to Empower for investment advisory/management fees and contract administrator fees amounted to \$134,639.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Employer, who may also be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

The Plan has an agreement with Empower whereby Empower will pay the total of the Plan’s consultant’s (Gallagher Benefit Services) and investment advisor’s (Kestra Advisory Services, LLC) fees on behalf of the Plan. Each calendar quarter, Empower will calculate the eligible credits by multiplying the value of the Plan’s assets as of the last business day of the calendar quarter by 1/4th of the annual reimbursement percentage which is 0.05%. The payments come from Empower and are not a Plan asset. The Plan also allows Empower to pay Gallagher Benefit Services (“Gallagher”) and Kestra Advisory Services LLC (“Kestra”) a flat combined rate per year.

The Plan and Empower have entered into a revenue sharing arrangement whereby a portion of the revenue earned by certain funds is passed through to the Plan for payment of permitted Plan expenses. In order for the Plan to receive credits as a result of this arrangement and to use this credit to pay Plan expenses, the Employer created the Plan Expense Account (“PEA”) under the Plan. The PEA is a cash account within the Plan, similar in design to forfeiture accounts, and is used to record-keep the re-distribution of plan-generated fund revenue. The PEA balance was \$4,483 and \$4,212 at December 31, 2024 and 2023. In 2024, \$20,000 was used to pay administrative expenses.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
