Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of BBP Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Responsibilities of Management for the Financial Statements

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Notes to Financial Statements

1. Plan Description

The following description of the BBP Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established effective May 23, 2015 (inception of the Plan). The Plan is a defined contribution plan covering all employees, other than carpenters and millwrights, of Brunswick Bowling Products, LLC (the Company). Employees are eligible upon date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The trustee of the Plan is Principal Trust Company (the Trustee). Principal Life Insurance Company (Principal Life) is the contract holder and recordkeeper of the Plan. The administrator of the Plan is the Company. The Trustee and contract holder hold all assets of the Plan in accordance with the service provider contract with the Company. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Participants may elect to contribute a portion of their pretax annual compensation to the Plan through a salary reduction program, limited to those amounts allowable as a deduction under the Internal Revenue Code (IRC). Eligible employees automatically defer 6% of their compensation with a 1% increase each year up to 12% unless they elect a contrary salary reduction or elect not to participate. Participants may also elect to make Roth deferral contributions.

The percentage of elective deferral contributions matched, if any, shall be a percentage as determined by the Company. In 2024 and 2023, the Company made a matching contribution in an amount equal to 100% of elective deferral contributions up to 3% of compensation, and 50% of the next 2% of elective deferral contributions up to 5% of compensation. Participants may also contribute amounts representing rollovers from other qualified defined benefit or defined contribution plans.

Discretionary variable retirement contributions may be made for each Plan year in an amount equal to a stated percentage as determined by the Company. The Company may determine different amounts of such contributions to be allocated separately on behalf of persons in different employee groups based on employee groups determined by the Company for the Plan year. Such contributions shall be made to participants for services rendered in such designated groups during the Plan year. Discretionary variable retirement contributions were \$1,232,413 and \$1,194,100 for 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, net investment earnings or losses, and administrative expenses. Allocations are based on participant earnings or account balances, or specific participant transactions as defined by the Plan. Investment earnings are allocated daily based on unit values and units owned in accounts. The benefit to which participants are entitled is the vested portion of their accounts.

Investment Options

Participants are allowed to allocate contributions to various investment options offered through Principal Trust Company. Participants may change their investment options at any time.

Vesting

Participants are immediately vested in their voluntary contributions and all employer contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their investment accounts any amount greater than \$1,000 but less than 50% of the participant's vested account balance. Participants may only borrow from the balance of their account resulting from elective deferrals and rollover contributions. In no event can a participant borrow more than \$50,000. The notes are secured by the balance in the participant's account and bear interest based on reasonable borrowing rates, which range from 3.25% to 8.50% on notes outstanding at December 31, 2024. The notes are repaid ratably through payroll deductions over a period of five years or less. Participants may not have more than one loan outstanding within a 12-month period.

Payment of Benefits

Upon retirement (age 65), termination of employment, death, or disability, participants or their beneficiaries may elect to receive the value of vested interest in his or her account in the form of a lump-sum distribution, or in an alternative manner, as mutually agreed upon with the Plan administrator. Withdrawals may also be made upon attainment of age 59½ or circumstances of financial hardship, as defined in the Plan.

Administrative Expenses

Certain administrative expenses are paid by the Company. Administrative expenses not paid directly by the Company may be paid from the Plan in accordance with Plan provisions.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared under the accrual method of accounting.

Subsequent Events

Subsequent events have been evaluated by management through June 27, 2025, the date these financial statements were available to be issued.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the guaranteed investment contract discussed below. Fair value is the price that would be received to sell an asset (an exit price) in the principal or most advantageous market for the asset in an orderly transaction between market participants on the measurement date (see Note 3).

The Plan's investment in a guaranteed investment contract is valued at contract value (see Note 5).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Discretionary variable retirement contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Notes Receivable from Participants

Participant loans are classified as notes receivable from participants and are measured at the unpaid principal balance plus unpaid accrued interest. Defaulted loans, if any, are reclassified as distributions based upon the terms of the Plan agreement and recorded as benefits paid to participants in the statements of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

3. Investments

In accordance with Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, the Plan utilizes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, and other inputs that are observable or can be corroborated by observable market data.

Level 3 - Inputs to the valuation methodology are both significant to the fair value measurement and unobservable.

The following valuation methodologies were used to measure the fair value of the Plan's investments:

Collective Investments Trusts (CITs) - The units held in CITs are valued using the net asset value (NAV), as reported by the Trustee, as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the CITs will sell for an amount different than the reported NAV. The CITs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. There are no unfunded commitments related to the CITs.

Pooled Separate Accounts (PSAs) - The units held in PSAs are valued based on the underlying investments (i.e., common stock, mutual funds, and short-term securities). While the majority of the underlying asset values is based on quoted prices, the NAV of the PSAs is not publicly quoted. The NAV is reported by the fund managers as of the financial statement date based on recent transaction prices and is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the PSAs will sell for an amount different than the reported NAV. The PSAs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. There are no unfunded commitments related to the PSAs.

Mutual Funds - The funds are valued at the daily closing price as reported by the fund. These funds are required to publish their NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The Plan's valuation methods may result in a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although Plan management believes the valuation methods are appropriate and consistent with the market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Information Certified by the Plan's Trustee

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee, Principal Trust Company, a qualified institution.

5. Guaranteed Investment Contract

The Plan invests in the Principal Fixed-Income Guaranteed Option (PFIGO), a guaranteed investment contract. The PFIGO is a benefit-responsive contract entered into with Principal Life. Principal Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The PFIGO is valued at contract value for presentation in the Plan's net assets available for benefits. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts, because contract value is that amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The contract has a 5% surrender fee should the Plan discontinue without proper notification as prescribed in the contract. Currently, Plan management believes that the occurrence of an event that would cause the Plan to transact at less-than-contract value is not probable.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is a blended rate determined using a dollar-weighted average of all the guaranteed interest rates of the guaranteed interest funds under this contract. Under the terms of the existing contract, the guaranteed minimum crediting interest rate is 1.55% and can be reset on a semi-annual basis. The PFIGO is a single group annuity contract with a fixed rate of interest.

6. Related Party Transactions

Investments in certain PSAs, CITs, and a guaranteed investment contract are managed by Principal Trust Company and Principal Life (collectively, Principal), the Trustee and contract holder, as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid to Principal for administrative services were \$51,349 and \$53,789 for 2024 and 2023, respectively. The Plan also issues loans to participants that are secured by the vested balance of the participants' accounts. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will automatically become fully entitled to the total balance in their accounts.

8. Tax Status

The Internal Revenue Service (IRS) informed Principal Life by an opinion letter, dated June 20, 2020, that the pre-approved basic savings plan is acceptable under Section 401 of the IRC. The Plan has been amended and restated since receiving its latest opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the Plan continues to be tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions. However, there currently are no audits for any tax periods in progress.
