### Plan Year

Effective December 31, 2008, the plan year equals the calendar year.

### Coverage and Participation

A salaried employee of the Company or related corporation (if so adopted), serving in Puerto Rico, whose customary employment is for at least 1,000 hours per year becomes a participant upon date of hire. Part-time salaried employees become participants after completing 1,000 hours of service in a 12-month period. (Six months of employment were required for contributory participation; however, employee contributions ceased effective January 1, 1994.)

Effective April 30, 2009, the Kelly-Springfield Puerto Rico location was closed. All active employees became retirees or vested terminations.

### Continuous Service

Eligibility: One year for each Plan year during which the employee completes at least 1,000 hours of service.

Benefit: Same as Eligibility Service, except that partial service, to the nearest one-twelfth of a year, is credited for the Plan years of Normal, Early or Disability retirement.

## Normal Retirement Benefit

Eligibility: Age 65

Benefit: The sum of the Past Service Pension and the Future Service Pension, as outlined below.

- Past Service Pension: The monthly benefit as of January 1, 1994 is the sum of the non-contributory and contributory benefits:
  - Non-contributory: \$15.00 per month per year of benefit service.
  - Contributory: a monthly benefit equal to 5% of employee contributions
- Future Service Pension: The monthly benefit is equal to one-twelfth of the aggregate benefit accrued as follows for service after January 1, 1994:
  - Integration Level: one-half of the Social Security Wage Base for the calendar year of the accrual.
  - Benefit Percentages: 0.75% for earnings below the Integration Level and 1.00% for earnings above the Integration Level.
  - Minimum Annual Accrual: \$180.00
- Maximum Benefit: The maximum monthly benefit is limited to 6.25% of Earnings during the 12 months prior to retirement less 72% of the monthly Social Security benefit.

## Early Retirement Benefit

Eligibility: Age 55 with 10 years of eligibility service; or age 55 with attained age plus years of eligibility service equaling at least 70.

Benefit: The accrued normal retirement benefit, reduced by 4/10 of 1% for each month benefit commencement is prior to the month following the month the employee attains age 62, except that the month the employee would have completed 37 years of service, if earlier, is used for the non-contributory benefit.

## Vested Benefits Upon Termination of Service

Eligibility: Any age with 5 years of eligibility service (only service after age 18 is considered).

Benefit: The accrued normal retirement benefit, commencing at age 65 or as early as age 55 but actuarially reduced.

Pre-retirement Benefit: Upon death after 5 years of eligibility service, a benefit payable to the surviving spouse equal to the amount which would have been paid to the spouse if the employee had survived to and retired on his earliest retirement date and elected the Post-Retirement Option (actuarially equivalent 50% J&S). The pension to the spouse commences on such earliest retirement date. Pension is reduced by 0.2% (0.6% after age 55) for each year coverage is in effect after age 35.

## Disability Benefit

Eligibility: Permanent incapacity with 10 years of eligibility service.

Benefit: The accrued normal retirement benefit, with the maximum limitation based on 64% of the actual Social Security disability benefit.

## Death Benefits

Upon the death of an employee with 5 years of Continuous Service, the surviving spouse will receive, commencing upon the later of the participant's date of death or earliest retirement date, 50% of the benefit the participant would have received had he then retired with the special 50% Joint and Survivor option in effect.

## Employee Contributions

Required Contributions: Prior to January 1, 1994 all Participants must contribute each month 3-1/2% (4% after age 55) of the excess of the Participant's Earnings over the Contributory Base Amount (1/12 of the Social Security Wage Base for the prior calendar year) plus 1-3/4% (2% after age 55) of the excess of the participant's Earnings (up to the Contributory Base Amount) over \$1,650; the minimum monthly contribution is \$5.00.

No employee contributions are made after January 1, 1994. Past contributions continue to accrue interest as described below.

Withdrawal of Contributions: Any Participant may at any time withdraw his employee contributions, together with appropriate accumulated interest (6% for all periods after 1-1-74).

Return of Contributions in Event of Death: Upon death of a Participant not entitled to any contributory benefit, accumulated contributions with interest are returned. Also, upon cessation of a contributory pension, the excess, if any, of contributions with interest over contributory benefits paid, is returned.

## Forms of Payment

If an employee does not elect an option or file a written revocation, retirement benefits other than deferred vested benefits will be paid on an actuarially equivalent 50% joint and survivor basis if married, or on a 5-year certain basis if unmarried. Available options are: Option A - joint and survivor (spouse only) with 5-year certain for the amount paid to the last survivor; Option B - period certain (10,

15 or 20 years certain); and the Qualified Optional Survivor Annuity – 75% Joint and Survivor (spouse only).

If a deferred vested participant does not elect an option or file a written revocation, benefits will be paid on a 50% joint and survivor basis if married, or if not married, on a straight life basis. The available option is the Qualified Optional Survivor Annuity – 75% Joint and Survivor (spouse only).

## **Benefits Not Valued**

The Pre-Retirement Survivor Benefit is not valued for Vested Terminated Participants. To cover the cost of such benefit the pension for Vested Terminated Participants is reduced .
