Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users made on the basis of these financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024 AND 2023

**NOTE 1 DESCRIPTION OF PLAN**

The **Nomax, Inc. 401(k) Profit Sharing Plan** (the Plan) was adopted effective January 1, 1996. The amended and restated provisions of the Plan became effective on October 1, 2022. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all non-excluded employees of **Nomax, Inc.** and participating affiliate **Amcon Laboratories, Inc.** (collectively referred to as the "Company"). Employees are eligible to participate in the Plan upon attaining age 18 and completing three months of service. Participants will then enter the Plan on the first day of the Plan year quarter following satisfaction of the eligibility requirements. On October 1, 2022, the Plan was amended to allow participants to complete one month of service and the entry date being the first day of the month following satisfaction of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees are responsible for oversight of the Plan.

**Administration**

The Plan Trustees are responsible for oversight of the Plan.

**Contributions**

Eligible participants may contribute an elected percentage of pre-tax or post-tax annual compensation, as defined in the Plan, and subject to certain Internal Revenue Code limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment allocation at any time. The Company contributes 100% of participant's salary deferral that do not exceed 3% of participant's compensation plus 50% of participant's salary deferrals between 3% and 5% of participant's compensation as safe harbor matching contributions. The Company may, at its discretion, elect annually to make additional matching contributions up to 4% of participant's compensation and nonelective contributions. For the year ended December 31, 2024, no additional discretionary matching contributions were made and additional discretionary nonelective contributions totaled \$396,187. Total contributions per participant are subject to certain limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, including safe harbor matching and any discretionary additional matching or nonelective, and (b) Plan earnings or losses. Allocations of Company matching contributions are based on a percentage of participant's compensation and excess compensation, as defined, and allocations of Company nonelective contributions are determined by the Company. Allocations of Plan earnings or losses are based on participant account balances, or specific transactions, as defined. Participant accounts may be charged with an allocation of administrative expenses which are incurred by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions and Company's safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary additional matching and nonelective contributions portion of their accounts plus actual earnings thereon is based on years of continuous service.

Notes to Financial Statements (Continued)

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

***Vesting (Continued)***

A participant is fully vested after three years of credited service. Notwithstanding the above, a participant is fully vested upon reaching early or normal retirement age, upon death, or becoming permanently disabled.

***Forfeited Accounts***

Participants who terminate their employment and are less than 100% vested in discretionary Company contributions forfeit their non-vested portion. Forfeitures are retained by the Plan to pay Plan expenses, to be allocated as an additional discretionary matching or nonelective Company contributions, or to reduce any additional discretionary matching or nonelective Company contributions. The Plan had cumulative forfeitures of \$14,902 and \$6,413 at December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, forfeitures added from distribution of non-vested accounts was \$14,468. Forfeitures included earnings of \$434 for the year ended December 31, 2024. During 2024, \$6,413 of forfeitures were used to reduce nonelective Company contributions.

***Loans to Participants***

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Participant loans are secured by the respective participant's vested account balance and are subject to interest charges. Loans bear an interest rate of prime plus 1% and must be repaid within 5 years. Principal and interest is paid ratably through payroll deductions.

***Payment of Benefits***

Upon termination of service, death, disability, or retirement, a participant may elect to receive the value of the participant's vested interest in their account in the form of a lump sum distribution or as a direct rollover to an individual retirement account. The Plan allows for in-service distributions when the participant reaches age 59 ½. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$200 and \$5,000, the Plan administrator may authorize the benefit payment be rolled into an individual retirement account in the participant's name.

***Participant Hardship Withdrawals***

According to the Plan, each participant who has not attained age 59 ½ may make a hardship withdrawal if he or she demonstrates that the withdrawal is necessitated by the participant's immediate and heavy financial need and the participant lacks the available resources.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the financial statements and accompanying notes. Actual results could differ from those estimates.

### **NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

#### ***Investments Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of participant loans or benefits distributed to participants are charged directly to the participant's account and are included in administrative expenses.

#### ***Subsequent Events***

Management has evaluated subsequent events through June 3, 2025, which is the date the financial statements were available to be issued.

### **NOTE 3 INVESTMENTS**

During 2024, the Plan's investments appreciated by \$1,633,911.

#### **NOTE 4 FAIR VALUE MEASUREMENTS**

Financial accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 inputs) and the lowest priority to unobservable inputs (level 3 inputs). The three levels of the fair value hierarchy under the standards are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are significant unobservable inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

- Mutual Funds – valued at the daily closing price reported in the active market in which the individual mutual funds are traded.

The inputs or methodologies used for valuing investments may not be an indication of the risk associated with investing in those securities. Furthermore, the Plan believes its valuation methods are appropriate and consistent. The use of different methodologies or assumptions could result in a different fair value measurement at the reporting date.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all amounts credited to the participants' accounts will become fully vested. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

**NOTE 7 TAX STATUS**

The Company adopted a prototype plan which received a favorable opinion letter dated June 30, 2020, from the Internal Revenue Service, which stated that the Plan, as then designed, was in accordance with the applicable sections of the Internal Revenue Code (the IRC) and is, therefore, not subject to tax under present income tax law. The Plan has been amended since receiving the opinion letter. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

Financial accounting standards for uncertain tax positions prohibit financial statement recognition of the impact of a tax position if the position is not "more likely than not" to be sustained on audit, based on the technical merits of the position. The Plan's Annual Return/Report of Employee Benefit Plan remains subject to examination by taxing authorities, generally for three years after they have been filed. As of May 22, 2025, no returns have been selected for examination.

**NOTE 8 INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN**

As permitted by Section 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator has elected to have AdvisorTrust, Inc., the custodian of the Plan, certify as to the accuracy and completeness of the information at December 31, 2024 and 2023 and for the years then ended, included in the accompanying statements and instructed the Plan's independent accountants not to perform any auditing procedures with respect to such information.

- A. Investments held by subservice organization on behalf of AdvisorTrust, Inc. at fair value as of December 31, 2024 and 2023 included in the accompanying statements of net assets available for benefits.
- B. Investment income included in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- C. Investments held by subservice organization on behalf of AdvisorTrust, Inc. as of December 31, 2024 included in the accompanying schedule of assets held for investment purposes.

#### **NOTE 9 PARTY-IN-INTEREST TRANSACTIONS**

Various companies, along with AdvisorTrust, Inc. as the custodian, provide professional services to the Plan such as administrative, recordkeeping, investment advisory, and other professional services at reasonable and customary rates, are parties-in-interest transactions. The Company, who has fiduciary responsibilities to the Plan, directly pays certain administrative expenses of the Plan. There were no prohibited transactions with any parties-in-interest.

#### **NOTE 10 DEFERRED DISTRIBUTIONS**

Net assets available for benefits as of December 31, 2024 and 2023 includes \$1,621,494 and \$1,569,862, respectively, allocated to the accounts of persons who as of that date were retired or had otherwise separated from the Company. The balances are payable to the former participants as provided under the terms of the Plan. These balances have not been recorded as a liability as of December 31, 2024 because benefits are only recorded when paid.
