Opinion

We have audited the accompanying financial statements of Ground Engineering Consultants, Inc. **NOTES TO FINANCIAL STATEMENTS
December 31, 2024 and 2023**

NOTE 1 - DESCRIPTION OF PLAN

The following description of Ground Engineering Consultants, Inc. Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan is an employee stock ownership plan (ESOP) established on January 1, 1999. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by Ground Engineering Consultants, Inc. (the Employer). The Employee Stock Ownership Plan Committee is responsible for oversight of the Plan. At December 31, 2024 and 2023, the Plan owned approximately 68% of the outstanding company common stock.

Eligibility: Employees of the Employer who have at least one year of service are eligible to participate.

Employer Contributions: The Employer may elect to make discretionary contributions to the Plan. In 2024, the Employer made a discretionary contribution totaling \$335,004 to the Plan. A participant is eligible for an allocation of the Employer's contribution for the year if the participant is employed on the last day of the Plan year and has completed at least 1,000 hours of service during the Plan year.

Participant Accounts: The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with Employer discretionary contributions, as well as allocations of Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Voting Rights: The Trustee of the Plan will vote all company common stock held by the Plan. Participants are entitled to direct the plan trustee as to the manner in which voting rights are to be exercised on company common stock allocated to the participants' accounts in the following two cases: (1) the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, and/or sale of substantially all assets of a trade or business and (2) if, at the time of the vote, the Company is a registration type class of security.

Vesting and Forfeitures: Vesting in the Employer's contribution portion of each participant's account is based on years of service. A participant becomes 20% vested after two years of service, increasing by 20% per additional year, with full vesting after six years of credited service. However, a participant will become 100% vested upon attainment of Normal Retirement Age (the later of age 60 or completion of five years of service) while in employment, upon termination due to total disability, upon death while employed or upon termination of the Plan. Although participants become vested in their account balances, the timing of the payment of their benefits is subject to certain restriction as specified below under *Benefits*.

Plan forfeitures are allocated to each eligible participant's account in proportion to each participant's eligible compensation as a percentage of total eligible compensation for the Plan year. Forfeitures allocated to participants during the year ended December 31, 2024, totaled \$56,422.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Benefits: Distributions from the Plan will commence as soon as practicable in the first Plan year following the Plan year in which a participant attains Normal Retirement Age or as the result of the participant's death, disability, or termination of employment.

Account balances which exceed \$7,000 of participants who terminate for reasons other than death or disability will generally be made in a lump-sum in cash or in five annual installments. However, if a participant's vested account balance exceeds a certain dollar threshold, as defined in the Plan Agreement, the number of installments may be increased.

Accounts with vested balances of \$1,000 or less will be distributed in a lump-sum cash payment in the year following termination of employment. Accounts with vested balances greater than \$1,000 but not greater than \$7,000 will be automatically rolled into an IRA.

Put Option: Under federal income tax regulations, the Employer's common stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Employer buy any shares of its common stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Employer can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification: Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in the Employer's common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to their account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. The election to diversify is made subsequent to year-end based upon the shares of the Employer's common stock in the participant's account at year-end. Participants who elect to diversify may receive a cash distribution of the applicable amount.

Plan Termination: The Employer reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, all participants become 100% vested, and the plan administrator is to distribute each participant's interest to the participant or their beneficiaries.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The shares of the Employer's common stock and the Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payment of Benefits: Benefits are recorded by the Plan when paid.

Expenses: Administrative expenses for maintaining the Plan may be paid by the Employer or the Plan, at the Employer's discretion. The Employer has historically paid most of the operating expenses for the Plan.

Tax Status: The Internal Revenue Service (IRS) has determined and informed the Employer by a letter dated September 23, 2015, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since the Plan Agreement applicable to the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other taxing authorities.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

Subsequent Events: The Plan Administrator has evaluated the financial statements for subsequent events occurring through June 18, 2025, the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The Plan has categorized its assets and liabilities that are measured at fair value into a three-level fair value hierarchy. The hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement. In situations where there is little or no market activity for the asset or liability, the Plan makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used by the Plan for assets that are measured at fair value on a recurring basis. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common Stock of Ground Engineering Consultants, Inc.: Valued at aggregate fair value as determined annually by the Plan Trustee based on a report from an independent valuation specialist at the reporting date. The independent valuation specialist utilized an income approach, considering the discounted future earnings of the Employer, with a certain adjustment related to lack of marketability to determine the fair value.

Money Market Fund Shares: Valued at the daily closing price as reported by the funds. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These funds held by the Plan are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain assets could result in a different fair value measurement at the reporting date.

NOTE 5 – PLAN AMENDMENT

Effective January 1, 2024, the Employer amended and restated the Plan Agreement in its entirety. There were no significant changes to the Plan's provisions.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan's assets are primarily invested in the Employer's common stock. Transactions in this investment qualify as exempt party-in-interest transactions.

The Employer provides certain accounting and administrative services to the Plan for which it receives no compensation.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, primarily consisting of an investment in the Employer's common stock, which are exposed to various risks, such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with the investment securities and to uncertainties inherent in the estimates and assumptions process, it is at least reasonably possible that changes in the value of the investment securities, primarily the Employer's common stock, will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Plan's financial statements.
