Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of DISA Global Solutions 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Note 1 – Plan Description

The following description of the DISA Global Solutions 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of DISA Global Solutions, Inc. (the “Company” or “Employer”) and related participating employers. The Plan, which commenced effective January 1, 2016, and was amended and restated effective April 30, 2021, to comply with the latest rules and regulations, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

Plan Custodian and Trustee

Fidelity Management Trust Company (“Fidelity,” the “Custodian,” or “Trustee”) is the Custodian maintaining custody of all investments held by the Plan, maintaining the Plan’s participant account balances, and providing recordkeeping services to the Plan. Among other duties, the Custodian receives contributions, holds and invests the fund assets in accordance with the directions of participants, and makes distributions as directed by the Plan Administrator. Fidelity also serves as the Plan’s Trustee.

Plan Mergers

Effective November 7, 2022, the Company acquired Global Radar Holdings, LLC, and on December 9, 2022, the Company acquired Crimcheck Holdings, LLC. Effective January 1, 2024, the Global Radar Holdings, LLC 401(k) Plan (the “Global Radar Plan”) and the Crimcheck 401(k) Plan (the “Crimcheck Plan”) (collectively, the “Merged Plans”) were merged into the Plan. Fidelity became the new Custodian and recordkeeper. To aid with the transition to Fidelity, the Merged Plans instituted a blackout period for all activity with the new Custodian between December 22, 2023 and February 2, 2024. The formal transfer of all assets was completed on January 31, 2024, and net assets totaling \$10,022,522 were transferred from the Merged Plans to the Plan. This amount is included as transfers of assets to this Plan on the statement of changes in net assets available for benefits.

Eligibility and Plan Entrance Date

All employees, except those under collective bargaining agreements, nonresident aliens who receive no United States source income, and leased employees, are eligible to participate in the Plan after the employee has reached 18 years of age and completed one month of service. Eligible employees are permitted to enter the Plan on the first day of each month after satisfying the eligibility requirements.

Participant Contributions

Participants may elect to contribute, on a before-tax or Roth basis, up to 90% of their eligible compensation as defined by the Plan, subject to the annual deferral limit established by the IRC, which was \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to the maximum amount allowed annually by the IRC, which was \$7,500 for 2024.

Participant Contributions (continued)

The Plan includes a Qualified Automatic Contribution Arrangement (“QACA”) provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. The Plan also includes an automatic escalation feature where each year on June 1st, participants with a deferral rate greater than 0% will have their deferral rate increased by 1% annually until a deferral rate of 6% is reached, unless they elect otherwise.

Rollover Contributions

Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

Employer Contributions

The Plan provides for a QACA Safe Harbor Employer matching contribution equal to 100% of the first 1% of the participant's eligible compensation contributed to the Plan and 50% of the next 5% of the participant's eligible compensation contributions.

The Plan provides for the Employer to make discretionary matching, qualified matching, and nonelective discretionary contributions. The Employer made no such contributions for the year ended December 31, 2024.

Participant Accounts

Each participant account is credited with the participant’s contributions, Safe Harbor Employer matching contributions, Employer discretionary matching contributions, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants become vested in QACA Safe Harbor Employer matching contributions based on the following schedule:

Vesting (continued)

Participants are 100% vested immediately in their pre-tax deferred and after-tax contributions, rollovers, and any income or loss thereon. Participants hired prior to August 1, 2014, are 100% vested in prior Employer discretionary matching contributions. In addition, participants with assets in the frozen Safe Harbor Employer matching contributions will continue to be 100% vested.

Effective April 1, 2019, participants with frozen Safe Harbor Employer contributions that merged into the Plan from the WorkSmart Systems, Inc. 401(k) Profit-Sharing Plan are immediately vested in these contributions and any earnings thereon. Also, participants that merged into the Plan from the AWSI Plan are 100% vested in Employer discretionary matching contributions.

Effective, January 1, 2024, all eligible employees that merged into the Plan from the Crimcheck Plan are vested in discretionary match contributions based on the following schedule:

Participant-Directed Investments

All assets of the Plan are participant-directed investments. Participants have the option of directing their account balances to one or more investment options offered by the Plan. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. The investment options vary in types of investments, rates of return, and investment risk.

Notes Receivable from Participants

Effective March 13, 2023, the Plan was amended to allow initiation of new notes receivable from participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above Prime, as defined. Principal and interest is paid ratably by the participant and are due in equal installments not less frequently than quarterly.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or termination of employment, a participant or beneficiaries may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account. Terminated participants whose vested account balance is less than \$1,000 receive automatic distributions as a single lump sum payment. Terminated participants whose vested account balance is greater than \$1,000 but less than \$5,000 will receive a direct rollover to an individual retirement account ("IRA") chosen by the Plan Administrator. A participant may withdraw all or a portion of their vested account balance in the event of a financial hardship, as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age 59 ½ from all vested balances. Rollover contributions may be withdrawn at any time.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$72,841 and \$73,965, respectively. These accounts will be used to reduce future Employer contributions and pay Plan expenses. During the year ended December 31, 2024, forfeitures of \$145,000 were used to reduce Employer contributions.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Agreement.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Certain expenses incurred by or attributable to a specific participant are paid from that participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs that are unobservable inputs for the assets or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within level 1 of the fair value hierarchy.
- **Money Market Fund** – This investment is valued at cost, which approximates fair value and is classified within level 1 of the valuation hierarchy.

Note 5 – Related Party and Party-in-Interest Transactions

Plan investments are shares of mutual funds and a money market fund managed by the Trustee; therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

The Plan has notes receivable from participants at December 31, 2024 and 2023. These receivables and all related transactions qualify as party-in-interest transactions and are exempt from being prohibited by ERISA.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

Note 7 – Tax Status

The Plan operates under a non-standardized, preapproved profit-sharing plan sponsored by FMR, LLC. The Internal Revenue Service (“IRS”) has determined and informed FMR, LLC, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has not filed individually with the IRS for a letter regarding the Plan’s qualified tax status, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and thus believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Because of the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term, and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information described in Note 4 to the financial statements is complete and accurate.

Opinion

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

For information included in the supplemental information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 – Plan Description

The following description of the DISA Global Solutions 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of DISA Global Solutions, Inc. (the “Company” or “Employer”) and related participating employers. The Plan, which commenced effective January 1, 2016, and was amended and restated effective April 30, 2021, to comply with the latest rules and regulations, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

Plan Custodian and Trustee

Fidelity Management Trust Company (“Fidelity,” the “Custodian,” or “Trustee”) is the Custodian maintaining custody of all investments held by the Plan, maintaining the Plan’s participant account balances, and providing recordkeeping services to the Plan. Among other duties, the Custodian receives contributions, holds and invests the fund assets in accordance with the directions of participants, and makes distributions as directed by the Plan Administrator. Fidelity also serves as the Plan’s Trustee.

Plan Mergers

Effective November 7, 2022, the Company acquired Global Radar Holdings, LLC, and on December 9, 2022, the Company acquired Crimcheck Holdings, LLC. Effective January 1, 2024, the Global Radar Holdings, LLC 401(k) Plan (the “Global Radar Plan”) and the Crimcheck 401(k) Plan (the “Crimcheck Plan”) (collectively, the “Merged Plans”) were merged into the Plan. Fidelity became the new Custodian and recordkeeper. To aid with the transition to Fidelity, the Merged Plans instituted a blackout period for all activity with the new Custodian between December 22, 2023 and February 2, 2024. The formal transfer of all assets was completed on January 31, 2024, and net assets totaling \$10,022,522 were transferred from the Merged Plans to the Plan. This amount is included as transfers of assets to this Plan on the statement of changes in net assets available for benefits.

Eligibility and Plan Entrance Date

All employees, except those under collective bargaining agreements, nonresident aliens who receive no United States source income, and leased employees, are eligible to participate in the Plan after the employee has reached 18 years of age and completed one month of service. Eligible employees are permitted to enter the Plan on the first day of each month after satisfying the eligibility requirements.

Participant Contributions

Participants may elect to contribute, on a before-tax or Roth basis, up to 90% of their eligible compensation as defined by the Plan, subject to the annual deferral limit established by the IRC, which was \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to the maximum amount allowed annually by the IRC, which was \$7,500 for 2024.

Note 1 – Plan Description (continued)

Participant Contributions (continued)

The Plan includes a Qualified Automatic Contribution Arrangement (“QACA”) provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. The Plan also includes an automatic escalation feature where each year on June 1st, participants with a deferral rate greater than 0% will have their deferral rate increased by 1% annually until a deferral rate of 6% is reached, unless they elect otherwise.

Rollover Contributions

Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

Employer Contributions

The Plan provides for a QACA Safe Harbor Employer matching contribution equal to 100% of the first 1% of the participant's eligible compensation contributed to the Plan and 50% of the next 5% of the participant's eligible compensation contributions.

The Plan provides for the Employer to make discretionary matching, qualified matching, and nonelective discretionary contributions. The Employer made no such contributions for the year ended December 31, 2024.

Participant Accounts

Each participant account is credited with the participant’s contributions, Safe Harbor Employer matching contributions, Employer discretionary matching contributions, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants become vested in QACA Safe Harbor Employer matching contributions based on the following schedule:

Vesting (continued)

Participants are 100% vested immediately in their pre-tax deferred and after-tax contributions, rollovers, and any income or loss thereon. Participants hired prior to August 1, 2014, are 100% vested in prior Employer discretionary matching contributions. In addition, participants with assets in the frozen Safe Harbor Employer matching contributions will continue to be 100% vested.

Effective April 1, 2019, participants with frozen Safe Harbor Employer contributions that merged into the Plan from the WorkSmart Systems, Inc. 401(k) Profit-Sharing Plan are immediately vested in these contributions and any earnings thereon. Also, participants that merged into the Plan from the AWSI Plan are 100% vested in Employer discretionary matching contributions.

Effective, January 1, 2024, all eligible employees that merged into the Plan from the Crimcheck Plan are vested in discretionary match contributions based on the following schedule:

Participant-Directed Investments

All assets of the Plan are participant-directed investments. Participants have the option of directing their account balances to one or more investment options offered by the Plan. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. The investment options vary in types of investments, rates of return, and investment risk.

Notes Receivable from Participants

Effective March 13, 2023, the Plan was amended to allow initiation of new notes receivable from participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above Prime, as defined. Principal and interest is paid ratably by the participant and are due in equal installments not less frequently than quarterly.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or termination of employment, a participant or beneficiaries may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account. Terminated participants whose vested account balance is less than \$1,000 receive automatic distributions as a single lump sum payment. Terminated participants whose vested account balance is greater than \$1,000 but less than \$5,000 will receive a direct rollover to an individual retirement account ("IRA") chosen by the Plan Administrator. A participant may withdraw all or a portion of their vested account balance in the event of a financial hardship, as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age 59 ½ from all vested balances. Rollover contributions may be withdrawn at any time.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$72,841 and \$73,965, respectively. These accounts will be used to reduce future Employer contributions and pay Plan expenses. During the year ended December 31, 2024, forfeitures of \$145,000 were used to reduce Employer contributions.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Agreement.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Certain expenses incurred by or attributable to a specific participant are paid from that participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs that are unobservable inputs for the assets or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within level 1 of the fair value hierarchy.
- **Money Market Fund** – This investment is valued at cost, which approximates fair value and is classified within level 1 of the valuation hierarchy.

Note 5 – Related Party and Party-in-Interest Transactions

Plan investments are shares of mutual funds and a money market fund managed by the Trustee; therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

The Plan has notes receivable from participants at December 31, 2024 and 2023. These receivables and all related transactions qualify as party-in-interest transactions and are exempt from being prohibited by ERISA.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

Note 7 – Tax Status

The Plan operates under a non-standardized, preapproved profit-sharing plan sponsored by FMR, LLC. The Internal Revenue Service (“IRS”) has determined and informed FMR, LLC, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has not filed individually with the IRS for a letter regarding the Plan’s qualified tax status, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and thus believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Because of the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term, and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
