## INDEPENDENT AUDITOR'S REPORT

To the Investment and Savings Plan Committee, Plan Administrator and Participants of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan, established on October 1, 1999, is a defined contribution plan of Hydro Aluminum Metals USA, LLC (the Company). The Plan is subject to the provisions of ERISA.

On December 29, 2022, the SECURE 2.0 Act of 2022 ("SECURE 2.0 Act") was signed into law. The SECURE 2.0 Act makes various required and optional changes applicable to tax qualified retirement plans with varying effective dates through 2027. Certain mandatory changes to plan provisions or optional changes to be made to plan provisions as a result of the SECURE 2.0 Act are discussed throughout these financial statements. The plan document is required to be amended in regard to the requirements of SECURE 2.0 by December 31, 2026.

Eligibility: The Plan covers substantially all employees of the Company who are 18 years of age or older. Leased employees, independent contractors, employees who are nonresident aliens, nonresident United States citizens (unless the individual has entered into a written contract with the Company, under which they are eligible to participate in the Plan), expatriate employees (as defined), and employees covered by a collective bargaining agreement that have not entered into an agreement with the Company providing for their participation in the Plan are excluded from participating in the Plan.

Employees are eligible to participate in the Plan for deferral, safe harbor matching and additional discretionary matching contributions on the first day of the payroll period following or coinciding with their attainment of the eligibility requirements. Employees must complete 1,000 hours of service during the plan year and be employed on the last day of the plan year in order to share in the allocation of the discretionary nonelective contribution (variable contribution), except in the case of death, disability or attainment of normal retirement age.

Contributions: Each year, participants may elect to contribute from 1% up to 75% of their eligible compensation (as defined by the Plan), up to the maximum allowable contribution under the Internal Revenue Code (IRC). These contributions may be made as pre-tax or after-tax Roth deferral contributions. Under the Plan's automatic contribution arrangement, a contribution of 5% of eligible compensation will automatically be elected, unless otherwise directed by the employee. Each participating employee's deferral percentage shall increase by 1% of eligible compensation up to a maximum amount of 10% of eligible compensation, subject to the provisions defined in the plan document. The increase takes place each January 1st, unless otherwise directed by the employee. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Active and inactive participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company makes the following contributions on behalf of participants:

A safe harbor matching contribution, on a pay period basis, equal to 100% of a participant's elective deferrals, up to 5% of the participant's eligible compensation. For 2024, the safe harbor matching contribution totaled \$933,350.

An additional discretionary matching contribution, as determined by the Company, to eligible participating employees, on a pay period basis. No additional discretionary matching contribution was made for 2024.

**NOTE 1 - DESCRIPTION OF PLAN - CONTINUED**

Contributions - continued:

A variable contribution, as determined by the Company. The contribution is allocated pro-rata as a uniform percentage of participant compensation. During 2024, the Company elected to make a variable contribution to eligible participants equal to 2.5% of each participant's eligible compensation, totaling \$487,129. This amount was remitted to the Plan in 2025 and is recorded as a receivable on the Statement of Net Assets Available for Benefits as of December 31, 2024.

Qualified nonelective contributions (QNECs), as defined in the Plan. No QNECS were made for 2024.

Participant Accounts: Each participant's account is credited with the participant's contributions and Company contributions, as well as allocations of plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings/losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Participants may direct the investment of their contributions and the Company contributions into various registered investment companies (mutual funds) and a common/collective trust fund offered by the Plan. For those participants who do not make an investment selection, their contributions and Company contributions are automatically invested in the Plan's qualified default investment account.

Vesting: Participants are immediately vested in all contributions, plus earnings thereon.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Effective April 1, 2024, participants whose principal place of residence is located in a federally declared disaster area, as defined by the Plan, may borrow a maximum amount equal to the lesser of \$100,000 or 100% of their vested account balance. The notes are secured by the balance in the participant's account, bear interest at a rate equal to the Prime rate plus 1% and must be repaid within five years, except for notes issued for the purchase of a primary residence, which must be repaid within ten years. Only one note may be outstanding at a time and only two loans may be approved for a participant in each rolling 12 month period. Principal and interest is paid ratably through payroll deductions and must be repaid at least quarterly.

Payment of Benefits: Benefit payments may be in the form of lump sums or installments and are payable upon termination of employment, death, upon incurring a disability or retirement at age 59 ½. Benefit payments from certain accounts that merged into the Plan during previous years as a result of plan mergers may be paid in the form of an annuity, as defined by the Plan, or another form or manner that may have been permitted under the terms of the merged plans. The Plan shall make automatic distributions of vested account balances that are less than \$5,000 in accordance with plan provisions. Distributions from a participant's rollover account may be made at any time. Hardship withdrawals, in-service withdrawals at age 59 ½ and effective April 1, 2024, in-service withdrawals to participants whose principal place of residence is located in a federally declared disaster area, who are victims of domestic abuse and who incur necessary personal or family emergency expenses are also permitted, subject to provisions defined in the plan document.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Basis of Accounting: The Plan's financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment and Savings Plan Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Unit Values: Individual participant accounts for the common/collective trust fund are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the fund, but do have an interest therein represented by units valued daily. Investment income and realized and unrealized gains on investments are not distributed, but rather reinvested and reflected in the net asset value of the fund. Generally, contributions to and withdrawals from the fund are converted to units by dividing the amounts of such transactions by the unit values last determined (see Note 3), and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes are reclassified as distributions based on the terms of the plan document.

Contributions: Contributions from plan participants and Company contributions are recorded in the year in which the employee contributions are withheld from compensation or in which participant compensation is earned.

Payment of Benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment management fees of individual fund investments are charged to the respective investment and included in the net appreciation/depreciation of the investment, as they are paid through revenue sharing. An annual asset based fee and transaction fees related to participant distributions are charged directly to the participant's account and are included in administrative expenses. Fees related to the administration of notes receivable from participants are deducted from the loan proceeds.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1**

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

**Level 2**

Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3**

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Galliard Stable Return PN Fund (GSRF):* The fund has invested all of its assets in the Galliard Stable Return Core Fund (GSRCF) and the value of this investment is based on the underlying unit value as reported by the trustee of the GSRCF. The NAV of the GSRF is calculated daily and reflects reinvested investment income. Units of the fund are issued and redeemed at the current NAV.

**NOTE 4 - INFORMATION CERTIFIED BY A QUALIFIED INSTITUTION**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants and dividend income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, a qualified institution.

**NOTE 5 - TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed Principal Life Insurance Company (PLIC), by a letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

**NOTE 5 - TAX STATUS - CONTINUED**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

PLIC provides certain administrative services to the Plan pursuant to the Service and Expense Agreement between the Plan and PLIC (Agreement). In conjunction with the Agreement, PLIC receives asset-based recordkeeping fees in exchange for the administrative services provided. In addition, affiliates of PLIC and PLIC may receive, as additional compensation, certain fees from one or more of the Plan's investment funds and PLIC may earn compensation in the form of short-term interest (float) on certain funds in connection with the Plan. Any compensation earned in excess of the recordkeeping fees is credited to the participants' accounts and netted with expenses on the Statement Changes in Net Assets Available for Benefits as of December 31, 2024. The Plan or Company may make payments to PLIC for administrative expenses not covered by the above fees. Participants also pay transactional fees relative to the administration of notes receivable and participant distributions. Net plan administration and distribution fees paid to PLIC totaled \$69,138 for 2024. Fees related to the administration of notes receivable (which are deducted from loan proceeds) paid to PLIC totaled \$2,550 for 2024.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits. As of December 31, 2024 and 2023, 34% and 29%, respectively, of net assets available for benefits is invested in the Vanguard Target Retirement Funds; however, by their nature, these funds are a diversified mix of equities and fixed income that rebalance over time.

**NOTE 8 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 9 - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through June 26, 2025, the date the financial statements were available to be issued.

Effective April 1, 2025, the Plan was amended to increase the maximum percentage of eligible compensation relative the Plan's automatic escalation provision from 10% to 15%.
