INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Heartland Credit Union Capital Accumulation Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Heartland Credit Union Capital Accumulation Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits do not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued. See Other Matter - Plan Merger section.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the plan's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

Other Matter - Plan Merger

As described in Note 1 to the financial statements, effective December 31, 2024, the plan sponsor approved the merger of the plan into the Credit Union Retirement Plan Association 401(k) ("CURPA") plan, at which time the CURPA plan assumed legal custody of all net assets of the plan. The majority of the plan net assets were transferred into the CURPA plan by December 31, 2024. Certain plan net assets were remitted into the CURPA plan during 2025; and are reflected as a transfer on the accompanying 2024 statement of changes in net assets available for benefits as the CURPA plan had legal custody of such net assets. See Note 6 for reconciliation.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - Heartland Credit Union Capital Accumulation Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through June 18, 2025, which is the date the financial statements were available to be issued.

Plan mergers - During 2023, Heartland Credit Union completed a merger with St. Mary's & Affiliates Credit Union ("St. Mary's"). St. Mary's sponsored their own retirement plan, which was merged into the plan during 2023.

Effective December 31, 2024, the plan sponsor approved the merger of the plan into the Credit Union Retirement Plan Association 401(k) ("CURPA") plan, at which time the CURPA plan assumed legal custody of all net assets of the plan. The majority of the plan net assets were transferred into the CURPA plan by December 31, 2024. Certain plan net assets were remitted into the CURPA plan during 2025; and are reflected as a transfer on the accompanying 2024 statement of changes in net assets available for benefits as the CURPA plan had legal custody of such net assets. See Note 6 for reconciliation.

Key parties of the plan - Heartland Credit Union was the plan sponsor, employer and the plan administrator. CUNA Mutual Group ("CUNA"), a marketing name for CUNA Mutual Holding Company, was the third party administrator that maintained participant records and performed various compliance tests as tax counsel. CMFG Life Insurance Company ("CMFG"), a subsidiary of CUNA Mutual Holding Company, was the custodian that held the plan's stable value investment and notes receivable from participants. Matrix Trust Company ("Matrix") was the custodian of the mutual fund and common/collective trust investments. Mercer Global Advisors Inc. was the investment advisor. Three officers of the plan sponsor were discretionary trustees over the plan's stable value investment. The Board of Trustees for CUNA Retirement Programs were the discretionary trustees for all plan assets other than the stable value investment.

Investments - The plan sponsor determined the investments available to plan participants. The participants allocated their contributions and transferred existing balances among the available investment options. The net appreciation (depreciation) in the fair values of investments bought, sold or held during the years are reflected in the accompanying statements of changes in net assets available for benefits. Participants should refer to the investment account summaries and prospectuses for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows.

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for investments measured at fair value.

Mutual funds - The mutual funds held by the plan were valued at the daily quoted market prices as reported by the funds. The mutual funds were registered with the U.S. Securities and Exchange Commission, were required to publish their daily net asset value ("NAV") and were deemed to be actively traded.

Common/collective trusts - The common/collective trusts held by the plan were direct filing entities valued at their NAV as certified by Matrix. The NAV was used as a practical expedient to estimate fair value and was generally based on the fair value of the underlying investments held by a common/collective trust fund less its liabilities. This practical expedient was not used if it was determined to be probable that the fund would sell the investment for an amount different from the reported NAV.

The plan administrator determines by level, within the fair value hierarchy, the plan's investments at fair value as set forth below.

Investment at contract value - The plan invested in a fully benefit-responsive stable value account through a group annuity contract between the plan and CMFG. The contract was an obligation of CMFG and was supported by the general account assets of CMFG. Interest rates were adjusted quarterly and credited daily. There were no penalties assessed for benefit payments or other withdrawals taken by participants.

This stable value account was a fully benefit-responsive investment contract that was reported at contract value under GAAP. Contract value was the amount participants received if they initiated permitted transactions under the terms of the plan. Contract value, as reported by CMFG, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal of all or a portion of the investment at contract value at any time.

2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

General - The plan was adopted effective January 1, 1983 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees were eligible to contribute to the plan once they had completed six months of employment with at least 500 hours of service and had reached age twenty-one. An employee could enter the plan on the earlier of the first day of the plan year or the first day of the seventh month of the plan year coinciding with or next following completion of eligibility requirements.

Contributions - Contributions were recorded in the year in which the eligible compensation was paid. Contributions to the plan can be made in the following ways:

- a. Participants could contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permitted Roth elective deferral contributions.
- b. Rollover contributions were accepted by the plan from other qualified plans. There were no such contributions in 2024 or 2023.
- c. Employer matching contributions could be made at the employer's discretion. The employer matching contribution was equal to 100% of the first 6% of employee compensation contributed to the plan as elective deferral contributions in 2024 and 2023. These contributions are funded coinciding with each payroll.
- d. Employer nonelective contributions could be made at the employer's discretion. The employer nonelective contribution was equal to 4% of eligible compensation in 2024 and 2023. These contributions were funded annually subsequent to year-end. The 2024 employer nonelective contributions were remitted into the CURPA plan during 2025 and are reflected as a transfer on the accompanying statements of changes in net assets.

Participant accounts - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral and rollover contributions and an allocation of the employer's contribution. Participants are allowed to change their investment options on a daily basis and change their deferral percentage each pay period.

Vesting - Participants were always 100% vested in their elective deferral contributions, rollover contributions, and related earnings. Participants began vesting in any employer contributions and related earnings upon two years of service, at which time they are 20% vested. The participant then vested at the rate of 20% for each year thereafter. Upon death, disability, or attainment of normal retirement age while employed, participants became 100% vested.

Payment of benefits - Benefits were recorded when paid. Benefit payments could commence upon termination of employment, death, disability or attainment of normal retirement age. Distributions could be in the form of a single lump sum, equal installments, or partial withdrawals. In addition, hardship withdrawals were permitted under certain circumstances and in-service withdrawals were allowed upon attaining the age of 59½.

Administrative expenses - Certain administrative expenses of the plan were paid by the employer. Certain other administrative fees were paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for distribution and loan fees and non-participant directed charges for service and administrative fees. Non-participant directed fees were allocated to the participants on an account value basis.

Forfeitures - Forfeited nonvested accounts could be used to reduce employer contributions. Forfeitures used were \$28,000 and \$32,000 in 2024 and 2023. There were no unapplied forfeitures as of December 31, 2024 and 2023.

Notes receivable from participants - Participants could take out loans against their accounts with the approval of the plan administrator. The minimum loan amount was \$1,000 and the maximum amount was the lesser of one-half of the participant's vested account balance, or \$50,000. Participants could not have more than four loans outstanding at any given time. The repayment term generally could not exceed 5 years except when the loan was for the purchase of a principal residence. As of December 31, 2024, all notes receivable were transferred to the CURPA Plan.

3. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments were managed by the custodians (as defined in Note 1). The custodians also provided certain administrative services to the plan pursuant to service agreements between the plan sponsor and the custodians. Direct fees paid to the custodians were \$52,000 and \$51,000 in 2024 and 2023. The custodians received indirect compensation from mutual fund service providers for services the custodians provided to the funds. This indirect compensation was used to offset certain amounts that would otherwise be owed by the plan to the custodians for its administrative services to the plan. Transactions between the plan and the custodians qualified as party-in-interest transactions.

Notes receivable from participants and transactions with the CURPA plan also qualified as party-in-interest transactions.

All of these party-in-interest transactions were exempt from the prohibited transaction rules of ERISA.

4. INCOME TAX STATUS

The plan was operating under a CMFG Life Insurance Company pre-approved profit sharing plan that received a favorable opinion letter on June 30, 2020. The favorable opinion letter from the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan, however, the plan administrator and tax counsel believed the plan was designed and was operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believed the plan was qualified, and the related trust was tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

5. INFORMATION CERTIFIED BY THE CUSTODIANS

Management obtained certifications from the custodians (as defined in Note 1), qualified institutions under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan was complete and accurate.

- a. Investments held and the fair and contract values of such, and notes receivable from participants as of December 31, 2023;
- b. Dividends and interest income from investments and net appreciation (depreciation) in fair values of investments and interest income on notes receivable from participants during 2024 and 2023; and
- c. Contributions to, withdrawals from, transfers in, transfers out, purchases, sales and inter-fund transfers between accounts during 2024 and 2023.

6. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

As discussed in Note 1, the plan follows the accrual method of accounting for financial statement purposes. The Form 5500 was prepared on a cash basis in 2024 and 2023. As a result, the accompanying statement of net assets available for benefits as of December 31, 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023 differ from the Form 5500. In addition, certain 2024 contributions were remitted into the CURPA plan during 2025 and as such, transfers out per the financial statements differ from transfers out recorded on the Form 5500.
