We are the Court Appointed Accountants for the Chapter 7 Bankruptcy Trustee of The Lyons Companies (“Lyons” or the “Debtor”), the Sponsor of The Lyons Companies 401(k) Plan. Lyons filed for protection under Chapter 11 of the United States Bankruptcy Code on March 15, 2024, and was converted to a Chapter 7 proceeding on September 11, 2024, at which time Stephen Barnes Esq. was appointed as the Chapter 7 Trustee. The Debtor sold all of its assets in the Chapter 11 during July 2024, at which time all operations and payroll ceased.

As a result of the Chapter 7 bankruptcy proceeding, and pursuant to 11 U.S.C. Sect. 704(a)(11), the Trustee is responsible for the liquidation of the Plan Assets of The Lyons Companies 401(k) Plan (“the Plan”).

The 2024 annual informational return was prepared by Retirement Management Services LLC (“RMS”), the Third-Party Administrator, from the best information available; that is, data provided by the Debtor’s former personnel, the Debtor’s payroll service, and the Plan’s Record Keeper and Plan Asset Custodian, John Hancock (“JH”). Due to the cessation of business and the filing of bankruptcy, certain key financial records, subsidiary ledgers and documentation supporting various policies, transactions, and other matters that would normally be expected to be present in an operating enterprise, were missing or unavailable.

During 2024, as part of the termination and liquidation process, all of the Plan’s remaining funds were distributed to Participants. We are not aware of any complaints from Participants regarding the distribution or disposition of their account balances.

This Plan requires audited financial statements, but as a result of the bankruptcy the Estate is not authorized to use Debtor funds to pay for the audit at this time, and bankruptcy regulations require that Plan expenses be paid from Plan Assets. In an effort to minimize costs and preserve participants’ funds, the annual audit will not be prepared. Given that the Plan has terminated and all funds were distributed to participants, the Trustee and Bederson believe that not preparing audits is in the best interests of the Plan’s participants. In addition, the Debtor’s former personnel have only provided limited financial or other records needed to administer the bankruptcy and complete the audit, and the Plan’s prior auditors have not responded to our requests for information. Accordingly, due to lack of information caused by the bankruptcy and the need to preserve Plan Assets for participants’ benefit, the annual audit will not be prepared or attached to this Form 5500.

The period on this return through September 11, 2024 pre-dates the appointment of the Trustee and his professionals. Neither the Trustee nor the Trustee’s Court Appointed Accountants have any direct knowledge of the transactions recorded by the Debtor, JH and RMS as reported on this return. In addition, the Trustee and his professionals have no knowledge of the processes used or policies put in place by the Debtor or JH.

The Trustee, by his signature on the face of this informational return, has relied on RMS’s expertise in preparing the return from the available records, which were limited due to the entity's cessation of business. However, it is our qualified opinion that this is a complete return based on the financial information available.
