REPORT OF INDEPENDENT AUDITORS

To the Employee Savings and Investment Committee of the
United Group Service Centers, Inc. Private Ownership Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the United Group Service Centers, Inc. Private Ownership Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of November 8, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period from January 1, 2023 through November 8, 2023 and for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from qualified institutions as of November 8, 2023 and December 31, 2022 and for the period from January 1, 2023 through November 8, 2023 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management has determined to meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of Form 5500, Schedule H, Line 4a – Schedule of Delinquent Participant Contributions for the period from January 1, 2023 through November 8, 2023 is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or was derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

and the Year Ended December 31, 2022

A. Description of the Plan

Plan Description

The following description of the United Group Service Centers, Inc. Private Ownership Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan’s provisions. The Plan is sponsored by United Group Service Centers, Inc. (the “Company” or “Plan Sponsor”).

General

The Plan, which was adopted and effective June 1, 1989, and most recently amended and restated effective August 1, 2022, is a defined contribution plan covering substantially all employees of the Company and participating employers who have reached 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective January 1, 2010, the Plan became a qualified multiple employer plan. Under these new provisions, the Plan document was restated to allow for the Plan to be a qualified multiple employer profit sharing plan following the 401(k) provisions of the Internal Revenue Code (the “Code”) and section 210 of ERISA. The Plan allowed participation for the following participating employers:

- United Group Service Centers, Inc.
- Netiquette Enterprise Technology Inc. dba NETinc
- Specialized Association Services Inc.
- J Jarie Gallery, LLC
- Oakpoint Charitable Foundation
- Zoology Foundation at Crooked Willow Farm

- National Service Source Inc. dba United Service Source Inc.

- Adalante Capital, LLC
- Joule, Inc. dba Crooked Willow Farms

The purpose of the Plan is to encourage the Company’s employees to save and invest, systematically, a portion of their current compensation so that they and their families may have a source of additional income upon their retirement, or in the event of death.

A. Description of the Plan – continued

General – continued

The Board of Directors of the Company has appointed the Employee Savings and Investment Committee and the plan administrator to administer the Plan.

Effective August 1, 2022, the Plan was amended to include Wild Mountain Bees LLC as a participating employer.

Effective October 28, 2022, Empower Retirement, LLC (“Empower”) became the sole custodian of the Plan, as Empower acquired the retirement business of Massachusetts Mutual Life Insurance Company (“MassMutual”) (collectively, the “Custodians”). As a result of this transition, the trustee of the Plan changed from Reliance Trust Company (“Reliance”) to Empower Trust Company, LLC (“ETC”) (formerly Great-West Trust Company, LLC) and Empower Annuity Insurance Company of America (“EAIC”) (formerly Great-West Life & Annuity Insurance Company) (collectively, the “Trustees”).

Effective August 1, 2022, the Plan was amended to exclude Membership.com LLC as a participating employer, and effective December 1, 2022, National Service Source Inc. exited the Plan. Membership.com and National Service Source Inc. transferred into another plan, and as a result, a transfer to another plan in the amount of approximately \$14,171,000 is recorded in the Plan’s statement of changes in net assets available for benefits for the year ended December 31, 2022.

Effective January 1, 2023, the Plan Sponsor elected to suspend all employee and employer contributions to the Plan and transfer all assets to the Nextstep 401(k) Retirement Savings Plan sponsored by Empower Retirement through a plan merger beginning on March 16, 2023 (the “Effective Date”) through November 8, 2023. The plan merger is recorded as a transfer out in the amount of approximately \$10,889,000 in the statement of changes in net assets for the period from January 1, 2023 through November 8, 2023.

Contributions

Effective January 1, 2023, the Plan Sponsor suspended all employee contributions. Prior to this date, participants aged 18 years or older were eligible to participate in the Plan the first day of their employment. Employees could elect to contribute a portion of their annual compensation on a pre-tax basis, as defined by the Plan. Contributions were subject to limitations on annual additions and other limitations imposed by the Code as defined in the Plan document.

Prior to January 1, 2023, the Plan had an automatic enrollment provision for all employees. Each employee had a 60-day opt-out period in which they could elect a contribution percentage and make investment choices. If the employee did not make an election within 60 days, they would be automatically enrolled at a 3% salary deferral rate and all contributions would be directed to the Plan’s default fund.

Contributions – continued

Non-highly compensated employees could contribute in 1% increments up to 100% of their 401(k) eligible salary up to the maximum annual amount allowed by the Code for any calendar year. All highly compensated employees were limited to a maximum of a 15% contribution rate.

Effective January 1, 2023, the Plan Sponsor suspended all employer contributions. For the year ended December 31, 2022, the Company made a discretionary matching contribution equal to 100% of each participant's elective deferrals not exceeding 7% of the participant's eligible compensation.

Participant Accounts

Prior to the Effective Date, each participant's account was credited with the participant's contributions, actual earnings thereon, and allocations of: (a) the Company's matching contributions and (b) forfeitures of terminated participant's non-vested accounts. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants' voluntary contributions to the Plan plus actual earnings or losses thereon are fully vested at all times. Prior to the Plan Termination Date, the participants' share of the Company's contributions and earnings or losses thereon vested in accordance with the following schedule:

1 year	10%
2 years	30%
3 years	50%
4 years	70%
5 years	100%

Company contributions become fully vested in the event of retirement, death, or disability of a participant. Effective January 1, 2023, as part of the plan merger, active participants became 100% vested in their employer matching contributions including the discretionary matching contributions.

Benefit Payments

Participants withdrawing during the year for reasons of service or disability, retirement, death, or termination are entitled to their account balances or a portion thereof, depending on the number of years of continuous service with the Company and the reason for withdrawal from the Plan. Those entitled to receive benefits may elect to receive either a lump-sum payment or a rollover distribution.

Participants' vested account benefits of \$1,000 or less after termination are subject to an involuntary lump-sum distribution which is processed as soon as administratively practicable. Participants' vested account benefits of more than \$1,000, but less than \$5,000 after termination are subject to automatic rollover to an individual retirement account, if not otherwise specified by the participant in a timely manner, with the custodian as soon as administratively practical. Participants' vested benefits of more than \$5,000 remain with the Plan's assets until the participant elects a distribution.

Prior to the Effective Date, certain in-service withdrawals were allowed. A participant could have also elected to withdraw all or a portion of his/her vested account balance while employed after reaching age 59 ½. A participant could receive a hardship distribution from salary reduction contributions and rollover contributions if the distribution was: (1) on account of uninsured medical expenses incurred by the participant, his/her spouse, or dependents; (2) to purchase (excluding mortgage payments) a principal residence of the participant; (3) for the payment of post-secondary tuition expenses for the participant, his/her spouse, or dependents; (4) needed to prevent eviction of the participant from his/her principal residence or foreclosure upon the mortgage of the participant's principal residence; (5) burial or funeral expenses for the participant's parent, spouse, children, or dependents; (6) expenses for the repair of damage to the participant's principal residence caused by fire, storm, or other casualty, provided that the expenses qualify as a casualty loss on the participant's tax return; or, (7) expenses or losses (including loss of income) incurred on account of disaster declared by the Federal Emergency Management Agency.

Forfeitures

Forfeited balances of terminated participants' non-vested accounts can be used to pay administrative expenses of the Plan. Prior to the Plan Termination Date, any part of the forfeiture account that was not used to pay expenses was allocated to participants employed by the Plan Sponsor or participating employers on the last day of the Plan year as additional Company contributions for the Plan year.

For the period from January 1, 2023 through November 8, 2023 and for the year ended December 31, 2022, approximately \$127,000 and \$17,000 of forfeitures were allocated to reduce plan administrative expenses, respectively. For the period from January 1, 2023 through November 8, 2023 and for the year ended December 31, 2022, the Plan did not allocate non-elective contributions from the forfeiture account to eligible participants. At December 31, 2022, forfeited non-vested accounts were approximately \$127,000. There were no unallocated forfeitures at November 8, 2023.

A. Description of the Plan – continued

Investment Options

Prior to the Plan Termination Date, upon enrollment in the Plan, a participant was allowed to direct their salary deferrals in 1% increments into any of the Plan's investment options.

Plan Expenses

Employees of the Company perform certain administrative functions with no compensation from the Plan. Certain administrative costs of the Plan are paid by the Plan. Plan expenses not paid by the Plan are paid by the Company and are not reflected in the accompanying financial statements.

The Plan entered into an agreement with Empower, whereby Empower was required to make quarterly contributions to the Plan Expense Account ("PEA") in an amount equal to \$23,000 annually, prior to the Effective Date. The funds in the PEA may be used to pay Plan administrative expenses during the year.

B. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP")

Use of Estimates

The preparation of the financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

Investment Valuation and Income

The investments of the Plan are stated at fair value as of the end of the year and are subject to market or credit risks customarily associated with equity investments. Fair value measurements are determined in accordance with GAAP, which defines fair value, establishes a framework for measuring fair value, and expands disclosures about assets and liabilities measured at fair value. See Note C for information related to the Plan's valuation methodologies.

Investment gains and losses are accounted for using the average cost basis of the securities sold. The net realized and unrealized gains and losses on investments include realized gains and losses on sales of investments during the year and unrealized increases or decreases in the market value of investments held at year-end. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

B. Significant Accounting Policies – continued

Contributions

Contributions from the participants and the employer are accrued in the period in which they are deducted in accordance with salary deferral agreements and become obligations of the Company, as determined by the Plan's administrator.

Payment of Benefits

Benefits are recorded when paid.

C. Fair Value Measurements

GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and establishes a three-tier hierarchy that is used to identify assets and liabilities measured at fair value. The hierarchy focuses on the inputs used to measure fair value. The three levels are as follows:

- Level 1 — observable inputs that are based upon quoted market prices for identical assets or liabilities within active markets.
- Level 2 — observable inputs other than Level 1 that are based upon quoted market prices for similar assets or liabilities, based upon quoted prices within inactive markets, or inputs other than quoted market prices that are observable through market data for substantially the full term of the asset or liability.
- Level 3 — inputs that are unobservable for the particular asset or liability due to little or no market activity and are significant to the fair value of the asset or liability. These inputs reflect assumptions that market participants would use when valuing the particular asset or liability.

GAAP requires a description of the methodologies used to measure the fair value of assets and liabilities. The methodologies used to measure the fair value of the Plan's investments are as follows:

- Mutual funds are valued at the published per share net asset value ("NAV") of shares held by the Plan and are classified within Level 1 of the valuation hierarchy. There are no significant restrictions on redeeming these investments at NAV.
- The guaranteed investment contract is an investment offered by EAIC. The NAV is computed and reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider, and is classified within Level 2 of the valuation hierarchy.

There have been no changes in the methodologies used at November 8, 2023 and December 31, 2022.

These items are classified in their entirety based on the lowest priority level of input that is significant to the fair value measurement. The assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the placement of assets and liabilities within the levels of the fair value hierarchy.

D. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at November 8, 2023 and December 31, 2022, and net appreciation (depreciation) in fair value of investments, interest and dividends for the period from January 1, 2023 through November 8, 2023 and for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustees of the Plan.

E. Tax Status

Effective August 1, 2022, the Plan was amended and restated by the adoption of the Empower Non-Standardized Pre-Approved Money Purchase Pension Plan which has a favorable advisory letter from the Internal Revenue Service (“IRS”) as of April, 7, 2021. This opinion letter states that the form of the prototype plan is acceptable under Section 401 of the Code. The Plan Sponsor may rely on this letter with respect to the qualification of the Plan under Code Section 401(a) with certain limitations.

Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Company believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan was qualified and was tax-exempt as of the financial statement date.

E. Tax Status – continued

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of November 08, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements, except as noted above. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

F. Parties-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

The Plan invests in a guaranteed interest account managed by the Custodians of the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. The Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA, which are exempt from the prohibited transaction rules.

G. Plan Termination

The Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, all amounts credited to participant's accounts will become 100% vested.

Effective January 1, 2023, as described in more detail in Note A, the Plan Sponsor elected to transfer all assets to the Nextep 401(k) Retirement Savings Plan sponsored by Empower Retirement through a plan merger. All affected participants became 100% vested in their accounts due to the plan merger. Prior to the transfer of participant balances to the Nextep 401(k) Retirement Savings Plan at Empower Retirement on the Effective Date, participants had the option to transfer their funds to another eligible retirement plan or to take a distribution as previously allowed by the Plan. All assets of the Plan have been fully distributed and transferred out as of November 8, 2023.

H. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances.

I. Subsequent Events

In preparing the accompanying financial statements, management has evaluated all subsequent events and transactions for potential recognition or disclosure through August 23, 2024, the date the financial statements were available for issuance.
