We have performed an audit of the financial statements of The Inland Hospital Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

1. Description of the Plan

The following description of The Inland Hospital Pension Plan (the Plan) is provided for general information purposes only. Participants should refer to the Summary Plan Document for more complete information.

General - The Plan is a defined contribution plan sponsored by Inland Hospital. The employees of Inland Hospital and certain affiliated organizations named as Participating Employers in the Plan's Adoption Agreement (collectively, the Employer) were eligible to participate in the Plan. State Street Bank and Trust Company serves as the Plan's trustee and maintains the Plan's investments. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2010, the Employer joined the Northern Light Health Retirement Partnership 403(b) Plan. In conjunction with the change, contributions to the Plan ceased effective December 31, 2009.

Investment Options - Participants may direct their account balances into various investment options. Investment objectives are as stated in the prospectus. The Plan currently offers several mutual funds and a group annuity contract as investment options for participants.

Vesting - Participants are fully vested at all times in their employee elective deferral account. Participants immediately vest in employer contributions.

Payment of Benefits - Participants may receive distributions for employee contributions deposited into their pre-1989 annuity contract for any reason. For all other account balances, participants may receive distributions upon the occurrence of the following events: (i) termination of employment; (ii) demonstration by the participant to the plan administrator that the participant is experiencing hardship, as defined in applicable regulations promulgated or to be promulgated pursuant to the Internal Revenue Code (the Code) for employee contributions only; (iii) death; (iv) becoming disabled, or (v) attaining age 59½. Participants may elect to receive part or all of his/her distribution in a lump sum, an annuity, or have the amounts rolled over.

Participant Accounts - Individual accounts are maintained for each plan participant. Each participant's account is credited with their previous contributions, rollovers, and allocations of Employer discretionary contributions. Plan earnings and expenses are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

2. Summary of Significant Accounting Policies

Method of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

Use of Estimates - The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Risks and Uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Benefits - Benefits to participants are recorded when paid.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value, except for the fully benefit responsive contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. See Note 8 for discussion of fair value measurement.

Administrative Expenses - The Employer pays certain administrative expenses of the Plan, except for Plan recordkeeping expenses.

3. Investment Contract with Insurance Company

The Plan has a group annuity contract with Transamerica Financial Life Insurance Company (TFLIC). TFLIC maintains the contributions in a fixed account. The fixed account is credited with deposits made to the account and interest credited under the terms of the contract, less any withdrawals. Upon suspension of the fixed account contract, TFLIC will transfer, to the designated payee, 95% of the contract value of the fixed account assets. A 5% withdrawal charge will be withdrawn from the fixed account upon transfer. The group annuity contract is included in the financial statements at contract value (which represents contributions made under the contract, plus earnings, less withdrawals), because it is fully benefit responsive. The average yield was 3.50% and 3.43% at December 31, 2024 and 2023, respectively.

4. Information Certified by the Trustee of the Plan

The investments, investment transactions, net appreciation in fair value of investments, and interest and dividends were obtained by management and agreed to or derived from the information certified by State Street Bank and Trust Company, the trustee of the Plan, as complete and accurate. 5. Related-Party Transactions

Plan investments include shares of mutual funds and a group annuity contract managed or held by Transamerica. Transamerica is an affiliate of Transamerica Retirement Solutions, the Plan recordkeeper and, therefore, these transactions qualify as party-in-interest transactions. Recordkeeper fees paid to Transamerica were \$6,872 and \$5,491 for the years ended December 31, 2024 and 2023, respectively.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Tax Status of the Plan

The Plan utilizes a prototype 403(b) plan document. The Internal Revenue Service approved the prototype plan document, and the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

8. Fair Value Measurement

The framework for measuring fair value in accordance with U.S. GAAP establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, and other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The following is a description for the valuation methodologies used for assets and liabilities measured at fair value:

Mutual funds - The fair values of mutual funds are based on daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
