## **Independent Auditor's Report**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Elm Street Technology 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## NOTE A – PLAN DESCRIPTION

The following description of the Elm Street Technology 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

### *GENERAL*

The Plan is a defined contribution 401(k) plan sponsored by Elm Street Technology, LLC with a plan year end of December 31st. The original Plan became effective September 1, 2016, with the most recent restatement of the Plan being effective November 15, 2024. This restatement updated the named limited trustee of the Plan. The Plan covers substantially all employees of Elm Street Technology, LLC, Outbound Engine, LLC and IDX, LLC, hereon collectively referred to as the “Company” and “Employer.” The provisions of the Plan are included in the official Plan document, which legally governs the operations of the Plan and is available for more detailed information. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

### *ELIGIBILITY*

The Plan covers substantially all employees of the Company that have 2 months of continuous service. There is no age requirement to join the plan.

### *PARTICIPANT AND COMPANY CONTRIBUTIONS*

Each year, participants may elect to contribute a percentage of their eligible compensation in pre-tax or Roth contributions up to 92 percent of their eligible compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also rollover funds from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan incorporates a match with a rate of 100 percent on up to 6 percent of a participant’s eligible compensation with a maximum match amount of \$3,000.

The Plan also incorporates a discretionary profit-sharing contribution. Participants must generally be employed on the last day of the Plan year and have 1,000 hours worked during the year to be eligible for the discretionary profit-sharing contribution. There were no profit-sharing contributions to participants in 2024 or 2023. Participants direct the investment of their match and discretionary profit-sharing contributions into various investment options offered by the Plan.

### *PARTICIPANT ACCOUNTS*

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions, and (b) Plan earnings or losses, and is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

## NOTE A – PLAN DESCRIPTION – CONT.

### *VESTING*

Participants are immediately vested in their elective (voluntary) contributions, employer matching contributions, and any income or loss thereon. Vesting in the discretionary profit-sharing contributions use a cliff schedule of 6 years (0 percent vested for 5 years, then 100 percent vested after 6 years of service).

### *FORFEITED ACCOUNTS*

On December 31, 2024 and 2023, there were no forfeited non-vested account balances. Any forfeiture amounts can be used to pay Plan expenses or to reduce future Employer contributions. \$0 of forfeiture amounts were utilized during 2024.

### *PAYMENT OF BENEFITS*

Distributions of benefits are defined in the Plan document. Generally, upon termination of employment, death, disability, or normal retirement, a participant (or designated beneficiary) may elect to receive 100% of his or her vested account balance in either a lump sum cash payment or a direct rollover to another qualified plan, or partial payouts. Participants who have attained age 59 1/2 may also withdraw all or a portion of their vested account balances. Minimum distributions are required once the participant reaches age 73. Participants may also receive a lump sum amount upon demonstration of a financial hardship.

### *NOTES RECEIVABLE FROM PARTICIPANTS*

The Plan provides that participants can borrow funds of at least \$1,000 up to a maximum equal to the lesser of 50 percent of their vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at reasonable rates determined by the loan administrator. The term of the loan cannot exceed five years. Principal and interest is paid ratably through payroll deductions. A participant may only have one loan outstanding at a time.

## NOTE B – SUMMARY OF ACCOUNTING POLICIES

### *BASIS OF ACCOUNTING*

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

### *USE OF ESTIMATES*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could vary from these estimates.

### *INVESTMENT VALUATION AND INCOME RECOGNITION*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *OTHER EMPLOYER CONTRIBUTIONS*

Other employer contributions relate to a correction made by the Employer for missed deferrals and matching contributions for participants on their eligible compensation. This correction was made in May 2025.

## **NOTE B – SUMMARY OF ACCOUNTING POLICIES – CONT.**

### *NOTES RECEIVABLE FROM PARTICIPANTS*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the loan balance is reduced, and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024.

### *PAYMENT OF BENEFITS*

Benefit payments to participants and their beneficiaries are recorded when paid.

### *OPERATING EXPENSES*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of the fair value of the investments.

### *DATE OF MANAGEMENT REVIEW*

Subsequent events were evaluated through June 9, 2025, which is the date the financial statements were available to be issued. Management is not required to and has not evaluated events or transactions that occurred after June 9, 2025.

## **NOTE C – UNAUDITED INVESTMENT INFORMATION CERTIFIED BY TRUSTEE**

The Plan Administrator has elected the method of compliance permitted by 29 CFR Section 2520.103-8 of the Department of Labor Rules and Regulations and disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by the trustee, Mid Atlantic Trust Company, was not subjected to any auditing procedures performed by the independent public accountants.

- a. All investments shown in the accompanying statements of net assets available for benefits, including notes receivable from participants.
- b. Net investment income from the investments, as shown in the accompanying statement of changes in net assets available for benefits, including dividends and interest income and net realized and unrealized appreciation (depreciation) in the fair value of assets.

## NOTE D – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB (Financial Accounting Standards Board) ASC (Accounting Standards Codification) 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

There have been no transfers between levels in 2024 or 2023.

Following is a description of the valuation methodologies used for assets measured at fair value.

**Money Market Fund:** Value based on quoted prices in active markets for identifiable securities.

**Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common/Collective Trust:** Valued at the NAV of the units in the Principal Stable Value Fund. The NAV, as provided by the trustee, Principal Trust Company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily.

## NOTE D – FAIR VALUE MEASUREMENTS – CONT.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

## **NOTE E – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Mid Atlantic Trust Company is the custodian of the Plan assets. Paychex provides third-party administrative and recordkeeping services. Pooler CPA Group, LLC is the Plan auditor. Wells Fargo is the investment manager and provides investment management services and consulting to the Plan and Plan participants. ERISA Fiduciary Services, Inc. provides plan administrative services. Trucker Huss, APC provide legal services. Therefore, these transactions qualify as party-in interest transactions.

Audit fees and certain other administrative expenses are rendered by parties in interest and are paid by the Company. The Company also provides certain administrative services for the Plan for which it receives no compensation.

## **NOTE F - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## **NOTE G – TAX STATUS**

The Plan, which is a prototype plan sponsored by Paychex, has received a favored opinion letter dated August 31, 2020, in which the Internal Revenue Service has stated that the Plan Documents are acceptable under section 401 of the Internal Revenue Code and therefore not subject to tax. The Plan has been amended since receiving the opinion letters. However, the Plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

## **NOTE H – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions, if any.

## **NOTE I – PARTIAL PLAN TERMINATION**

In 2023 the Plan experienced a partial plan termination based on layoffs at the Company. All participants that were affected by the partial plan termination were noted to have been vested in their employer contribution accounts at 100 percent.

### NOTE K – DELINQUENT PARTICIPANT CONTRIBUTIONS

In 2022, the Company acquired Outbound Engine, and the assets of the Outbound Engine 401(k) Plan were transferred to the Elm Street Technology 401(k) Profit Sharing Plan and Trust in February 2023. During the audit of the 2022 Outbound Engine 401(k) Plan by other auditors it was noted that there were \$120,302 of participant contributions and loan payments that were remitted beyond the normal remittance time periods that the Outbound Engine 401(k) Plan submitted contributions to the custodian. As result of the acquisition of Outbound Engine and the agreement set forth by the two parties, the late remittances will be corrected outside of VFCP in 2025 and added to these financial statement supplemental schedules. The overall lost earnings are not considered material and are not accrued within these financial statements.

During 2023, the Plan remitted employee contributions in the amount of \$3,083 beyond the normal remittance time periods that the Plan usually submits contributions to the custodian. The third-party administrator created an earnings analysis and the total amount of the correction would be a loss of \$232. The Company decided to take a conservative approach and not make those corrections to the affected participant accounts.
