INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Connoisseur Media, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Notes to Financial Statements

December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Connoisseur Media, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established in 2008 and is a defined contribution plan covering substantially all employees of Connoisseur Media, LLC (the Company or Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Substantially all employees of the Company are eligible to participate in the Plan once they have reached age 21 or older, and have completed two months of service. After an employee of the Company has satisfied the eligibility requirements, they are eligible to enter the Plan as a Participant on the first day of the month coinciding with or following the date on which the eligibility requirements are satisfied. Excluded participants are union employees, leased employees and those otherwise deemed ineligible in accordance with the Plan document.

Contributions

The Plan permits participants to defer a portion of their compensation, as defined in the Plan, through voluntary payroll withholdings. Roth contributions are also permitted under the Plan. The amount an employee may contribute is limited to the maximum amount as permitted under the Internal Revenue Service (IRS). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute (rollover) amounts representing distributions from other qualified plans. The Plan has established an automatic enrollment provision which sets a default automatic deferral of 3% of participant's compensation, with an automatic escalation amount of 1%, up to a maximum of 7%, unless a participant elects otherwise.

The Company, at its discretion, may make matching employer contributions on behalf of each eligible participant. The Company may also make discretionary employer matching contributions; however, no such contributions were made in 2024. Contributions are subject to IRS limitations.

The Plan allows participants to change the investment of their funds on any business day in any combination of the investment options offered under the Plan, as long as the changes conform to the investment option's guidelines.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Plan Sponsor's contribution and the Plan earnings and is charged with administrative expenses not paid by the Plan Sponsor. The Plan provides that earnings on contributions are accumulated tax deferred. The Plan also provides that the participants are not subject to income tax on the amounts contributed and related earnings until the Plan makes distributions to the participant. Each participant has the right to invest their contributions into any of the various investment options offered by the Plan. Allocations are based on participant earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All of the Plan's investments are participant-directed.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Vesting

Participants are vested immediately in their contributions and employer contributions plus actual earnings thereon.

Notes Receivable from Participants

The Plan permits participants, including terminated employees, to borrow from their participant accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All loans must be repaid in level payments on at least a quarterly basis over a five-year period unless the loan is for the purchase of a principal residence in which case the loan may be repaid over a ten-year period. The loans are secured by the balance of the participant's vested account and bear interest at a rate commensurate with market rates.

Payment of Benefits

Upon termination of service for any reason, participants with a vested account balance less than \$5,000 will automatically receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For terminated participants with a vested account balance greater than \$5,000, participants may elect to defer their payments to a later date and receive a single lump-sum payment.

In-service distributions may also be made from the Plan, these distributions may be made from a participant's vested account balance. Withdrawals from a participant's salary deferral account (excluding earnings) may also be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Withdrawals from a participant's accounts may also be made upon reaching age 59½, in accordance with the provisions specified in the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through June 24, 2025, the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The funds must to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)

The fair value of the money market fund is reported at the carrying amount which approximates fair value because the instrument is liquid in nature.

NOTE 4 - CERTIFIED INVESTMENTS

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company ("Fidelity"), the trustee of the Plan.

NOTE 5 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The expenses of administering the Plan are paid by the Plan to the extent not paid by the Company. The Company provides various recordkeeping and administrative services to the Plan for which it receives no compensation. Fidelity is the Trustee and recordkeeper as defined by the Plan and qualifies as parties-in-interest and at times holds assets in a cash account. In addition, loans to participants qualify as party-in-interest transactions.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 7 - TAX STATUS

The Plan is a volume submitter plan sponsored by Fidelity which received an opinion letter from the United States Treasury Department Internal Revenue Service (IRS) on June 30, 2020, which stated that the volume submitter document was acceptable in accordance with the applicable requirements of the IRC. The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
