Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Tax Deferred Annuity Plan for Employees of Chugachmiut, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Tax Deferred Annuity Plan for Employees of Chugachmiut's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Tax Deferred Annuity Plan for Employees of Chugachmiut's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Note 1: Description of Plan

The following description of the Tax Deferred Annuity Plan for Employees of Chugachmiut (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant directed, defined contribution plan covering all employees of Chugachmiut (the Employer), exception for non-resident aliens with no U.S. income and employees who are eligible to make salary reduction contributions to another plan of the Employer described in Sections 401(k), 403(b), or 457(b) of the Internal Revenue Code (the Code). Eligible participants can begin contributing to the Plan on the first date of hire. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Amendments

Effective December 17, 2015, the Plan amended its Tax Deferred Annuity Plan document to allow for Roth contributions.

Contributions

Eligible employees may elect to contribute any percentages of their salary, up to a statutory limit of \$23,000 and \$22,500 for 2024 and 2023, respectively. In addition, participants who are 50 years of age or older, can choose to make a catch-up contribution, limited to \$7,500 for 2024 and 2023. Eligible employees may roll over distributions from other qualified plans.

Participants direct the investments of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's elected contribution and an allocation of the plan earnings for the year. The allocations are based on each participant's earnings with the investments that the participant has selected. Participants are immediately vested in their contributions and all actual earnings.

Benefits

Hardships and in-service withdrawals are permitted if certain criteria are met. On termination of service, death, or retirement, participants may elect to receive an annuity or a lump-sum distribution. If the account balance is less than \$1,000, the participant will automatically receive a lump sum distribution that will be distributed directly to the participant.

Policy Loans

Participants may borrow from Mutual of America using a portion of their account as security for the loan. The minimum loan is \$1,000 and may be up to the lesser of \$50,000 or 50% of their account balance. The Administrator and the Issuer of the affected Annuity Contracts shall specify the interest rate for each loan at the time it is approved. The loan interest rate charged for any loan shall be reasonable and commensurate with the current commercial rates charged on similar loans by persons in the business of lending money, including duly licensed companies issuing contracts funding retirement plans. Currently, the loans bear interest rates between 5.33% and 5.85%. Principal and interest is paid ratably through monthly payroll deductions. The Plan Administrator has concluded that these loans are not plan assets and that such arrangements are exempt transactions. The balances as of December 31, 2024 and 2023 are \$23,078 and \$28,805. Plan assets

serve as collateral to these loans. Participants paid \$2,407 and \$1,137 of interest on such loans during the plan years ended December 31, 2024 and 2023, respectively. In the event of default, such loans are reportable to plan participants as taxable income but remain outstanding and continue to accrue interest until repaid by the plan participant of the participant becomes eligible to receive a distribution under the terms of the Plan. As of December 31, 2023, there was one loan in default in the amount of \$1,804, plus accrued interest of \$908.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Uses of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Interest Accumulation Account

The Interest Accumulation Account with Mutual of America Life Insurance Company is comparable to a cash equivalent. There are no front or back-end charges, so the account is completely liquid. The interest rate accredited to the account is a current rate and is not dependent upon the length of time the assets are invested. Requests for withdrawal can be made any time. The value shown is the redeemable value; there are no deferred sales charges, load assessments or interest rate adjustments that would affect the value.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on the investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan Administrator has evaluated subsequent events through June 13, 2025, the date on which the financial statements were available to be issued.

Note 3: Information Certified by Mutual of America Life Insurance Company

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mutual of America Life Insurance Company, as issuer, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- (a) Interest accumulation account and investments at fair value, as shown in the Statements of Net Assets Available for Benefits;
- (b) Interest income and net appreciation in fair value of investments, as shown in the Statements of Changes in Net Assets Available for Benefits; and
- (c) All information included in the Schedule of Assets (Held at End of Year), as shown in the supplemental schedule.

Note 4: Fair Value Measurement

Fair value is defined as the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. A framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below.

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts: Net Asset Value (NAV) of shares held. The NAV is based on the fair value of the underlying investments held in the account less its liabilities and is deemed readily determinable as it is a basis for current transactions.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Tax Status

The Plan terms have been drafted in reliance on the sample language provided by the Internal Revenue Service in the draft Listing of Required Modifications issued April 4, 2010. The Plan is required to operate in conformity with the Internal Revenue Code to maintain the exclusion from tax for plan participants. Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator intends to apply for a determination letter on the Plan when the government opens such program.

Plan management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

Note 6: Related-Party and Party in Interest Transactions

Certain Plan investments are shares of separate accounts managed by Mutual of America Investment Corporation, a subsidiary of Mutual of America Life Insurance Company. Mutual of America Life Insurance Company is the issuer as defined by the Plan and, therefore, these transactions qualify as party in interest transactions as defined by ERISA. Any transactions involving these investments are executed on the open market at fair market value. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party in interest transactions under ERISA.
