Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Elite Spice, Inc. 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS
December 31, 2024 and 2023

NOTE A – PLAN DESCRIPTION

The following brief description of Elite Spice, Inc. 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering substantially all non-union employees of Elite Spice, Inc. (the Sponsor) who have attained age twenty-one and have completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was originally effective as of January 1, 1990 and was restated on September 9, 2009 to incorporate required provisions of statutory and regulatory changes.

2. Eligibility

Each employee is eligible to make contributions to the Plan on the first day of the quarter following the attainment of age twenty one and having worked at least 1,000 hours of service within a 12-month period.

Effective in March 1, 2024, the Plan was amended to allow employees who have attained age twenty one to become eligible to make contributions beginning on the first day of the month following 30 days of employment.

3. Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan requires all newly eligible employees to automatically contribute 4% of compensation to the Plan, unless the employee affirmatively elected not to participate. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Sponsor may elect to make a discretionary matching contribution on participant deferrals up to a maximum limit of \$1,000 per participant. For the year ended December 31, 2024, the Sponsor elected to match 50% of the employee's deferrals. The discretionary matching contributions are invested in the same investment options and allocation percentages as the participant-directed contributions. The employee must have at least 12-months of service, worked at least 1,000 hours during the year, and be employed at the end of the year to be eligible for a discretionary matching contribution.

NOTE A – PLAN DESCRIPTION - Continued

4. Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Sponsor's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

5. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Sponsor's matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants are 50% vested after one year of service and 100% vested after two years of service.

6. Notes Receivable from Participants

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with rates charged for similar loans by commercial lenders as determined by the Plan administrator. Principal and interest are paid through monthly payroll deductions.

7. Payment of Benefits

Upon termination of service due to death, disability, retirement or termination of service due to other reasons, a participant or the participant's estate or beneficiary will receive a lump-sum amount equal to the value of the participant's vested interest in the participant's account, or in the form of an annuity. Amounts less than \$7,000 are payable only in a lump sum. Partial, systematic and hardship withdrawals are permitted by the Plan, subject to the Plan provisions and Internal Revenue Service (IRS) restrictions. The Plan adopted the provision of the CARES Act and SECURE Act which allowed qualified individuals to receive payments of benefits up to \$100,000 without the 10% penalty from January 1, 2020 to December 31, 2020. Individuals who received qualified distributions under the CARES Act can elect to pay the distribution back within three years. As of December 31, 2023, the payback period allowed by the CARES ACT has expired and no participants elected to pay back their qualified distribution.

8. Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$533 and \$342, respectively. Forfeitures will be used to pay Plan expenses and reduce future Sponsor contributions. During the year ended December 31, 2024, \$341 in forfeitures were used to pay Plan expenses.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

2. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and the custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

5. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding expense deduction. The Plan had no excess contributions payable as of December 31, 2024.

6. Payment of Benefits

Benefits are recorded when paid.

7. Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable and benefits paid to participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - Continued

8. Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through June 19, 2025, the date the financial statements were available to be issued.

NOTE C – INFORMATION CERTIFIED BY THE PLAN’S CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal), the custodian of the Plan.

NOTE D – FAIR VALUE OF FINANCIAL INSTRUMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets:
- Quoted prices for identical or similar assets or liabilities in inactive markets:
- Inputs other than quoted prices that are observable for the asset or liability:
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

NOTE D – FAIR VALUE OF FINANCIAL INSTRUMENTS – Continued

Self-directed brokerage accounts: Valued at the net asset value, which is based on the market value of its underlying investments, all of which are publicly traded securities.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued at NAV as determined by the quoted market prices of the underlying mutual funds in which the pooled separate accounts invest.

Common collective trusts: Valued at the NAV of the units held by the Plan, as provided by the trustee. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities. The underlying investments contain investment and contractual components which have observable pricing inputs including quoted market prices for similar assets in active and non-active markets. The NAV is available to current investors and is the basis for current transactions.

NOTE E – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Principal Life Insurance Company and MMA Securities, LLC (MMA) provided contract administration and recordkeeping services, respectively, for the Plan. Therefore, transactions with Principal Life Insurance Company and MMA qualify as party-in-interest transactions. During the year ended December 31, 2024, the Plan paid \$82,357 to Principal Life Insurance Company and \$34,149 to MMA for contract administration and recordkeeping expenses.

NOTE F – PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their allocation of Sponsor contribution accounts.

NOTE G – TAX STATUS

The IRS issued a volume submitter profit sharing plan opinion letter to Principal Life Insurance Company dated June 30, 2020, stating that its prototype plan document was designed in accordance with applicable IRC requirements as of that date. Although the Sponsor has not applied for a determination letter for the Plan and although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
