NOTE A - DESCRIPTION OF PLAN

The following description of the ShorePoint, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering substantially all employees, as defined by the Plan, of ShorePoint, Inc. (the "Company") who have attained age twenty-one and are eligible to participate in the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan or such dollar limit established by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company's safe harbor contribution is 3% of eligible compensation. The Company has the option to make flexible discretionary contributions; however, no discretionary contributions were made for the periods ended December 31, 2024 and 2023. Participants direct the investment of their contributions and Company matching contributions into various investment options offered by the Plan.

**Participant Accounts** - Each participant's account is credited with the participant's contribution, the Company's contribution and an allocation of Plan earnings, expenses and forfeitures. Investment earnings are allocated based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants direct the investment of their accounts among available investment options.

**Vesting** - Participants are vested immediately in their contributions and the Company's safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service. A participant earns 50% each credited service year and becomes fully vested after 2 years of service.

**Notes Receivable From Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear a fixed rate of interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates of prime plus 1% at the time the note is originated. All notes must have a definite repayment schedule, which provides for principal and interest payments to be made ratably through payroll deductions over a period not to exceed five years. Notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest.

**Payment Of Benefits** - On termination of service, death or disability, and under specific situations of financial hardship, a participant or beneficiary may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan also allows in-service distributions for eligible participants.

**Forfeited Accounts** - Forfeitures can be used to reduce future Company contributions and pay certain Plan expenses. During 2024 and 2023, the Plan utilized \$0 of forfeitures to reduce Company contributions. At December 31, 2024 and 2023, the balances of unallocated forfeited non-vested accounts totaled \$0.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis Of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Investment Valuation And Income Recognition** - Investments in pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the price participants would receive if they were to initiate permitted transactions under the terms of Plan.

See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment Of Benefits** - Benefits are recorded when paid.

**Notes Receivable From Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Plan Expenses** - Certain expenses of maintaining the Plan are paid directly by the Plan sponsor. Expenses that are paid by the Plan sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions from the Plan are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**Use Of Estimates** - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Subsequent Events** - The Plan evaluates the events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through June 30, 2025, the date the financial statements were available to be issued.

NOTE C - INVESTMENTS

All investment information included in the accompanying financial statements and supplemental schedule were obtained or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company.

NOTE D - FAIR VALUE MEASUREMENTS

The Plan applies generally accepted accounting principles which defines the fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority and unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under generally accepted accounting principles are described as follows:

- Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - inputs to the valuation methodology include quoted prices for identical or similar assets and liabilities in active markets or inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets at fair value.

***Pooled Separate Accounts*** - These investments are accounts maintained by an insurance company for the collective investment and reinvestment of assets contributed thereto from employee benefit plans maintained by more than one employer or controlled group of corporations. They are valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective investment, the insurance company reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

NOTE E - INVESTMENT CONTRACT

The Plan currently offers a fixed account through Voya Retirement Insurance and Annuity Company.

The fixed account's value is derived from the contract provisions between ShorePoint, Inc. and Voya Retirement Insurance and Annuity Company. The Plan's investment is a fully benefit-responsive guaranteed interest contract. The Plan's investment in the contract is stated at contract value as contract value is the relevant measure for fully benefit-responsive contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the contracts.

The fixed account is credited with a declared rate of interest and is subject to a minimum rate described in the contract. Amounts allocated to the fixed account are held in the Company's general account which supports insurance and annuity obligations. The general account is managed on an aggregate basis and supports all of the Company's financial commitments. No portion of the general account is attributable to a particular plan nor do plans have any undivided ownership interest in general account assets.

Withdrawals to pay participant benefits (as defined in the contract) from the fixed account are made at contract value. Certain contracts limit the amount available for benefits from the fixed accounts to a percentage of the account value surrenders from the fixed account would either be subject to a market value adjustment or paid in installments as elected by the contract holder.

NOTE F - PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments are managed by Voya Retirement Insurance and Annuity Company, which qualify as parties-in-interest. Fees paid by the Plan for investment management services were \$6,025 and \$3,750 for the years ended December 31, 2024 and 2023, respectively.

Certain participants of the Plan have outstanding loans with the Plan at December 31, 2024 and 2023. These loans are considered party-in-interest transactions according to the Department of Labor guidelines. Total outstanding loans as of December 31, 2024 and 2023 were \$99,490 and \$40,253, respectively.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

NOTE H - TAX STATUS

The Plan has adopted a Non-Standardized Pre-Approved Prototype Plan sponsored by Retirement Planners and Administrators, Inc. The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and has no income subject to unrelated business income tax.

NOTE I - RISKS AND UNCERTAINTIES

The Plan provides for various investment options in pooled funds and guaranteed investment contracts. These securities are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with these securities and the level of uncertainty related to changes in the value, it is at least reasonably possible that changes in the various risk factors will occur in the near term that could materially affect the participants' account balances and the amounts reported in the accompanying financial statements.
