## INDEPENDENT AUDITOR'S REPORT

Plan Administrator and Plan Participants  
AA Transportation Co., Inc. 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of AA Transportation Co., Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) Audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

NOTE A: DESCRIPTION OF THE PLAN

The following description of the AA Transportation Co., Inc. 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan document, including amendments, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of AA Transportation Co. Inc. (the “Company”) as well as employees of AA Limousine Service, Inc., Hillside Meadows Equestrian Center, LLC, and AA Charter LLC d/b/a AA Trucking, LLC who have attained eighteen years of age. Employees are eligible to enter the Plan on the first day of each month following the date the employee satisfies the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to 100% of their annual wages subject to Internal Revenue Service limitations. The Company may contribute and allocate to each participant's account a discretionary matching percentage of participant contributions. Effective January 1, 2022, the Plan was amended to include a safe harbor contribution arrangement. Under the safe harbor, the Company will match 100% of participants’ elective deferrals up to 3% of their compensation, plus 50% of their elective deferrals which exceed 3% up to 5% of their compensation. Additional profit-sharing amounts may be contributed at the option of the Company to employees who have completed 500 hours of service during the Plan year or are employed as of the last day of the Plan year. For the years ended December 31, 2024 and 2023, the Company did not make a profit sharing contribution. Effective January 1, 2025, the Plan was amended to include after-tax Roth contributions.

Participant accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution and (b) Plan earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant notes receivable

Participant notes receivable are measured and valued at their unpaid principal balance plus any accrued but unpaid interest. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are payable over terms up to five years (longer if for the purchase of a principal residence). The notes are secured by the balance in the participant’s account and bear interest at rates that range from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their voluntary contributions and safe harbor contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. Employees vest in the Company contributions at a rate of 20% after two years of service and an additional 20% each year thereafter until six years of service are completed. Effective January 1, 2019, a participant receives credit for a year of service if they complete at least 360 hours of service during the plan year. Prior to January 1, 2019, a participant received credit for a year of service if they completed at least 1,000 hours of service during the plan year.

Accounts forfeited

Forfeitures of non-vested employer contributions may be used to reduce future employer contributions and Plan administrative expenses. There was \$- and \$1,101 of non-vested employer contribution forfeitures utilized for the years ended December 31, 2024 and 2023, respectively. As of December 31, 2024 and 2023, \$7,065 and \$5,537, respectively, was held in the Plan which will be used to reduce future employer contributions or pay plan administrative expenses.

Payment of benefits

Upon death, disability or retirement, a participant may elect to receive the value of their vested benefits as a lump-sum distribution. In addition, distributions may be made from vested account balances in excess of \$1,000, with participant consent, under the following conditions: separation from service; upon participant's attainment of age 59 ½; upon participant's attainment of the required minimum distribution age required by law; upon the hardship of a participant as provided for in the Plan and in performing qualified military service. Vested account balances that are less than \$1,000 upon separation of service will be paid in one lump-sum distribution in accordance with the provisions of the Plan. Effective January 1, 2025, the Plan was amended and vested account balances that are less than \$7,000 upon separation of service will be paid in one lump-sum distribution in accordance with the provisions of the Plan.

Administrative expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation or depreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Payment of benefits

Benefits paid to participants are recorded as of the date paid due to hardship or discretionary withdrawals, retirement, or termination of employment and represent amounts distributed from participants' individual vested account balances.

Use of estimates in preparation of financial statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

Investment valuation and income recognition

Investments held by the Plan are reported at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for further discussion of fair value measurements.

Purchases and sales are made and recorded as needed, when a contribution is made to the Plan, when a distribution is made from the Plan or when a participant changes his or her investment election.

Historical cost is used to determine the net appreciation or depreciation of investments, as reported by the Plan's custodian. Interest and dividend income is recorded as earned.

Subsequent events

The Plan has conducted an evaluation of potential subsequent events occurring after the statement of net assets available for benefits date through June 12, 2025, which is the date the financial statements are available to be issued. See Note A.

NOTE C: FAIR VALUE MEASUREMENTS

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under U.S. GAAP are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market and mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are actively traded open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to report their daily net asset value and to transact at that price.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E: PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts and their accounts will be paid to them as provided by the Plan document.

NOTE F: TAX STATUS

On June 30, 2020, the Internal Revenue Service stated that the non-standardized, preapproved profit-sharing plan adopted by the Plan, as then designed, qualifies under section 401 of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator and the Plan's tax counsel believe that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or other applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G: TRANSACTIONS WITH PARTIES-IN-INTEREST

For the years ended December 31, 2024 and 2023, Empower Trust Company, LLC is the custodian of the plan, and transactions in any affiliated investments qualify as party-in-interest transactions which are exempt from the prohibited transactions rules. As described in Note A, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA.

NOTE H: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I: DELINQUENT PARTICIPANT CONTRIBUTIONS

Certain participant contributions were not remitted to the Plan within the time frame specified by the Department of Labor's Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company for the year ended December 31, 2023. In April 2024, the Company remitted these deferrals and made a contribution to compensate the participants for lost investment earnings relating to these prohibited transactions.
