Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kassouf & Co., Inc. 401(k) Profit Sharing Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Kassouf & Co., Inc. 401(k) Profit Sharing Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of the Kassouf & Co., Inc. 401(k) Profit Sharing Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan covering substantially all full-time employees of a controlled group of employers consisting of Kassouf & Co., Inc., Highland Avenue Land Company, LLC, Kassouf Retirement Plan Services, LLC, Kassouf Wealth Advisors, LLC, and Seventh Avenue Land Company, LLC (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions and Funding

The Plan provides for the following four methods of funding for each participant's account:

i) Elective Contributions

Participants may contribute up to 100 percent of pre-tax annual compensation, or make nondeductible (after-tax) contributions, as defined by the Plan, not to exceed the maximum amounts allowed by law. Participants who have attained age 50 before the close of the Plan year are eligible to make catch-up contributions in amounts subject to the limitations as specified by law.

ii) Employer Safe Harbor Matching Contributions

The Company contributes a safe harbor matching contribution equal to 100 percent of the deferrals that a participant contributes to the Plan, up to three percent of the participant's eligible compensation, as defined by the Plan. Additionally, the Company matches 50 percent of the deferrals that a participant contributes to the Plan that are between three and five percent of the participant's eligible compensation.

iii) Non-Elective Employer Contributions

The Company may elect to make an annual non-elective employer contribution. In the event that the Company elects to make a non-elective employer contribution, the contribution will be allocated among all eligible employees who have completed at least 1,000 hours of service during the year and who are still employed by the Company on the last day of the year. No non-elective employer contributions were made during the year ended September 30, 2024.

NOTE 1 – DESCRIPTION OF THE PLAN (continued)

iv) Rollover Contributions

Employees may transfer amounts to the Plan which were distributed from another tax-qualified retirement plan (rollover).

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, any rollover contributions, and employer safe harbor matching contributions. Vesting in the Company's non-elective discretionary portion of their accounts plus actual earnings thereon is based on years of credited service, as defined by the Plan. A participant is 100 percent vested after six years of credited service. A participant will be 100 percent vested if employed on or after meeting the normal retirement age of 65, becoming disabled, or upon death.

Payment of Benefits

On termination of service or the attainment of normal retirement age (65), a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Benefits are recorded when paid.

Forfeited Accounts

Forfeitures of terminated or withdrawing participants' non-vested non-elective employer contributions may be used to pay Plan expenses or to reduce future employer contributions. As of September 30, 2024 and 2023, there were no forfeitures or forfeited non-vested balances.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and related disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Management has evaluated subsequent events through April 30, 2025, the date at which the financial statements were available to be issued, and noted no material events requiring disclosure.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.

NOTE 3 – FAIR VALUE MEASUREMENTS (continued)

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 – CERTIFIED INVESTMENT INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at September 30, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended September 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company (the custodian of the Plan). This information has not been audited by the Plan’s independent auditors. The information certified by Matrix Trust Company is summarized below.

NOTE 5 – INCOME TAX STATUS

The Plan Sponsor has adopted a non-standardized pre-approved profit sharing plan. The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the Code). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan administrator is aware of certain operational, plan document, or demographic issues that, if not properly corrected, could be treated by the IRS as qualification failures. Management is taking steps to correct these issues. If necessary, the tax qualification issues will be resolved directly with the IRS. Accordingly, management believes that the Plan will retain its tax-qualified status.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested and non-forfeitable in their accounts. Plan assets will be allocated to provide benefits to participants based on their individual account balances.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan is serviced by Savant Wealth Management as its investment advisor, and Matrix Trust Company, Inc. as its custodian. Certain fees incurred by the Plan for investment management and custodian services are paid through revenue sharing, rather than direct payment, and are included in net appreciation in fair value of investments. These transactions qualify as party-in-interest transactions.

Smith, Dukes & Buckalew, LLP is the Plan's auditor. This relationship qualifies as party-in-interest.

During the year ended September 30, 2024, the Plan made direct payments to these parties totaling \$66,611.

Kassouf Retirement Plan Services, LLC serves as the Plan's record-keeper. Employees of Kassouf Retirement Plan Services, LLC are eligible to participate in the Plan as part of the controlled group of employers related by common ownership. No compensation is paid by the Plan to Kassouf Retirement Plan Services, LLC or its employees, either directly or indirectly.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

NOTE 9 – DELINQUENT CONTRIBUTIONS

During 2024, certain employee deferrals aggregating \$1,600 were not remitted to the Plan within the timeframe required by the Department of Labor. The Company will compute lost earnings on these deposits and make a contribution for lost earnings to the Plan. This information has been included in the Form 5500, Schedule H, line 4a, and is shown in the supplemental Schedule of Delinquent Participant Contributions.
