### 1. Nature of Business and Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are maintained on the accrual basis of accounting.

Cash and Cash Equivalents - Cash and cash equivalents consist primarily of cash in checking accounts. Cash balances uninsured by FDIC at December 31, 2024 and 2023 was \$-0- and \$-0-, respectively.

Investment Valuation and Income Recognition - Investments are stated at fair value. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes net realized and unrealized gains (losses) on investments.

Management fees and operating expenses to the Plan for investments in registered investment companies are deducted from income earned on a daily basis and are not separately reflected. Consequently, these management fees and operating expenses are reflected in net appreciation (depreciation) in the fair market value of investments for such investments.

Administration of the Plan – Expenses of administration are paid by the Plan.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Benefits Paid to Participants - Benefits are recorded when paid.

Subsequent Events - Subsequent events have been evaluated through June 26, 2025, which is the date the financial statements were available to be issued.

### 2. Description of Plan

The following description of the Harding's Galesburg Market, Inc. 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution 401(k) profit-sharing plan, established January 1, 1988, covering all full-time employees of the Company who are age twenty-one or older, who have a minimum of one year of service and have worked a minimum of 1,000 hours. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

## Notes to Financial Statements

### 2. Description of Plan - Continued

Tax Status - The Plan is a qualified plan under the Internal Revenue Code and is exempt from federal income taxes under Section 401(a) of the Code. All tax years remain statutorily open for review.

Contributions - Participants may contribute a portion of their annual cash basis compensation to the limit as permitted by law. The Plan allows participants to make Roth election contributions. The Company may make a discretionary contribution. For the year ended December 31, 2024 and 2023, the Company made a discretionary contribution based on .2 percent of sales. The employer's discretionary contribution is funded by the due date, including extension, of the Company's federal corporate income tax return.

Participant Accounts - Each participant account is credited with the participant's contributions, the employer's discretionary contribution, and an allocation of Plan earnings and expenses. Allocations are determined by the Employer and applied on a uniform basis to all participants, as defined. Participants direct the investment of their contributions and the employer discretionary contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service.

Notes Receivable - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The receivables are secured by the balance in the participant's account. The interest rate on participant loans is the prime rate plus 1%. Current interest rates range from 4.25 percent to 9.5 percent. Principal and interest is paid ratably through payroll deductions. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If participant does not make a payment and then plan administrator considers the receivable in default, the receivable is reduced and the delinquent and receivable is recorded as a benefit payment based on terms of the plan document.

Payment of Benefits - Once a participant reaches age 65, the participant may receive a lump-sum cash distribution. Upon termination, a participant may elect to receive an early distribution equal to their vested account balance.

### 2. Description of Plan - Continued

**Forfeitures** - Any participant forfeitures of employer contributions due to withdrawal from the Plan are first used to reduce administrative fees and any remaining amount is used to reduce employer contributions. For the year ended December 31, 2024 and 2023, plan forfeitures amounted to \$11,182 and \$3,230, respectively. At December 31, 2024 and 2023, the Plan had \$8,663 and \$3,360 of unvested forfeited amounts that will be used to pay for plan expenses in the following year.

Accounting Standards Codification No. 820, Fair Value Measurements and Disclosures, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of levels:

- Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

#### *Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. The fair values of collective investments are valued at quoted prices in active markets for identical or similar securities.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024 and 2023 are reported in net (depreciation) appreciation in fair value of investments.

- 3. Fair Value Measurements – Continued** The following is a description of the valuation methodologies used to measure assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.
- Mutual Funds – Valued at the closing price reported on the active market on which the individual securities are traded.
- 4. Plan Termination** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.
- 5. Tax Status** The Internal Revenue Service has determined and informed that the prototype Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) as of August 7, 2001. The Plan has been amended since receiving the determination letter including a recent plan amendment effective July 1, 2022. However, the Plan administrator and the plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believe the Plan is qualified and therefore, tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
- Accounting principles generally accepted in the United State of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. Management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine tax audits by jurisdictions; however, there are currently no audits for any tax periods in progress.
- 6. Certification of Information by Custodian** Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Greenleaf Trust (the trustee of the Plan).

### **7. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, credit and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **8. Party in Interest Transactions**

Certain Plan investments are managed by Greenleaf Trust. Greenleaf Trust is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investments management services amounted to \$42,274 and \$32,126 for the years ended December 31, 2024 and 2023.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.


