#### Note 1 - Description of the Plan

The following description of the Zones, Inc. 401(k) Plan (the Plan) provides general information only. Participants should refer to the plan agreements for a more complete description of the Plan's provisions. Effective January 1, 2024, the Plan's name was changed to Zones, LLC 401(k) Plan.

**General** - The Plan is a defined contribution plan established for the benefit of eligible employees of Zones, LLC. (the Company). Leased employees, nonresident aliens, collective bargaining (union) employees and part-time, temporary, and seasonal employees that have not completed 1,000 hours of service during the relevant computation period are ineligible to participate in the Plan. All remaining employees who have completed 30 days of service and are at least 18 years of age are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions** - Participants may elect to defer up to 70% of their eligible compensation as pretax or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans (rollover). The Plan includes a provision whereby all newly eligible employees are automatically enrolled at a 3% deferral rate unless they elect a different deferral rate or not to participate in the Plan. Participants that are automatically enrolled will have their deferral rate increase by 1% each year, up to a maximum of 10%, unless otherwise elected.

The Company may make discretionary matching contributions. For the year ended December 31, 2024, the Company elected to match 33.33% of the first 6% of eligible compensation that a participant contributes to the Plan. The Company may also make discretionary nonelective contributions. There were no nonelective contributions made for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and matching contributions, as well as allocations of the Company's nonelective contributions (if any) and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

**Vesting** - Participants are immediately vested in their salary deferral contributions and any nonelective employer contributions plus actual earnings thereon. Participants hired prior to January 1, 2000 are immediately vested in the Company's matching contribution. Vesting in the Company's matching contributions for those hired after January 1, 2000 is based on years of continuous service. A participant is fully vested after five years of credited service.

**Forfeitures** - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$67,522 and \$18,723, respectively. These accounts will be used to reduce future employer contributions or pay administrative expenses of the Plan. During 2024, forfeitures of approximately \$89,000 and \$27,000 were used to pay eligible plan expenses and fund the employer match, respectively.

**Payment of Benefits** - Upon termination of service, death, disability, or retirement, a participant may elect to receive a distribution of their vested account balance. The distribution may be in the form of a lump-sum payment or installment payments. Participants who have reached the age of 59½ may elect to withdraw all or a portion of their vested account balance prior to termination of employment (in-service withdrawal). The Plan allows for hardship withdrawals in accordance with provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

**Notes Receivable From Participants** - Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account. Loans are secured by the balance in the participant's account. Interest rates are set at 1.0% above the prime rate, as defined. Principal and interest is paid ratably through payroll deductions.

#### Note 2 - Significant Accounting Policies

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants** - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Benefits Paid to Participants** - Benefits are recorded when paid.

**Investment Management and Administrative Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Transaction based fees for notes receivable from participants and benefit payments are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

**Subsequent Events** - The Plan's management has evaluated subsequent events through June 26, 2025, the date the financial statements were available to be issued.

#### Note 3 - Fair Value Measurements

GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds - Valued at the NAV provided by the funds' trustee. The NAV is based on the fair value of the underlying assets of the funds, minus their liabilities, and then divided by the number of units outstanding at the valuation date. The NAV is used as a practical expedient to measure fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

Pooled Separate Accounts - Valued at the NAV of units of the pooled separate account. The NAV, as provided by Empower Annuity Insurance Company (EAIC), is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient would not be used if it is determined to be probable that the pooled separate account will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

#### Note 4 - Guaranteed Income Fund

The Plan has entered into a general account backed evergreen (no maturity) group annuity spread contract with Empower Annuity Insurance Company (EAIC), which is a fully benefit-responsive investment. Participants may ordinarily direct the withdrawal or transfers of all or a portion of their account balance at contract value within reasonable timeframes. The account is credited with deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and expenses. The issuer is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan.

When establishing interest crediting rates for this product, EAIC considers many factors, including current economic and market conditions, the general interest rate environment and both the expected and actual experience of a reference portfolio within the issuer's general account. These rates are established without the use of a specific formula. Interest crediting rates are reviewed on a semi-annual basis for resetting. The minimum crediting rate under the contract is 1.50% less a variable asset charge rate.

Generally, there are no events that could limit the ability of the Plan to transact at contract value or settle at an amount different than contract value. Upon termination of the contract between EAIC and the Plan, EAIC will initiate termination disbursements the later of A) 90 days after EAIC receives all information necessary to make the disbursement or B) 90 days after the date all outstanding expenses are paid under the contract. Transfers out of this fund must be directed to and remain in a noncompeting fund for a period of 90 days before it can be invested in a competing fund.

The Guaranteed Income Fund is recorded at contract value and based on the nature of the fund, generally is deemed to approximate fair value. Contract value represents contributions, earnings at guaranteed crediting rates, less withdrawals and fees.

#### Note 5 - Certified Information

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company, both qualified institutions. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

#### Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their account balances.

#### Note 8 - Tax Status

The Company adopted an Empower Retirement LLC pre-approved plan document. Empower Retirement LLC received an approval letter from the IRS dated September 16, 2022, which states that the form of the plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

#### Note 9 - Party-in-Interest Transactions

Plan investments include a guaranteed income fund and units of pooled separate accounts managed by EAIC. EAIC is a custodian for the Plan and, therefore, transactions with such investments are party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions.

#### **Note 10 - Concentrations of Credit Risk**

Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of the guaranteed income fund issued by EAIC. This investment represented approximately 9% and 10% of total plan investments at December 31, 2024 and 2023, respectively. The Plan's management seeks to limit its credit exposure by working with high credit quality institutions.

#### **Note 11 - Delinquent Contributions**

The Company determined there were instances during 2024, 2023, 2022, and 2021 in which participant deferral contributions and loan repayments were not deposited by the Company as plan assets within the time limitation stipulated under the Department of Labor's (DOL) regulations. Delinquent contributions are prohibited party-in-interest transactions under ERISA and also represent related party transactions between the Plan and the plan sponsor.

For 2024, \$1,719,356 of deferral contributions and loan repayments were identified as delinquent. For 2023, \$2,241,321 of deferral contributions and loan repayments were identified as delinquent. For 2022 and 2021, respectively, \$1,399 and \$71,507 of deferral contributions and loan repayments were identified as delinquent.

The Company restored lost earnings on the 2021, 2022, and 2023 delinquent contributions and loan repayments in 2024 and is working with their recordkeeper to calculate and restore lost earnings on 2024 delinquent contributions.
