INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the
Metropolitan DC Paving Industry Employees
Health and Welfare Fund

Opinion

We have audited the accompanying financial statements of Metropolitan DC Paving Industry Employees Welfare Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and of benefit obligations of the Plan as of September 30, 2024 and 2023, and the changes in its net assets available for benefits and of benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.


Basis for Opinion



NOTES TO FINANCIAL STATEMENTS

YEARS ENDED SEPTEMBER 30, 2024 AND 2023

NOTE 1. DESCRIPTION OF THE PLAN

The following brief description of Metropolitan DC Paving Industry Employees Health and Welfare Fund (the Plan) is provided for general information purposes only. Participants should refer to the Summary Plan Description for more complete information.

General - The Plan is maintained pursuant to various collective bargaining agreements between the Metropolitan DC Paving, Highway and Construction Materials Council, AFL-CIO and its affiliated unions, Laborers Local No. 11, Cement Masons Local No. 891, Teamsters Local No. 639 (effective 10/1/08) and individual employers, for the purpose of providing group life, hospitalization, medical, disability income, death, prescription and vision care benefits to eligible participants and their dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Contributions to the Plan are made by individual employers under the provisions of a collective bargaining agreement and, under certain conditions stipulated in the Plan, employees may qualify to contribute on their own behalf.

Benefits - Benefits are provided by contributions to the Plan and any income earned from the investment of contributions. All monies are used exclusively for providing benefits to eligible employees or their dependents, and the paying of all expenses incurred with respect to the operation of the Plan.

Termination - In the event the Plan is terminated, the Board of Trustees (Trustees) shall use any remaining funds to satisfy existing and arising claims for benefits under the terms of this Plan and to pay reasonable administrative expenses until such funds are exhausted.

Stop Loss - Premiums for stop loss insurance are included in the schedules of benefits paid in the accompanying statements of changes in net assets available for benefits. The stop loss insurance held by the Plan pays on claims over \$250,000 per individual. During the fiscal years ended September 30, 2024 and 2023, the Plan paid \$286,656 and \$254,761, respectively, in stop loss premiums. No refunds were received during September 30, 2024 and 2022.

Other - The Plan's Trustees, as Sponsor, have the right under the Plan to modify the benefits provided to members. The Plan may be terminated only by joint agreement between industry and union, subject to the provisions set forth in ERISA.



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements are prepared on the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

Estimates - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, incurred but not reported (IBNR), eligibility credits, claims payable, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Employer Contributions Receivable - Accounts receivable are stated at the amount the management expects to collect from balances outstanding at year end. Based on a review of historical losses, current economic conditions and supportable and reasonable forecast assumptions, management has concluded that any expected credit losses on balances outstanding at year end will be immaterial.

Investment Valuation and Income Recognition - Investments are carried at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by its investment advisers. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recognized on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are recognized on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Concentration of Credit Risk - Financial instruments that potentially subject the Plan to concentrations of credit risk consist primarily of cash. The Plan currently keeps its cash accounts with one financial institution. The balances are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 in a single financial institution. As of September 30, 2024, the Plan had \$652,496 in excess of federally insured limits.

Administrative Expenses - Administrative expenses are paid by the Plan.

Reclassifications - Certain reclassifications may have been made to conform to current year financial statement presentation. These reclassifications had no effect on the net assets available for benefits.

New Accounting Pronouncement Adopted - During the year ended September 30, 2024, the Plan adopted the provisions of Accounting Standards Update (ASU) 2016-13, *Financial Instruments - Credit Losses* (Topic 326). This ASU replaced the incurred loss methodology with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. The ASU requires nonprofit entities to immediately recognize the estimated expected credit losses over the life of a financial instrument, including employer

contributions. The estimate of expected credit losses considers not only historical information, but also current and future economic conditions and events. The Plan adopted the ASU effective October 1, 2023. The impact of the adoption was not considered material to the financial statements and primarily resulted in additional disclosures.

NOTE 3. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Short-term investments: Valued at cost which approximates fair value.

Registered investment companies: Valued at the closing price reported on the active market on which the securities are traded.



NOTE 3. FAIR VALUE MEASUREMENTS (CONTINUED)

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4. POST-RETIREMENT BENEFIT OBLIGATIONS

The Plan adopted the provisions of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 965. However, this Plan does not provide retiree health benefits and therefore, there is no actuarial post-retirement obligation applicable to this Plan. The Plan only incurs current benefit obligations for: a) claims incurred but not yet reported, b) current claims (premiums) payable, and c) accumulated eligibility.

Benefits Currently Payable and Incurred but Not Reported - Amounts currently payable to or for participants, beneficiaries and dependents represent actual and estimated amounts paid or payable after year end for all reported claims for benefits occurring during the respective accounting periods. These amounts are estimated by the Plan consultant and actuary based on eligibility counts and claims experience.

NOTE 5. INCOME TAX STATUS

The Internal Revenue Service (IRS) has made a favorable determination on the Plan's tax status and has notified it that it is exempt from federal income taxes pursuant to Internal Revenue Code (IRC) Section 501(c)(9). The Plan sponsor believes that the Plan, as amended, continues to qualify and to operate in accordance with applicable provisions of the IRC.



NOTE 5. INCOME TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6. LITIGATION

Based on the advice of Plan Counsel, there is no litigation, either pending or threatened, which would have a material adverse effect on the Plan's financial position.

NOTE 7. SIGNIFICANT PLAN AMENDMENTS

During the Plan fiscal year(s) ended September 30, 2024 and 2023, no significant plan amendments were adopted.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial estimates for claims incurred but not reported and for accumulated eligibility credits reported based on certain assumptions pertaining to historical claims data, cost trends and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.



