INDEPENDENT AUDITORS' REPORT

To the Trustees of the  
EastRise Federal Credit Union Salary Savings Plan  
Williston, Vermont

We have performed audits of the accompanying financial statements of EastRise Federal Credit Union Salary Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of EastRise Federal Credit Union Salary Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about EastRise Federal Credit Union Salary Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### (1) Description of the Plan

The following brief description of the EastRise Federal Credit Union Salary Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Effective April 18, 2024, the New England Federal Credit Union Capital Accumulation Plan merged into the Plan and ceased to exist as a standalone plan. Total assets merged into the Plan amounted to \$12,720,213.

Effective January 1, 2023, employees of Vermont State Employees Credit Union (VSECU) became eligible participants of the Plan. In addition, the VSECU Capital Accumulation Plan merged into the Plan during 2023 and ceased to exist as a standalone plan. Total assets merged into the Plan amounted to \$23,510,720.

(a) General - The Plan is a defined contribution retirement plan covering all employees of the EastRise Federal Credit Union (the "Company") employed after January 1, 2006 who have attained the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) Administrative Expenses - Administrative expenses are paid by the Company and investment management fees are paid by the Plan. Investment management fees are reported as a reduction to investment earnings.

(c) Contributions - Contributions to the Plan are made by the participant and by the Company. An individual participant may elect to contribute a percentage or a defined dollar amount of their compensation not to exceed Internal Revenue Service (IRS) limits. Participants direct their contribution into various investment options. The Plan provides for automatic enrollment with employee contributions at 6% of compensation upon meeting eligibility requirements.

The Plan is a "Safe Harbor 401(k)" plan, and as such the Company commits to making certain contributions. Effective January 1, 2023, The Company makes a safe harbor matching contribution equal to 75% of salary deferrals that do not exceed 6% of the participants' compensation. To be eligible for the safe harbor, participants must have attained age 18. A participant may enter the Plan immediately following the satisfaction of eligibility requirements.

The Company may also make discretionary profit sharing contributions in any amount set by the Board of Directors annually, subject to IRS limitations. The Company did not make any discretionary profit sharing contributions in 2024 or 2023. In order to receive the profit sharing contribution, a participant must have completed 1,000 hours of service and be employed on the last day of the Plan year.

The Company's non-elective contribution is 3% of each participant's eligible compensation into the Plan in 2024 and 2023. To be eligible for the non-elective employer contribution, a participant must attain the age of 18.

- For the participants of the former VSECU Plan, the Plan also makes contributions based on an allocation formula that takes into account the participants' date of birth and years of service, for participants to receive an additional employer contribution ranging from 1-9%.
- (d) Forfeitures - Forfeitures may be used to reduce Company contributions. At December 31, 2024 and 2023, there was \$0 in unallocated forfeitures. Forfeitures in the amount of \$48 and \$46 were used to reduce Company contributions in December 31, 2024 and 2023, respectively.
- (e) Benefit Payments - Upon normal retirement, participants may elect to receive either a lump sum payment equal to the value of their account or ad-hoc distribution, where a participant may request a distribution of some or all of the Plan accounts, subject to any reasonable limits regarding timing and amounts as imposed by the plan administrator. On termination of service, if a participant's vested benefit is less than \$7,000, the benefits will be distributed in one lump-sum payment. If \$7,000 or greater, the participant may leave it in the Plan, request an early lump sum distribution, or rollover to another qualified plan. Hardship distributions are permitted in an amount not to exceed the total participant's elective deferral amount. A participant may not receive a hardship distribution from safe harbor matching, qualified nonelective or discretionary profit sharing contribution accounts. No other in-service distributions are allowed.
- (f) Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Employees hired prior to January 1, 2023, are immediately vested in their employer contributions. Vesting in the Company's discretionary matching and other discretionary contribution portion of the participant's account plus actual earnings thereon is based on years of continuous service for employees hired after January 1, 2023. A participant is 20% vested after one year of credited service, with an additional 20% per year thereafter until fully vested.
- (g) Notes Receivable - Participants may, upon written application, borrow any amount from \$1,000 up to 50% of their total vested account balance up to a maximum of \$50,000, as defined in the Plan. A participant may choose to have up to two loans outstanding. Loans are repaid through payroll deduction on an after-tax basis for a period not to exceed five years unless for the purchase of a principal residence which is up to 10 years. Any loan granted or renewed under this policy will bear an interest rate equal to prime plus 1%.
- (h) Participant Accounts - Each participant's account is credited with the participant's contributions and their allocation of (a) the Company's contributions and earnings thereon, (b) Plan earnings, and (c) forfeitures of terminated participants' non-vested account balances. Allocations of investment earnings are based on account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant determines the investment strategy of their account as provided by the Plan.

### (2) Summary of Significant Accounting Policies

- (a) Basis of Accounting - The financial statements are prepared on the accrual basis of accounting.
- (b) Valuation of Investments - Investments are stated at fair value using quoted market prices in active markets. Purchases and sales of securities are recorded on a trade-date basis. Unrealized gains and losses are based on the differences of beginning of the year fair values or cost if purchased during the current year, and year-end fair values. Interest and dividend income is accrued as earned.
- (c) Notes Receivable - Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.
- (d) Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- (e) Risks and Uncertainties - The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.
- (f) Benefit Payments - Benefits are recorded when paid.
- (g) Subsequent Events - The Plan evaluated subsequent events through June 30, 2025, the date the Plan's financial statements were available to be used.

### (3) Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances. Additionally, the Company may amend the Plan at any time without the consent of any participant or beneficiary, provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefit.

### (4) Income Taxes

The Company has adopted a prototype plan, which received a favorable determination letter from the Internal Revenue Service dated March 31, 2008, which stated the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

### (5) Information Certified by the Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 and the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Principal Life Insurance Company and Principal Trust Company, the custodians of the Plan, as well as Matrix Trust Company, the custodian of the VSECU Plan during 2023, have certified to the completeness and accuracy of all types and amounts of investments reflected on the accompanying statements of net assets available for plan benefits at December 31, 2024 and 2023, the schedule of assets held for investment purposes at December 31, 2024, and the related investment activity reflected in the statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023.

### (6) Fair Value Measurements

U.S. GAAP establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts and common collective trusts:* Valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
