Opinion

Notes to Financial Statements

September 30, 2024 and 2023

1. Description of the Plan

The following brief description of the Smith & Loveless, Inc. Employee Health Care Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan provides hospitalization, medical, dental, and other health benefits to substantially all bargaining unit and non-bargaining unit employees of Smith & Loveless, Inc. (the Company). Benefits provided for the bargaining unit employees are pursuant to a collective bargaining agreement between the Company and the United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, Allied Industrial and Service Workers International Union Local No. 13-18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Beginning January 1, 2016, the medical plan was self-insured. The dental claims are self-insured for the fiscal years ending September 30, 2024 and 2023. Medical and dental claims of participants are processed by a third-party benefit claims administrator.

Plan Contributions

The Plan provides health benefits for the following employees of the Company; 1) full-time employees who are not governed by a collective bargaining agreement and have completed 2 months of continuous employment, effective as of the first of the following month, and 2) full-time employees who are governed by a collective bargaining agreement who are scheduled to work at least 30 hours per week and who have completed a 320 hour probationary period. The agreements provide that the Company will pay a portion of the cost of dental coverage and a portion of the cost of medical coverage for eligible employees. Eligible non-bargaining unit employees who elect coverage contribute a percentage of their compensation from 2.00% to 4.70% plus additional specified amounts, determined periodically, to extend coverage to eligible dependents. The Company pays a portion of the cost of dental and medical coverage provided to the bargaining unit employees pursuant to the current collective bargaining agreement. Bargaining unit employees contribute a specific amount per paycheck as defined in the current collective bargaining agreement. Effective January 1, 2020, employees were eligible for dental coverage after completing sixty days of employment.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

Stop-Loss Coverage

The Plan has entered into a stop-loss arrangement to limit exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of the benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than the exclusive benefit of the Plan's participants.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on accrual method of accounting.

Payment of Benefits

Claim payments are recorded when paid by the third-party claims processor.

Incurred But Not Reported Claims

Plan liabilities for dental claims incurred but not reported are estimated based upon historic claims experience and actual claims reported subsequent to the Plan year-end. Plan liabilities for medical claims incurred but not reported are estimated based upon the weighted average of monthly claims and weighted average lag time for the claim to be processed and paid. Additional accruals are included for the estimated ultimate cost of future claims only if such claims are

covered as of the Plan's fiscal year-end and the Plan is obligated to pay for the care regardless of continued participation in the Plan. Claims payable at the Plan's year-end are benefit claims that have been processed and approved for payment but not paid. The amount is estimated based on actual claims data.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Stop-Loss Insurance

Premiums for stop-loss insurance are included in the accompanying statement of changes in net assets available for benefits net of any rate adjustments throughout the year. Reimbursements under the stop loss contract are netted against claims payments in the financial statements. In certain circumstances, per the insurance contract, the insurance company will assume the claims management process for catastrophic claims. When this occurs, the insurance company deals directly with the healthcare providers and pays the adjudicated claims directly. Such amounts are not included in the financial statements because the Plan does not pay the claims initially and thus does not receive a stop-loss recovery.

During the years ended September 30, 2024 and 2023, reimbursements under the stop-loss policy amounted to \$614,909 and \$122,591, respectively. The total reimbursement for the year ended September 30, 2024 includes a receivable from the stop-loss insurance company of \$236,820 related to claims incurred during the plan year. There was no stop-loss receivable as of September 30, 2023. There are no reserves against the receivable as of September 30, 2024.

Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators and other service providers. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

2. Summary of Significant Accounting Policies (continued)

Risk and Uncertainties

The present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Reclassification

Certain amounts in the 2023 financial statements were reclassified to conform to the current year presentation. Such reclassifications did not impact net assets available for benefits or the changes in net assets available for benefits.

3. Income Tax Status

The Plan is required to operate in conformity with the Internal Revenue Code (IRC) to maintain the tax-exempt status of the Plan. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position more likely than not, would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Related Party Transactions

As noted in Notes 1 and 2, the Plan has a number of service providers. Such parties are parties-in-interest under ERISA.
